**Port Blair, May 1**  
The first phase of 'OORJA 2017 CAPFs U-19 Football Talent Hunt Tournament' organized by Border Security Force, South Bengal Frontier was inaugurated by the Lt. Governor, A&N Islands, Prof. Jagdish Mukhi in the presence of Arjuna & Dronacharya Awardee/Former Indian Football Captain, Shri Syed Naeemuddin, officers from BSF, PBMC, Chairperson, Shri B. Eshwar Rao, Senior officers of the Administration and a good number of football enthusiasts here this evening at Netaji Stadium. The first phase is being held from 1st to 12th May, 2017. A total of sixteen football teams, eight each of boys and girls of various schools and Sports Clubs from Andaman & Nicobar Islands are participating in the tournament.

Addressing the gathering, the Lt. Governor said, for the first time in the history of football, India is going to host the Under-17 FIFA World Cup Football Tournament in the month of October 2017. In line with this, he said as per the desire and the initiative of the Hon'ble Prime Minister, Shri Narendra Modi, an Under-19 Football Tournament (Boys & Girls) is being jointly organized by Central Armed Police Forces (CAPFs) under the aegis of All India Police Sports Control Board. The Lt. Governor mentioned that while emphasizing successful hosting of the event, the Govt. of India has decided that FIFA World Cup must be a catalyst for change and the tipping point for football in the country, which can only be done by creating a mass movement. He said, the tournament has been titled 'OORJA 2017 - CAPFs U-19 Football Talent Hunt Tournament' and the event has been designed, keeping in mind, the objective to give an opportunity to every child of the country to play football.

Complimenting the Border Security Force and the participants, the Lt. Governor expressed the hope that this tournament will provide the budding football players of Andaman & Nicobar Islands, the opportunity to execute their skill and talent in the sport. He further said that, Isles sportspersons have excelled in various sports activities and have won several medals in National and International sports events. He hoped that the youth of the Islands will also perform well in this football tournament.

The Lt. Governor stated that the objective of the tournament which is a part of 'Mission XI Million' is to create fervor among the youth of India towards football and to select promising players to represent the country adding that the aim to recruit young promising players in CAPFs would be met. He urged all the players to make best use of the opportunity to showcase the best sportsmanship as well as the spirit of comradeship.

The Lt. Governor expressed confidence that the teams selected in this tournament, will certainly do well in the next phase. He said, "it is a matter of great pride for all of

us that the former Indian footballer, Arjuna and Dronacharya Awardee, Shri Syed Naeemuddin, is with us today and he would carry along his baton of expertise in emboldening the proficiency amongst the participants".

The Lt. Governor remarked that BSF has a history of successfully taking most difficult challenges and today, it is a force with vast experience in effective border management, ant-insurgency and anti-militancy operation as well as providing security during elections and disaster management. "We are all proud of the achievements of this premiere Border Guarding Force", he added.

He bestowed his good wishes to the BSF and its officials as well as the participants for this tournament and assured of all support of Administration required for organizing this prestigious tournament.

The Lt. Governor also hoisted the Olympic flag and declared the championship open. The mentor of this tournament, Shri Syed Naeemuddin lit the torch and handed over to two well known sports persons of the Islands, Ms Reena Kumari (Rowing) and Mr. Emerson (Cycling) both of whom inturn lighted the cauldron.
