Significant milestone for ANIIMS in Blood Group identification

Rare Bombay Blood Group identified in a blood donor during routine blood grouping at G.B. Pant Hospital

Sri Vijaya Puram, Sept. 1

The Blood Centre at G.B. Pant Hospital, ANIIMS, Sri Vijaya Puram, has successfully identified a rare Bombay Blood Group [Oh phenotype], Rh(D) positive, in a blood donor during routine blood grouping, highlighting the importance of comprehensive and confirmatory blood group testing for ensuring transfusion safety.

As informed by the donor, the donor had previously undergone blood grouping at two private laboratories in Sri Vijaya Puram, where the blood sample was reported as O-positive. However, during subsequent routine testing at the Blood Centre, G.B. Pant Hospital, the sample showed an apparent O-group pattern on forward grouping. A discrepancy was observed during reverse grouping, which prompted the Blood Centre team to undertake further detailed evaluation.

Further immunohematological investigations, including Anti-H lectin



testing, were carried out, which led to the identification of the donor's blood group as the rare Bombay phenotype (Oh), Rh(D) positive.

The Bombay blood group is an exceptionally rare blood group, with its occurrence reported to be as low as approximately 1 in 10 lakh (1 in 1 million) individuals in certain populations. Individuals with this phenotype lack the H antigen and, despite appearing similar to blood group O on routine forward grouping,

Class VIII and encourage them to complete their school education up to higher secondary level, i.e., Class XII.

The Scheme provides one lakh fresh scholarships every year for Class IX students who clear the qualifying exam for the scholarship conducted by the State/UT governments. The scholarship is continued through renewal mode from Classes X to XII based on the student's academic performance. The scheme is applicable only to students studying in State Government, Government-aided and local body schools. The scholarship amount is Rs. 12,000 per annum per student.

NMMSS scholarships are disbursed directly into the bank accounts of selected students by electronic transfer through the Public Financial Management System (PFMS) following DBT mode. The eligibility parameters for availing the scholarship include parental income of not more than Rs. 3.50 lakh per annum, a minimum of 55% marks or equivalent grade in the Class VII examination for appearing in the selection test for award of scholarship (relaxable by 5% for SC/ST students).

The NMMSS is implemented through the National Scholarship Portal (NSP) - the one-stop platform for scholarship schemes disbursed to students by the Government of India. As of 31.08.2026, 79,398 fresh and 1,87, 208 renewal applications have been submitted.
