Lt. Governor visits Coast Guard Regional Headquarters

Briefed about major infrastructure projects under progress to strengthen Coastal Security matrix



Port Blair, Dec. 1

The Lt. Governor, A&N Islands, Prof. Jagdish Mukhi visited Coast Guard Regional Headquarters (Andaman & Nicobar) yesterday and was presented an overview of the operations and activities of Coast Guard in the Andaman and Nicobar Islands. The Lt. Governor interacted with Coast Guard Officers and discussed matters related to Coastal Security imperatives of the Islands,

Coast Guard stake and responsibility towards safety and security of mariner & fisher folks at sea, the inter operability and synergy with other state agencies. The Lt. Governor visited Regional Operation Center (ROC) at this Headquarters for a first hand overview of the surveillance facilities and operational efficiency of the Coast Guard organization.

Inspector General KS Sheoran PTM, TM

Commander Coast Guard Region (A&N) briefed the Lt. Governor about major infrastructure projects under progress to strengthen the Coastal Security matrix with emphasis on the Chain of Static Sensors (RADAR) project. COMCG (A&N) elucidated the Coast Guard Charter of duties for the Lt. Governor and informed on various operations including search & rescue, anti-poaching, medical evacuation and the

community interaction programmes. The Lt. Governor was hosted at an official reception onboard Coast Guard Ship Vishwast where he met Coast Guard Officers and men serving onboard. Smt Prem Mukhi, the First Lady of the Islands, accompanied the Lt. Governor and interacted with the committee members of the Coast Guard Wives Welfare Association, a CG communiq   said here today.

World AIDS Day observed in Isles

Work in tandem to make the Islands an 'AIDS free zone': Lt. Governor

Along with the rest of the country and the world, 'World AIDS Day' was observed in A&N Islands today to create greater awareness about the disease. The main function for the observance was organized at the Auditorium of GB Pant Hospital here this evening by the A&N AIDS Control Society (ANACS). The Lt. Governor, A&N Islands, Prof. Jagdish Mukhi was the chief guest on this occasion. The Chief Secretary, A&N Administration, Shri Anindo Majumdar was the guest of honour while the Principal Secretary (Health), Shri Raajiv Yaduvanshi was also present on the occasion.

Addressing the gathering, the Lt. Governor expressed happiness that 'World AIDS Day' is being observed in A & N Islands. He said, the UNO, considering the seriousness of AIDS and its impact on world population, declared 1st December as World AIDS Day, with the objective of creating awareness among people about the dreaded disease, its causes and prevention. Acquired Immunity Deficiency Syndrome, commonly known as AIDS, is a dreaded disease which has spread all over the world and till date no definite cure has been found for it, he said.

The Lt. Governor stated that in order to observe the World AIDS Day meaningfully, it is pertinent to prepare planned activities for prevention



and control of AIDS, setting target of 'zero HIV Islands', and adopting a particular vulnerable village. Arrangements should be made for the visit of eminent Medical Officers, nurses, paramedic staff, medical college students as well as youth to such places for observance of World AIDS Day, in a different and meaningful manner, he observed.

The Lt. Governor lauded the A&N AIDS Control Society for the efforts made in containing the spread of AIDS in the Islands and stressed the need for continuous efforts, particularly at the grass root level. The Lt. Governor appealed to one and all present on the occasion to motivate people in propagating about the causes of AIDS, its mode of transmission

and preventive measures; and to work in tandem in making these Islands an AIDS free zone in the years to come. The Lt. Governor also distributed certificates to the winners of various competitions organized by ANACS as part of the observance of the Day. A puppet show by Ms. Priyanka Talukdar and a welcome song presented by artists of Mukta Dhara received huge applause

In his address, the Chief Secretary, Shri Anindo Majumdar remarked that though the incidence of AIDS in A&N Islands is low as compared to the national level, the vulnerability is more and we cannot be complacent, as we are no longer isolated and are exposed to the disease. He stated that AIDS is a raging global issue and India ranks 3rd

Australia has not lost a Test at the Gabba since 1988 but the Brisbane Test was moved back because of the day-night fixture against Pakistan which starts on December 15. Subsequently, Australia lost in Perth to South Africa, the first time they were defeated in an opening Test of the Australian summer since 1988. After successfully hosting the day-night fixture for the last two seasons, Adelaide, which is earmarked as the second Ashes Test, is almost certain to host the

match under lights. England have not yet publicly committed to playing underlights during the Ashes but it is understood they have agreed in principle. Earlier this year, Alastair Cook, the England captain, and his Australian counterpart Steve Smith publicly stated their preference for the Ashes Tests to remain day fixtures. England will host their first day-night Test against West Indies in Edgbaston in August. James Sutherland, CA chief executive, recently stated an Ashes day-night fixture was a possibility. The venue for the Perth Test, slated for the Third Ashes Test, is unknown and may not be finalised when the schedule is confirmed. There have been plans for the new Perth Stadium, a 60,000 capacity stadium in Burswood, to be open in time for the Ashes but is now likely to be launched to coincide with the start of the Australian football season in 2018.

Sydney, Dec 1 The England and Wales Cricket Board have agreed in principle to play the first Ashes test under lights on next year's tour of Australia, local media reported on Thursday. Cricket Australia have hosted two day-night tests under lights over the last two seasons, both of which have been a commercial success with large numbers attending the matches against New Zealand and South Africa.

Saina Nehwal in Macau Open badminton quarters, Parupalli Kashyap exits

Macau, Dec 1
It was a mixed day for Indians at the Macau Open Grand Prix Gold badminton tournament on Thursday as top seed Saina Nehwal went through to the quarterfinal stage while Parupalli Kashyap bowed out of the tournament in straight sets. Saina Nehwal, who had to undergo a knee surgery earlier in August, survived a scare before going past Indonesian Dinar Dyah Ayustine 17-21, 21-18, 21-12 to reach the last eight.



It was a good start for Saina Nehwal, who led the first game at the halfway mark, but the world No 50 staged a terrific comeback as she took the lead at 19-15, having trailed 7-10 to Saina earlier. Two points went either way and Dinar won the first game comfortably. In the second, Saina surged to a similar 10-3 lead only to find the determined Dinar level it

back at 18-18. However, the comeback was short-lived as Saina went on to take the next three points and drew the match level at 1-1. The manner in which Saina forced the comeback seemed to have taken the Indonesian by surprise as she went down 12-21, virtually without a fight, handing Saina Nehwal yet another hard-fought victory. Saina, who is yet to reach the last four of a tournament having crashed out of China Open in

Magnus Carlsen wins third world chess title



New York, Dec 1
Magnus Carlsen of Norway has won the World Chess Championship for the third consecutive time after defeating

challenger Sergey Karjakin of Russia. Carlsen sealed victory following three weeks of play and a series of tiebreakers in New York. Karjakin tied against Carlsen in 12 regular rounds but was beaten in the final phase of four quickfire games. Organisers said the event was followed by about six million chess fans around the world. The prize of 1.1 million dollars is divided between the two players with the winner taking 60 per cent.

handed over 12 cartons of Baghban tobacco, 2 packet of Khaini pouches and 5 pans, seized from the residential premises of Food Business Operator Shri. Ajit Biswas, R/o Subash Nagar, Shadipur. The market value of the contraband product is estimated to be around Rs. 7800/- approx.

Further, the Food Safety officers also seized large quantity of contraband tobacco products from different locations of South Andaman including Havelock and Little Andaman. Accordingly 17 FBOs have been booked under relevant sections and compounding procedure is under process and the confiscated tobacco products have been destroyed by burning. All the stocks kept on hold at Little Andaman by the Food Business Operators has been destroyed by burning in the presence of Senior Officials of Little Andaman and Food Business Operators yesterday. The Market value of the stock destroyed is approx. Rs. 75000/-
