

Similarly, no landlord/owner/manager or the residential/commercial etc establishment shall employ any servants/house help/unless and until he/she has furnished the particulars of the said servants (s) to the local Police Station. All the persons who intent to offer accommodation on rent or employ any servant/house help shall inform in writing the particulars of tenants, paying Guests & Servants to the Station Officers concerned in whose jurisdiction the premises falls. Any breach of this order would invite action Under Section 208 of Bharatiya Nagarik Suraksha Sanhita (BNSS)-2023.

In view of above the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.
