Andaman oil exploration may propel India towards \$20 trillion economy: Lt Governor, A&N Islands

Admiral D K Joshi, PVSM, AVSM, YSM, NM, VSM, (Retd.), Hon'ble Lt. Governor, A&N Islands and Vice-Chairman, Islands Development Agency said that projects worth Rs. 82,450 crores are planned for Great Nicobar Island including the transshipment terminal, a power plant and a proposed township

Oil exploration in the Andaman Basin could significantly boost India's long-term economic prospects and support its journey towards becoming a \$20 trillion economy, Admiral D K Joshi, PVSM, AVSM, YSM, NM, VSM, (Retd.), Hon'ble Lt. Governor, A&N Islands and Vice-Chairman, Islands Development Agency said, PTI reported.

Speaking at the 30th Colonel Pyara Lal Memorial Lecture in New Delhi on "Development of Andaman & Nicobar Islands: Challenges & Imperatives", Hon'ble Lt. Governor outlined key development initiatives underway in the archipelago.

"We have been able to free up 63.5 per cent of the 6 lakh sq kms 'No-Go Zone' for oil, with Andaman Basin having been reported as 'Guyana-like potential', which could propel India's growth from a \$4 trillion economy toward a \$20



trillion dollar economy," he said.

Hon'ble Lt. Governor who also serves as Vice-Chairman of the Islands Development Agency (IDA), said the archipelago is positioned to play a significant role in advancing

Hon'ble Prime Minister, Shri Narendra Modi's vision of self-reliance, innovation and citizen empowerment.

He highlighted that Galathea Bay at Great Nicobar has been notified as

India's 13th major port. The project will be developed under the Public-Private Partnership (PPP) model and will include an International Container Transshipment Terminal (ICTT).

The proposed transformation of the islands into a ship repair and shipbuilding hub in the Indo-Pacific region is another key initiative, leveraging the region's strategic maritime location, he said.

Hon'ble Lt. Governor added that projects worth Rs. 82,450 crore are planned for Great Nicobar Island, including the transshipment terminal, a power plant and a proposed township. These initiatives, he said, would strengthen maritime trade, connectivity and national security, and act as a force multiplier in advancing India's geo-strategic and economic interests. 

No separate NOC required for Doctors to practice in A&N Islands: DHS

The general public and all concerned have been informed that there are no separate rules or regulations in the Union Territory of Andaman & Nicobar Islands mandating issuance of a No Objection Certificate (NOC) for medical practitioners.

Accordingly, any medical practitioner

who possesses a valid registration from any State Medical Council or the National Medical Commission is eligible to practice in the Union Territory of Andaman & Nicobar Islands. Therefore, no separate NOC from the Health Department, A&N Administration is required for practicing in this UT, a press release from DHS said.

vehicular movement and the safety of the devotees:

ONE WAY:

1. The stretch from Corbyn's Chowk Junction to Mazar Pahad via Corbyn's Cove has been declared as a One-Way Route, with entry permitted only from Corbyn's Chowk Junction and exit through Mazar Pahad. No vehicles shall be allowed to ply from Mazar Pahad towards Corbyn's Cove Beach, except two-wheelers.

2. The entry of Heavy Goods Vehicles (HGVs) on the stretch from Corbyn's Chowk Junction to Mazar Pahad via Corbyn's Cove shall remain restricted during the period.

3. The road leading from Children's Park, Chakkargaon to Corbyn's Cove Road shall remain closed for general vehicular movement, except for two-wheelers, during the period of Holi celebrations.

The above traffic restrictions shall be enforced on 04.03.2026 from 0900 Hrs to 1600 Hrs. This order shall come into force with immediate effect and shall remain valid for the above-mentioned date and time unless withdrawn earlier, a notification issued by DM (SA) said.

Swift & courageous response by Fire Service at Baratang averts major loss

On 01.03.2026, during the evening hours, a major fire broke out at M/s Mohan Mutha Infrastructure Pvt. Ltd.'s Bitumen Heating Plant at Sundargarh, Baratang. The 20-ton capacity plant was engulfed in intense flames, posing a grave threat of the fire spreading to nearby areas and potentially disrupting the ongoing NH-04 road construction works.

Upon receiving the alert, Fire Service personnel responded without delay, mobilizing water tender and multi-utility vehicles along with all necessary fire-fighting equipment and extinguishing resources required to combat a high-intensity industrial fire. The operation was led by ASI S. Subba Raj and executed by a



committed team within half an hour, averting a major catastrophe. Property worth approximately 80.00 lakhs was saved, no injuries or casualties were reported, and the risk to personnel and surrounding infrastructure was effectively minimized. The timely intervention ensured uninterrupted continuation of the critical infrastructure work and reflected the preparedness and dedication of the Fire Service team, a press release from SP, N&MA said.


