Mechanized fishing vessel owners urged to comply with provisions of A&N Islands Marine Fishing Regulation, 2003 & Marine Fishing Rules, 2004

Sri Vijaya Puram, Aug. 1

The Zonal Fisheries Office, South Andaman, has advised all mechanized fishing vessel owners, and a s s o c i a t e d stakeholders to strictly comply with the provisions of the A&N Islands Marine Fishing Regulation, 2003, A&N Islands Marine Fishing Rules, 2004 and

s u b s e q u e n t amendments for u n d e r t a k i n g sustainable harnessing of Fishing Resources. The Mechanized fishing vessels (having engine of 30 HP capacity and above) are strictly prohibited from carrying out fishing operations within the 0-6 nautical miles (NM) zone and for operating

in creeks, channels, estuaries and other prohibited areas. As per the A&N Islands Marine Fishing (Amendment) Rules, 2025, mechanized fishing vessels shall operate only in the 06-12 nautical mile zone of territorial waters using permitted gears like gillnet, long line,

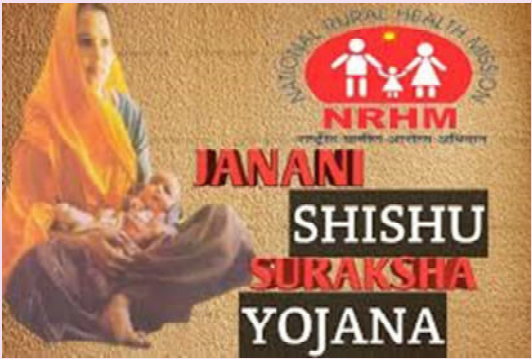
Janani Shishu Suraksha Karyakaram 3914 beneficiaries received benefits during 2025-26 under the scheme in A&N Islands

Janani Shishu Suraksha Karyakaram (JSSK) is an initiative to provide completely free and cashless services to pregnant women including normal deliveries and caesarean operations and sick new born (up to 1 year after birth) in Government health institutions in both rural & urban areas.

Ministry of Health and Family Welfare (MoHFW), Government of India has launched the (JSSK) on 1st June, 2011 in view of the difficulty being faced by the pregnant women and parents of sick new-born along-with high out of pocket expenses incurred by them on delivery and treatment of sick- new-born. The scheme is to benefit pregnant women who



access Government health facilities for their delivery. Moreover, it will motivate those who still choose to deliver at their homes to opt for institutional deliveries. According to data received from Directorate of Health Services, entitled benefits were extended to institutional deliveries under JSSK and altogether, 3914 beneficiaries received benefits during 2025-26 under this scheme in A&N Islands. The scheme has eliminated out of pocket expenses

incurred by the pregnant women and sick new borne while accessing services at Government health facilities. The following are the Free Entitlements for pregnant women:

- > Free diet during stay in the health institutions
- > Free provision of blood

hook & line and pelagic trawl net etc.

All the fishing boats fitted with engines having engine of 30 HP capacity and above to strictly use gillnet of not less than 25 mm, pelagic trawl net with cod end not less than 30mm mesh size. The usage of knotless gillnet made of monofilament twine locally known as plastic jaal is strictly prohibited.

All fishermen and fishing vessel owners have been warned that any violation of the provisions of the Regulation and Rules, including fishing in prohibited areas or using unauthorized fishing gears, shall attract strict legal action, including imposition of penalties/fines and other actions as provided under the rules.

All stakeholders have been requested to cooperate with the Department in ensuring sustainable fisheries management and the conservation of marine fishery resources, a press release from Department of Fisheries said.

has been set up to strengthen poultry-based livelihood activities among Self Help Group (SHG) members. The Hatchery Unit, with a capacity to incubate 240 eggs at a time, will ensure the availability of quality chicks and provide livestock support services to SHGs and local farmers. The SHG members of GP Beodnabad, Calicut and Sippighat involved in Livestock rearing are expected to benefit from the centre, which will play a vital role in promoting poultry farming, enhancing household incomes, and creating sustainable livelihood opportunities.

The two poultry shelters are constructed under VB G-RAM-G to support SHG members of GP Beodnabad in taking up poultry farming on a sustainable basis. Each poultry shelter has been constructed with approximate expenditures of Rs.1.50 Lakh, generating nearly 130 persondays each. Designed to accommodate 50 birds each, these shelters will provide SHG members with the necessary infrastructure to undertake scientific poultry rearing, enabling them to generate regular income, improve nutritional security, and become economically self-reliant. 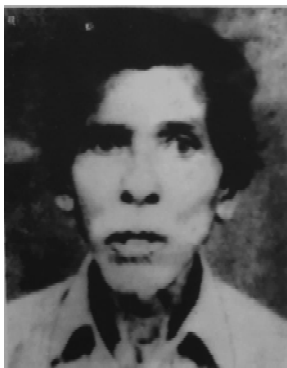

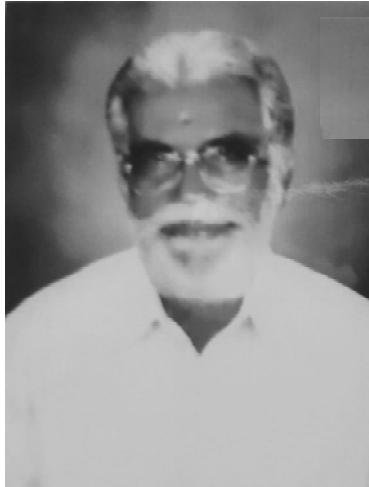
