Hon'ble MP expresses gratitude to A&N Administration for enhancing financial support & facilities for patients referred under Ayushman Bharat Scheme

Sri Vijaya Puram, Sept. 3

Shri Bishnu Pada Ray, Hon'ble Member of Parliament, Andaman & Nicobar Islands, has expressed his gratitude to the Government of India and the A&N Administration for enhancing the financial support and facilities available to patients referred under the Ayushman Bharat Scheme.

During a press conference held today at MP Office, the Hon'ble MP stated that, with a view to extending better facilities and financial assistance to patients referred under the Ayushman Bharat Scheme, he had raised several important issues with the Hon'ble Lieutenant Governor, A&N Islands, on 21 October, 2025.

Following discussions held under the Chairmanship of the Chief Secretary in the General Body meeting of the State Health Society, the issues raised by the Hon'ble MP have



been considered, and appropriate decisions have been taken to modify the existing guidelines relating to referral cases, with the objective of safeguarding the interests of patients covered under the Ayushman Bharat Scheme and referred to empanelled hospitals. This has been confirmed in a written communication sent to Hon'ble MP by the Secretary (Health), A&N Administration on 28.08.2026.

The enhanced facilities and modifications in the guidelines, effective from 1st August, 2026, include:

1. **Enhanced income ceiling:** The income ceiling for eligibility under the

Ayushman Bharat Scheme has been enhanced from Rs.3 lakh to Rs.5 lakh, enabling eligible beneficiaries to avail cashless treatment up to Rs.5 lakh.

2. **Air travel facility:** The earlier provision of ship fare for the patient and attendant has been revised. The patient and one attendant are now permitted to travel by economy-class air travel, subject to a maximum reimbursement of Rs.40,000.

3. **Wage-loss compensation:** The provision of wage-loss compensation of Rs.1,000 per day for up to 20 days, which was earlier restricted to certain categories, has now been extended to all categories of patients referred under the scheme.

4. **Stretcher charges:** Stretcher charges, without any prescribed ceiling, will be arranged and paid by the Administration in advance. Consequently,

patients will not be required to

Administration sanctions construction of Steel Bridge at Tugapur, Mayabunder

Long-pending demand of local residents fulfilled

Sri Vijaya Puram, Sept. 3

The Andaman and Nicobar Administration has accorded sanction for the construction of a Steel Bridge near the residence of Shri Amulya Bepari at Tugapur No. 7, Mayabunder, at an estimated cost of Rs.5,91,78,968/-.

The construction of the bridge has been a long-pending demand of the villagers and local PRIs of the area. Initially, a proposal for construction of a foot bridge at the location was under consideration. However, in view of the persistent demand

of local residents for a motorable bridge, the matter was taken up during a community meeting held at Tugapur No. 7 on 14.05.2025, in the presence of the Hon'ble Member of Parliament, A&N Islands, PRI representatives and officials of APWD.

During the meeting, the need for a motorable Steel Bridge was discussed in detail, considering the difficulties faced by residents in movement and connectivity. Based on the request of the public representatives and the requirements of the local population, the matter was

subsequently pursued with the Andaman and Nicobar Administration, resulting in the sanction of the much-needed bridge.

The proposed Steel Bridge is expected to significantly improve connectivity for the residents of Tugapur and adjoining areas, facilitate the movement of vehicles and strengthen the rural road network in the Mayabunder region. The project is proposed to be completed within a period of 12 months.

The major components of the work include construction of approach roads,

manufacturing, supply and installation of steel bridge components, and other associated civil and structural works required for making the bridge fully functional.

The sanction of the project marks an important step towards addressing the long-standing connectivity requirements of the people of Tugapur and adjoining areas and reflects the Administration's continued focus on improving rural infrastructure and providing better connectivity to local communities, a press release from APWD said.

Gems of India Challenge 2026 Submission Window extended till September 30

A&N Police shows outstanding performance across all cybercrime parameters in PRAGATI review

Sri Vijaya Puram, Sept. 3

A&N Police has earned national-level recognition for its outstanding performance across all parameters assessed under the State/UTs Performance Matrix for the period from 1st January to 20th August 2026, as reviewed during the 52nd PRAGATI Review Meeting chaired by the Hon'ble Prime Minister of India. The Cybercrime Performance Matrix assesses the performance of States and Union Territories across key areas, including cybercrime prevention and response, investigation, victim assistance, inter-agency coordination, and capacity building.

A&N Islands recorded excellent performance across all the parameters assessed, reflecting the consistent and focused efforts of Andaman & Nicobar Police towards

strengthening the cybercrime response system in the Islands. The assessment covered important initiatives such as the State Cybercrime Coordination Centre (S4C), e-Zero FIR, Grievance Redressal Module (GRM), Money Restoration Module (MRM), Sahyog and Samanvay platforms, cybercrime hotspot action, CyTrain and IEC activities.

As part of these efforts, the Andaman & Nicobar Islands Cybercrime Coordination Centre (ANI4C) has been established and operationalised, while the e-Zero FIR mechanism has also been successfully implemented in the Union Territory. The threshold for FIR registration in cyber financial fraud cases has been reduced from

bear this expenditure from their own resources.

5. **Airport/harbour transportation:** Ambulance/cab charges from the airport or harbour, up to Rs.3,000, will be reimbursed.

6. **Air ambulance facility:** In cases involving seriously ill patients requiring evacuation by air ambulance, the cost will be borne by the Administration. The process for finalising the arrangement through tie-ups with the concerned Government agencies is currently underway.

7. **MRI facility:** The proposal for installation of an MRI facility at GB Pant Hospital is at the final stage, and necessary steps have already been initiated.

8. **Availability of medicines:** Steps have also been taken to earmark Rs.30 Cr. to ensure uninterrupted availability of medicines to patients through a proper and continuous supply chain, thereby avoiding hardship to patients who may otherwise be compelled to purchase medicines from private medical shops.

Hon'ble MP stated that these measures would provide significant relief to patients and their attendants, particularly those requiring referral treatment outside the Islands, and would go a long way in safeguarding the interests and welfare of the people of A&N Islands, a press release from Office of MP, A&N Islands said.

Rs.1 lakh to Rs.50,000/-, enabling FIRs to be registered for cyber financial losses of Rs.50,000/- and above. This will help more victims receive timely legal and investigative assistance.
