World Health Day today- An insight into ANISHI Scheme Provides cashless medical treatment benefit upto Rs. 5 lakhs

Port Blair, April 6
Along with the rest of the globe, World Health Day will also be celebrated here in A&N Islands tomorrow. The theme for this year's celebration is 'Universal health coverage: everyone, everywhere'.

The Health Department of Andaman & Nicobar Administration is implementing ANISHI Scheme which provides cashless medical treatment benefit upto Rs. 5.00 Lakhs per patient per illness to the people belonging to Below Poverty Level / Priority House Hold, Pensioner of A&N Administration who have settled in these Islands after retirement with their



dependent family member and Permanent Resident whose family annual income is below Rs. 3.00 Lakhs. The eligible person(s)/patient can avail the cashless benefit in any empanelled hospital notified by the Administration from time to time 'by completing the codal formalities at Nodal Cell (ANISHI)'.

As specified under the scheme, the patient is to be

referred by the concerned specialist of GB Pant Hospital, Port Blair thereafter, he/she has to approach the Nodal Cell (ANISHI) located at DHS Office for cashless benefit of the scheme. If the beneficiary is a permanent resident, he needs to submit annual family income certificate issued by Tehsildar, a copy of Islander /Voter /Aadhaar card and

Ration card. The pensioner have to submit a copy of Pension Pay Order. The state Nodal Cell processes the case within 02 days and after obtaining approval of the Chairman ANISHI, orders are issued to the empanelled hospital to provide cashless benefit to treat the referred patient under the ANISHI Scheme.

In case the beneficiary is on his personal visit to mainland and had fallen sick requiring emergency treatment and gets admitted to one of the empanelled hospital under the scheme, the Medical Superintendent /Director of the concern empanelled hospital in mainland will have to first

Cyber crime using ATM cards General public cautioned to be vigilant & change PIN of ATM cards in case of theft

Port Blair, April 6
The general public needs to be beware of a new form of cybercrime. In the last few days, several persons have informed police stations, that money has been fraudulently withdrawn from their accounts using ATM cards in the mainland particularly Delhi although they have not given their ATM cards to anyone. The fraud is not limited to any particular bank and it seems to have affected customers of all banks alike. Further, in these transactions, the money is withdrawn from the ATMs without disclosure of confidential information like ATM PIN. The general public have been requested to change the PIN of their ATM cards immediately to avoid any such loss on account of fraud. The ATM PIN can be changed either at the ATM machine or using internet banking or using mobile app of concerned bank.

The Reserve Bank of India has defined limited liability of customers in Unauthorized Electronic Banking Transactions. Hence, the customers who are affected by such fraud have been requested to approach the concerned bank with an application within 3 working days for redressal of their grievance, a communication said.

Coming into the IPL after two years of suspension, Chennai Super Kings will be led by the captain cool M.S. Dhoni. CSK fans thronged the M.A. Chidambaram Stadium to back their superstars when the practice sessions were held in Chennai. The rivalry between these two teams is quite well known. Chennai Super Kings has won the IPL twice while Mumbai Indians has won three times. Both the teams have played 22 matches against each other. Mumbai Indians has won 12 times while Chennai Super Kings has won 10. The last time the two teams met was in 2015.

**Weightlifter Sanjita Chanu wins
2nd gold medal for India**



Gold Coast, April 6
After Indian weightlifters bagged two medals on the first day of the Commonwealth Games 2018 at Gold Coast in weightlifting, Manipuri lifter Sanjita Chanu made the country proud by winning the second gold medal in women's 53-kg weightlifting event on Friday. Sanjita Chanu also broke the Commonwealth

Games record by lifting 84kg in Snatch. She lifted a total of 192 kg (84 kg in Snatch and 108 kg in Clean and Jerk) to win the medal for India. Defending champions Loa Dika Toua of Papua New Guinea was distant second with 182 kg, while New Zealand's Rachel Leblanc-Bazinet took bronze with 181 kg. Sanjita had earlier won the

gold in the women's 48 kg category at Glasgow in the 2014 Commonwealth Games and she lived up to expectations of her coach and countrymen by winning another one in Gold Coast. With Sanjita Chanu winning a gold, India's medal count has now reached 3 on the Day 2 as of now.

They are third in the table after England and Australia.

**Teenager Deepak becomes youngest
Indian weightlifter to win medal at CWG**

Gold Coast, April 6
Teenager Deepak Lather today became the youngest Indian weightlifter to claim a Commonwealth Games medal, clinching a bronze in the men's 69kg category here. The 18-year-old from Haryana lifted a total of 295kg (136kg+159kg) to finish third after his nearest rival, Vaipava Loane, fouled his last two lifts to end with a total of 292kg. The youngster, competing in his maiden Commonwealth Games, holds the distinction of being the youngest to hold the national

**Boxers Amit, Naman enter
quarter-finals**

Gold Coast, April 6
Indian boxers Amit Panghal (49kg) and Naman Tanwar (91kg) on Friday advanced to the quarter-finals after notching up comprehensive wins in their opening bouts of the Commonwealth Games here. Tanwar defeated Tanzania's Haruna Mhando in a lopsided unanimous verdict to make the last-eight stage in the afternoon session. In the evening session, Amit got the better of Ghana's Tetteh Sulemanu in another one-sided bout that ended in judges ruling unanimously in the Indian's favour. The 19-year-old Tanwar, making his debut at the Games, is a bronze-medallist from the World Youth Championships. He had defeated reigning Asian silver-medallist Sumit Sangwan in the trials to make the squad. Amit, on the other hand, is chasing a third successive international gold medal, having claimed top finishes at the India Open and the Strandja Memorial Tournament before coming here.

**India women's hockey team back to
winning ways, beat Malaysia 4-1**

Gold Coast, April 6
After a disappointing start to the Commonwealth Games campaign, the Indian women hockey team got back on track as they defeated Malaysia 4-1 in a pool A clash in Gold Coast on Friday. Defender Gurjit Kuar's brace helped the team get to winning ways as she converted two penalty corners successfully in the 6th and the 39th minutes. Her goals were followed by those of captain Rani Rampal (56th minute) and Lalremsiami (59th minute). Malaysia's lone goal came from a penalty corner chance in the 38th minute through Nuraini Rashid. "It's quite a good result, in the second half we did much



better. Malaysia played well in the first and second quarters and didn't give us much space," India captain Rani Rampal said after the much-needed win. "Yesterday (Thursday 5 April) was quite a bad day, but in sport sometimes you lose and we now have to bounce back. Today our defensive structure

was good and we played a controlled game," Rani stated. India's hockey campaign was off to a disappointing start at the Commonwealth Games after the country's women's team was upstaged 2-3 by a lower-ranked Wales in a Group A clash. India will now play England on April 8.

**India rout Scotland 5-0 to enter badminton
mixed-team event quarterfinals**

Gold Coast, April 6
Indian badminton players did not let their winning spirit die down after the first day of Commonwealth Games 2018 as they beat Scotland 5-0 in another whitewash victory to enter the quarterfinals of mixed-team event. Powered with ace shuttlers Saina Nehwal and Kidambi Srikanth, India beat Sri Lanka, Pakistan and Scotland all by the same margin. Saina started India's campaign against Scotland on Friday as she beat Julie Macpherson 21-14, 21-12 in women's singles at the Carrara Sports Arena, giving her side 1-0 lead. It was a one-sided encounter as Saina used her experience to reach an easy victory against her opponent. After struggling on Day 1 against Pakistan's Murad Ali,



Srikanth took the centrestage against Kieran Merrilees in men's singles. The Indian shuttler started on a bad note, trailing 4-1 but comeback after the mid-game break in a thrilling encounter to win the first game 21-18. His second game, however, was in complete contrast to the first with Srikanth on fire. He took a powerful 17-0 lead to completely destroy his opponent, winning the second game with a margin of 21-2. Later, Sikki Reddy-Ashwini

Ponnappa won 21-8, 21-12 against Scotland's Kirsty Gilmour-Eleanor O'Donnell in the women's doubles category to give India 3-0 lead. Satwik Rankireddy teamed up with Chirag Chandrashekar Shetty in the men's doubles to beat Patrick Machugh-Adam Hall 21-16, 21-19 while Pranaav Chopra-Sikki Reddy had an exciting encounter against Martin Campbell-Julie Macpherson to emerge winners by 21-17, 21-15.

inform the Nodal Officer (ANISHI) about the particulars of the patient and his/her clinical condition. The State Nodal Cell after verification of records convey the approval to treat the patient as per the guidelines of the scheme, however the patient/relatives have to submit the documents as the case may be. In such cases, the travel expense to the patient/attendant will not be reimbursed. If the patient get admitted in a 'hospital which is not empanelled' under the scheme, then benefit will be extended only if the patient is shifted to the nearest empanelled hospital under the scheme. In case the beneficiary undergoes treatment or on his own gets admitted in empanelled /non-empanelled hospital without completing codal formalities at State Nodal Cell (ANISHI), the reimbursement of hospital expense for such cases 'will not be allowed' under the scheme.
