## New Chapter in Island Tourism: Little Andaman to witness historic surfing showdown

### Department of Tourism in association with Surfing Federation of India set to host National-Level Surfing C'ship titled 'Little Andaman Pro 2026' at Butler Bay Beach from April 9 to 12

### Event formally inaugurated with participation of Federation representatives and surfers from India and abroad

Sri Vijaya Puram, Apr. 6 In a significant milestone for the Andaman & Nicobar Islands, the Department of Tourism, in association with the Surfing Federation of India, is set to host a National-Level Surfing Championship titled 'Little Andaman Pro 2026' in Little Andaman for the very first time. The championship will be held from April 9 to 12 at the scenic Butler Bay Beach, marking the beginning of a new era for water sports in the Islands.

The Little Andaman Pro 2026 assumes greater significance as it debuts in a highly anticipated season for Indian surfing, just ahead of India's first-ever surfing campaign at the upcoming Asian Games 2026 in Japan. The four-day championship will witness participation of



around 86 surfers, including international competitors, who will compete across multiple categories such as Men's Open Surfing Shortboard, Women's Open Surfing Shortboard, Men's Open Stand-Up Paddleboard (SUP), and Women's Open Stand-Up Paddleboard (SUP). Adding further prestige to the event, internationally acclaimed Judge Mr. Rory Symes from Australia has been appointed as the Head Judge. With the hosting of the Little Andaman Pro 2026, the Andaman & Nicobar Islands are set to script a new chapter in adventure tourism and water sports, firmly establishing Little Andaman as an emerging destination for surfing in India.

The event was formally inaugurated today at Megapode Nest by Chief Secretary, A&N Administration, Dr. Chandra Bhushan Kumar, IAS in the presence of Senior Officers of the A&N Administration, representatives of the Surfing Federation of India, and a large gathering of surfers from across the country. The inauguration ceremony reflected the growing importance of



adventure tourism and the Administration's commitment to promoting the Islands as a hub for global sporting events.

Addressing the gathering, the Chief Secretary expressed his happiness over the organisation of such a prestigious event in Little Andaman, stating that it would significantly enhance the global visibility of the Andaman & Nicobar Islands. He highlighted the wide range of water-based and adventure activities already popular in the Islands, including scuba diving and game fishing, and spoke about the strong sporting culture in disciplines such as Football, Cycling, Kayaking & Rowing, where athletes from the Islands have brought laurels to the nation.

Emphasising the importance of youth participation, he expressed hope that witnessing top surfers in action would inspire local youth to take up surfing and other water sports. He noted that any sport thrives when it is embraced by the younger generation and encouraged the participants to showcase their best performances while upholding the spirit of sportsmanship and

unity. In her address, the Commissioner-cum-Secretary (IP&T), Ms. Chanchal Yadav, IAS said that the overwhelming response from the surfers across India is unbelievable. She said that surfing is one of the most popular water sports in the world and is growing phenomenally. This is the first of the beginning to bring world's most popular and premier water sports to the Islands, which the Commissioner said the remarkable event, the Tourism Department has put up. She further stated that by seeing the surfers from different parts of the country in action, islanders especially youth & athletes will take courage to venture into this field and join this sport. ## Operation 'Sea Sentinel' launched by Nicobar District Police; 11 foreign poachers apprehended & approx. 800 kg of illegally harvested sea cucumber recovered

Car Nicobar, Apr. 6 An anti-poaching operation was launched by Police Station Nancowrie in the sea areas off Kakana, Pilpillow, Pondha and Dering on 04/04/2026 at about 0915 hrs. The operation was carried out by a police team comprising SI (ED) M. M. Dasan, PC/2940 Kenny Roger, CT/021284 Raj Kumar, HG(V)/671 Lucas and HG(V)/634 Anjaan. During the operation, at about 1040 hrs, a suspected Myanmarese poaching vessel was detected near the coast of North Kakana. On noticing the police



presence, the vessel cut its anchor rope and attempted to flee towards the south-east direction off Tillong Chaung. Acting swiftly, the police team pursued the vessel and in coordination with the Indian Coast Guard, attempted to intercept it. Two warning rounds were fired by PC/2940 Kenny Roger. However, the poachers ignored the warning and continued to flee. No injuries were reported. The fleeing vessel was subsequently intercepted and abandoned near Isle of Man Island, where the poachers escaped into

the dense forest. Following this, a large-scale operation codenamed 'Sea Sentinel' was launched, with teams from PS Nancowrie and LoP Tillangchaung, led by SI L Hari Krishna, undertaking extensive search and surveillance operations under challenging terrain and weather conditions. On 05/04/2026 at about 0715 hrs, a joint team of police personnel and 11 Army personnel carried out intensive search operations, resulting in the apprehension of one Myanmarese

## Mainland Island summer vacation schedule of vessel MV Swaraj Dweep, Nalanda & MV Campbell Bay revised

Sri Vijaya Puram, Apr. 6 All passengers and the general public have been informed that the vessels MV Campbell Bay and vessel Sindhu are currently undergoing dry dock/Annual Planned Survey (APS) at Kolkata. MV Campbell Bay was scheduled to arrive at Sri Vijaya Puram by the first week of April, 2026; however, due to unforeseen circumstances, its arrival has been delayed. Owing to the non-availability of these vessels, the Directorate of Shipping Services is facing difficulties in

maintaining the scheduled sailings in the Inter-Island sector. It has further been reported that there is heavy passenger traffic and acute shortage of essential commodities in the Southern Group of Islands. In order to address this situation, the vessel Nalanda, with a cargo capacity of 150 tonnes, is required to be deployed to the Southern Group of Islands, as MV Kalighat is insufficient to meet the required cargo demand due to insufficient Cargo

**PM Suryaghar Muft Bijli Yojana: A step towards net zero and consumer empowerment**

Sri Vijaya Puram, Apr. 6  
The general public, all Government Departments, and all Private Organizations have been informed that the earlier load shedding schedule dated 16.12.2025 had an average load-shedding duration of 60 minutes. However, during March 2025, only 45 min of load shedding was actually implemented approximately.

The Electricity Department is working on different augmentation projects across South Andaman to enhance power generation capacity and to significantly reduce or completely eliminate load shedding. With the addition of 2.5 MW generating capacity at Phoenix Bay Power House and Commissioning of new 5 MW Plant by M/s Modern Hiring Services on 03/02/2026, the shortage has been reduced considerably.

Now, the new load shedding schedule has been prepared for only 45 minutes during Evening hours especially and Day and Night hours load shedding has been exempted.

Day and night time load shedding, if required, shall be purely depending on unforeseen shortages, if occur, which depends purely on weather conditions & other technical breakdowns.

Further steps are being taken to further reduce the duration of load shedding and to fully eliminate the cause. Projects underway are -  
> 10 MW HPP- M/s Sudhir Sales & Services Ltd. is expected to be commissioned shortly.  
> 3 x 2000KVA D.G. Sets in house augmentation at BBPH under tendering process.  
> 7 x 2000KVA D.G. Sets in house augmentation at CPH under tendering process.

The Administration reiterates that to overcome the dependency of consumers in the grid supply, the PM Suryaghar Muft Bijli Yojana is nowadays playing a significant role by providing subsidized initial investment contributing substantial energy bill saving and selling surplus power to the grid leading to financial liberation and energy independence.

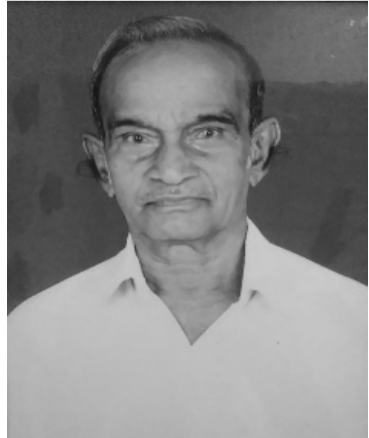
