

Participatory democracy is a must for a country like India: PM

New Delhi, Aug 6
The Prime Minister Shri Narendra Modi has said participatory democracy is a must for a country like India. He said, if democracy is limited to voting and choosing a government then the spirit of democracy would not develop and hence participatory democracy is essential. He said, this is being made possible by technology. He gave the example of Swachh Bharat as an excellent example of public participation.

Shri Modi said responsibility with accountability is hallmark of Good Governance. He said there should be a



balanced coordination between development and good governance for the welfare of people. He emphasised that Last mile delivery is as important as

policies and the benefits must reach the intended beneficiaries. He said lack of good governance results in loss of crores of money.

Shri Modi said, grievance

redressal systems are the biggest strengths of the democracy. He said, the problem of citizen should be addressed and responded, and his government is taking

initiatives in this direction. He came down heavily on so called cow protection brigades saying that such people do so only to cover their anti social activities. Calling for action against criminals donning garb of cow vigilantes, he urged States to prepare dossier of their activities. He said, most of them will be found to be involved in illegal activities.

Speaking at the 'Townhall' event in New Delhi to mark two year completion of MyGov portal, Shri Modi suggested that those who want to serve cows should work towards stopping cows from consuming plastics. He

ANIPMT -2016 topper shares his experience
Says 'hard work, dedication & determination' is what drives a person towards success

Port Blair, Aug 6

Fascinated by human physiology, U. Rohit, the topper of ANIPMT -2016 was inclined towards pursuing MBBS since class XI. Sharing his success mantra during an interview with DT Reporter here today, Rohit said there is no substitute for hard work.

It was mere hard work and dedication which led to Rohit's achievement of being the topper of ANIPMT 2016 scoring a total of 155/180, (84/90) in Biology, (37/45) in Physics and (34/45) in Chemistry. A product of Govt. Model. Sr. Sec.School, Port Blair, Rohit ensured to put in 12 to 13 hours of study, right from the month of April till June while preparing for ANIPMT 2016 including 3 to 4 hours of self study.

Sharing his experience of ANIPMT 2016, Rohit said Biology paper was the easiest while Chemistry was a bit tough and Physics was more calculative and formula based. Asked whether he was expecting to be the topper of ANIPMT, Rohit said it came as a pleasant surprise to him, since he was expecting to score between 120 to 130, as there was a stiff competition.

Rohit revealed that he is the first person from his family to pursue MBBS and attributed his success to his beloved parents, Shri U.Prakash Rao (employee under PBMC) and Smti U. Hemalatha (home maker) for their constant encouragement and support and his aunts for encouraging him

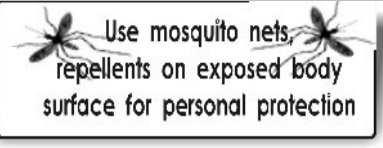

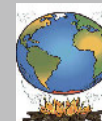

The stadium became a forest floor and people of the native tribes of Brazil, in traditional dress, performed a choreographed dance with the fibre optic lights to recreate tribal art. The Parade of nations started at the Opening Ceremony with Greece entering the stadium as per tradition.

J P Nadda said, the programme is a very cost effective and significant health intervention along with deworming programme. He said, the practice of breastfeeding enhance immunity level in the child and it will greatly help to reduce the under five mortality of children.

Breastfeeding is one of the important interventions for child survival. Around 20 per cent newborn deaths and 13 per cent under-five deaths can be prevented by breastfeeding. Besides this, breastfeeding can prevent child deaths associated with Diarrhoea and Pneumonia.

Infants who are not breastfed are 15 times more likely to die from pneumonia and 11 times more to die from diarrhea than children who are exclusively breastfed. Breastfed infant also have higher intelligence quotient.
