## LG visits Telugu Basti at Old Pahargaon

# Issues on the spot directions to mitigate problems of affected families due to water logging



Port Blair, Sept. 7  
The Lt. Governor, A&N Islands, Prof. Jagdish Mukhi today visited Old Pahadgaon area (Ward no 16) where he met the residents of Telugu Basti whose houses were affected due to water logging following the heavy rain which lashed the city yesterday. The Lt. Governor, accompanied by

a team of Officers of the Administration, personally inspected the main drain in the locality, the depth of which was reduced due to accumulation of filth & mud in yesterday's heavy rain.

The Lt. Governor, after giving a patient hearing to the grievances of the affected families, gave on the spot directions to provide immediate relief to the residents/families. The Lt. Governor asked the Deputy Commissioner, South Andaman to immediately provide food items to the affected families. He also directed the APWD to take up the construction of a wall to

arrest mud sliding, which has resulted in the accumulation of filth/mud in the open drain. The Lt. Governor further directed the Chairperson, Port Blair Municipal Council to take immediate steps to de-silt the drain by involving all manpower available so that the problem of water logging can be solved instantaneously, which, he said, will provide relief to the affected families. The Lt. Governor asked the Deputy Commissioner to immediately remove the encroachment in that area which has hampered the flow of water into drain. He also directed the DCSA to make an assessment of the

damage caused to people at Telugu Basti due to heavy rain, so that required financial assistance can be provided as per the guidelines laid by the Govt. of India. When the Lt. Governor was apprised about the poor quality of drinking water being supplied to the residents of Telugu Basti, he asked the concerned authorities to take two samples of water i.e. one from the APWD storage/treatment plant from where the water is being supplied and other from the taps of the residents so that responsibility can be fixed and the problem can be solved.

The Member of Parliament, Shri Bishnu Pada Ray was also present on the occasion and apprised the Lt Governor about the grievances of the affected families. The Secretary to the Lt. Governor, Dr. A.K. Singla, the Deputy Commissioner, South Andaman, Shri Udit Prakash Rai, The Secretary PBMC, Shri Yashpal Garg, the Chairperson PBMC, Smt. Sheela Singh, Sr. Vice Chairperson and also the Ward Councillor Ward No. 16, Smt. S. Usha, Officials from the District Administration were present during the visit of the Lt Governor.

## Financial support to farmers suffering crop loss

# PMFBY supports sustainable production in agriculture sector

Port Blair, Sept. 7  
The Pradhan Mantri Fasal Bima Yojana (PMFBY) aims at supporting sustainable production in Agriculture Sector by providing financial support to farmers suffering crop loss arising out of unforeseen events, stabilizing the income of farmers to ensure their

continuance in farming, encouraging farmers to adopt innovative agriculture practices and ensuring flow of credit to the agriculture sector. All farmers including share croppers and tenants farmers growing the notified crops in the notified area are eligible for coverage. The

scheme is compulsory component for loanee farmers whereas it is optional for non-loanee farmers. Under the scheme insured area is prevented from sowing/planting due to deficit rainfall or adverse seasonal conditions, yield losses due to non-preventable risks on

standing crop, post-harvest losses and localized calamities such as inundation affecting the isolated farms. Paddy has been notified for Kharif 2016 for 53 Gram Panchayats and for Rabi season 2016-17 Green Gram and Black Gram have been notified. (Contd. on last page)

## 'International Tsunami Drill' Directorate of Disaster Management conducts mock exercise

The real disaster time test for the communication facilities of the Emergency Operation Centers (EOCs), set up at various places of the Islands was conducted by the Directorate of Disaster Management in the Islands today. The mock exercise involved all the EOCs, State Control Room, control rooms of different Departments and stakeholders and was organized as part of the 'International Tsunami Drill' (10Wave 16-Indian Ocean Wide Exercise) conducted in the Indian Ocean rim countries today, involving three Tsunami Service

Providers (Australia, India and Indonesia) of the Indian Ocean Region. The Mock Drill was coordinated by the Intergovernmental Oceanographic Commission (IOC)/United Nations Educational, Scientific and Cultural Organization (UNESCO) of the UNO.

Speaking to The Daily Telegrams, The Assistant Director, Disaster Management (Operation), Shri T K S Ajayan informed that top to bottom communication tests, right from Indian National Center for Ocean Information Services (INCOIS) Hyderabad, Ministry of Earth Sciences, Gol to the

end centers, spread all over the Islands, were conducted and found to be satisfactorily working. All communication equipments in the EOCs, set up at different parts of the Islands are at their best condition and ready for use any time, if disaster occurs, he said.

Shri Gyan Singh, Asst. Director, Disaster Management (Logistic)

informed that the Directorate of Disaster Management is well prepared to take up emergency operation throughout the Islands, with rescue teams and relief materials made available at the different EOCs. Anjum, India's first woman to get MCC membership

New Delhi, Sept 7

Anjum Chopra becomes the first woman cricketer from India to be awarded an honorary life membership of the Marylebone Cricket Club (MCC). Virender Sehwag and Zaheer Khan were recently awarded the MCC memberships too.

A former India captain and recipient of the Padma Shri in 2014, Anjum was thrilled to share the communication from the MCC. "It is actually an honour for women's cricket in India. My journey had begun with a trip to the National Stadium as a schoolgirl and I am delighted to be the first woman player from India to receive the prestigious MCC membership," said Anjum on Tuesday.

Having made her international debut at 17, Anjum went on to play 12 Tests, 127 ODIs and 18 T20s. A left-hander, Anjum aggregated 548

runs in Tests, 2,856 runs in ODIs, which included a century against England at Northampton in 1999. The MCC, while announcing her membership, said, "Since her retirement as a player in 2012, her voice has become familiar to millions across the world in her current role as a commentator on the Indian Premier League (IPL)." Anjum, who was honoured alongside Sehwag, was the first Indian woman to hit an international century.

"I am really humbled to be among an august gathering of some of the finest players the game has seen," said Anjum.

She has found a place among the commentators of the game. "To share the stage with the great Sunil Gavaskar was like a dream come true. I learn from every commentary stint. It helps me stay in touch with the game in some way."

An Arjuna awardee in 2007, Anjum led India to a rare Test series win against South Africa in 2002. "It was a huge boost to our image," said Anjum.



International Cricket Council withdraws two-tier Test proposal under pressure from BCCI

New Delhi, Sept 7

The International Cricket Council on Wednesday withdrew its contentious proposal of having a 'Two-Tier' Test system following "vehement opposition" from world's richest cricketing body BCCI with the support of Sri Lanka, Zimbabwe and Bangladesh. "The two-tier Test system proposal, which was supposed to come up for discussion during the two-day Chief Executives Committee (CEC) meeting in Dubai has been taken off the table keeping in mind the objections raised by four members.

BCCI President Shri Anurag Thakur, who has been a vocal critic of this move terming it a detrimental and retrograde step for the financially weaker nations, welcomed the move. "I am thankful to the members of the ICC who understood our viewpoint and agreed to take this proposal off the table. As one of the key stakeholders in world cricket, BCCI would continue to have an inclusive



approach and ensure that everyone's interest and the growth of cricket isn't compromised," Thakur, who was at the forefront of the anti Two-Tier format, said today. The Indian Board president said the growth and popularity of the game won't suffer because of the existing format.

Monfils overpowers Pouille to reach US Open semifinals

New York, Sept 7

Gael Monfils is back in a Grand Slam semi-final after an eight-year wait, pummeling fellow Frenchman Lucas Pouille 6-4, 6-3, 6-3 to reach the US Open last four. Tenth-seeded Monfils was in control throughout against the 22-year-old Pouille, who was coming off an epic fifth-set tiebreaker win over 14-time major winner Rafael Nadal. That

marked the 24th-seeded Pouille's third straight five-setter. Whether it was a let-down after the biggest win of his career or sheer fatigue, his 44 unforced errors meant he never stood a chance against the dialed-in Monfils. Dictating from the baseline, Monfils took charge with seven of his 13 aces in the opening set, gaining the only break he needed in the seventh game.

As per the guidelines of PMFBY, the Annual Commercial/Agriculture/Horticultural crops are to be covered. As an initial step, it was decided to notify vegetable crops lobia and bhindi for kharif 2016 and Rabi 2016-17 for Manglutan village under Gram Panchayat, Guptapara and Tomato for Gram Panchayat, Neil Island.

The sum insured for all notified crop as per the scale of finance is as under:

As per the operational guidelines of the scheme, the maximum insurance premium payable by the farmers is 2%, 1.5%, 5% for Kharif (Paddy), Rabi (Pulses) and Annual Horticulture Crop respectively. With the view to reduce the financial burden on the farmers, the committee has unanimously considered and fixed 0.5% sum insured as farmer's premium rate uniformly for all the crops.

The Reliance General Insurance Company Pvt. Ltd., has been nominated as implementing Agency for all notified crops for Andaman and Nicobar Islands for 3 years w.e.f. Kharif, 2016 onwards.

The Joint Committee has been formed at district level under the chairmanship of concerned Deputy Commissioner which shall make a Joint inspection in the affected areas immediately after the occurrence on natural calamities and submit assessment report to the Directorate of Agriculture.
