DBT mode, directly crediting the stipend to the bank account of the students to facilitate transparency and timely assistance. The Principal, JNRM, in a press release received here informed that recently, information was received that the girl students in JNRM pursuing higher education were not getting

stipend. On examination, it was found that some of the students changed the bank account number without intimation to the competent authorities, resulting in the rejection of sanctioned stipend in the online mechanism. As no manual interference could be done in the online stipend sanctioning system,

Examination by Staff Selection Commission; 4417 candidates shortlisted

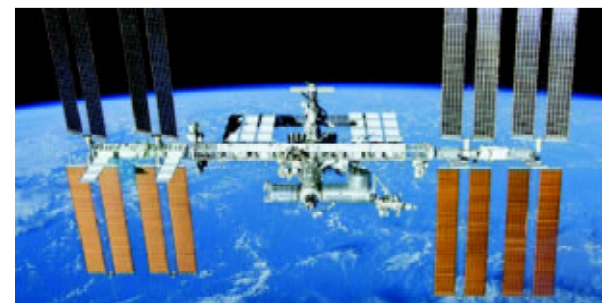

China unveils replica of its first permanently crewed space station

Beijing, Nov 6
 China has unveiled a replica of its first permanently crewed space station, which would replace the international community's orbiting laboratory, ISS. The 17-metre core module was a star attraction at the biennial Airshow China in the southern coastal city of Zhuhai. Three astronauts will be permanently stationed in the 60-tonne orbiting lab, which will



enable the crew to conduct biological and microgravity research. Assembly is expected to be completed around 2022 and the station would have a lifespan of around 10 years.

Star Indian shuttler PV Sindhu cruised past Evgeniya Kosetskaya of Russia in the opening round of the Fuzhou China Open Tuesday. The Olympic silver medallist registered an easy 21-13 21-19 win in a match that lasted less than 30 minutes. Sindhu, who is seeded third, hardly broke a sweat in the first game. She won six consecutive points to take a 1-0 lead. The unseeded Russian tested Sindhu in the second game which went down to the wire. However, the Indian



emerged victorious in the hard-fought encounter. The 23-year-old will now take on the unseeded Busanan Ongbamrunphan of Thailand in the second round. In the women's doubles, the pairing of Ashwini Ponnappa and Sikki Reddy crashed out of the competition after losing in the first round. Ponnappa and Reddy lost 21-19 15-21 21-17 to the Japanese duo of Shiho Tanaka and Koharu Yonemoto.

Saurav Ghosal skips Senior Nationals, aims to defend International title

India's top squash player Saurav Ghosal is skipping the Senior National Championships and instead looking to defend the title in the USD 30,000 Kolkata International meet beginning here Wednesday. Zimbabwe Beat Bangladesh By 151 Runs For 1st Test Win In 5 Years

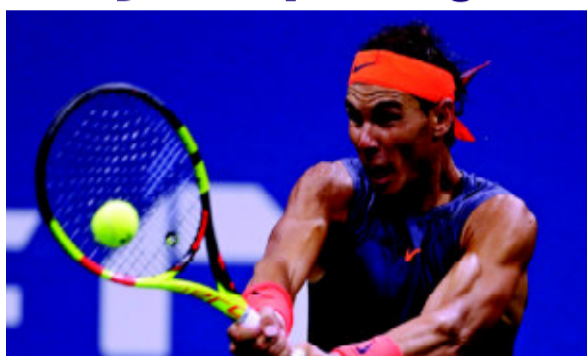
Sylhet, Nov 6
Brandon Mavuta and Sikandar Raza shared seven wickets between them as Zimbabwe recorded their first Test win in five years with a thumping 151-run victory over Bangladesh on Tuesday. Debutant leg-spinner Mavuta claimed 4/21 and off-spinner Raza took 3/41 as hosts Bangladesh were left chasing 321 runs on the fourth day in the northeastern city of Sylhet. Wellington Masakadza, another debutant, also shone with two wickets as Zimbabwe made quick work of Bangladesh's



lower order, dismissing the hosts for 169. Left-arm spinner Maskadza took the final wicket of the innings, sending Ariful Haque for 38 as Zimbabwe notched their first Test win since beating Pakistan in Harare in 2013. It is also the first time Zimbabwe has clinched an away Test victory since beating Bangladesh in Chittagong 17 years ago in 2001. Zimbabwe sensed a win once Raza claimed three vital wickets in the opening session to reduce Bangladesh's innings to half.

Rafael Nadal pulls out of ATP Finals, Novak Djokovic to end year a top rankings

London, Nov 6
Rafael Nadal has pulled out of next week's ATP Tour Finals in London due to injury, so Novak Djokovic will end the year as world number one having returned to the top of the rankings on Monday. French Open champion Nadal announced that an abdominal muscle problem, which prevented him from playing in the Paris



Masters last week, and ankle surgery had forced him to pull out of the season-ending event.

Earth's protective ozone layer healing: UN

New York, Nov 6

A United Nations, UN report has said Earth's protective ozone layer is finally healing from damage caused by aerosol sprays and coolants. According to a scientific assessment released at a conference in Quito, Ecuador, the ozone layer had been thinning

since the late 1970s. Scientists raised the alarm and ozone-depleting chemicals were phased out worldwide. As a result, the upper ozone layer above the northern hemisphere should be repaired in the 2030s and the gaping Antarctic ozone hole should be disappeared in the 2060s.
