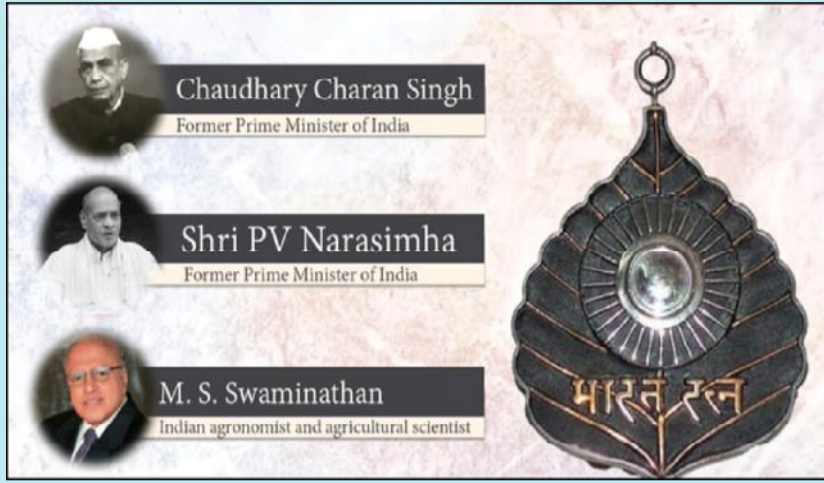
## Former PMs Chaudhary Charan Singh and Shri PV Narsimha Rao and Dr. MS Swaminathan to be conferred with Bharat Ratna

## DLSA to hold National Lok Adalat on March 9

Port Blair, Feb. 9

The District Legal Services Authority, Andaman & Nicobar Islands will be holding National Lok Adalat in the District Court Complex at Port Blair and Sub-Divisional Court Complex at Mayabunder and Circuit Court at Diglipur on 09-03.2024. Besides the compoundable nature of cases pending in different courts, disputes at the pre-litigation stage will also be entertained by the National Lok Adalat for disposal upon consensual settlement between the parties. Pre-litigation disputes include NI Act cases u/s 138, money recovery cases, labour dispute cases, electricity and water bills cases (excluding non-compoundable), maintenance cases, civil disputes and disputes under the Consumer Protection Act.

The general public having any such dispute at the pre-litigation stage or post-litigation stage are at liberty to submit their disputes in writing to the Secretary, District Legal Services Authority, Port Blair before 29.02.2024, so that their disputes may be processed and made ready for hearing before the National Lok Adalat on 09.03.2024, a press release from DLSA said.

**ORDER NO.162**

It has been reported that certain criminal, anti-social elements or terrorists, inimical to India may pose a threat to the safety of general public, dignitaries and vital installations by the use of sub-conventional aerial platforms like para-gliders, para-motors, hand gliders, UAVs, UASs, micro light aircrafts, remotely piloted aircrafts, hot air balloons, small size powered aircrafts, Chinese Lalten, quadcopters or even by para jumping from aircraft etc.

And whereas it is necessary to take suitable security measures in this regard keeping in view the VVIP visit to A & N Islands.

Now, therefore, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure, 1973, I, Veditha Reddy, IAS, District Magistrate, South Andaman District, Andaman And Nicobar Islands, do hereby prohibit flying of sub-conventional aerial platforms like para-gliders, para-motors, hand gliders, UAVs, UASs, microlight aircrafts, remotely piloted aircrafts, hot air balloons, small size powered aircrafts, quadcopters or para jumping from aircraft etc. from 18th February till 24th February, 2024 in the area of Port Blair Tehsil and Swaraj Dweep in connection with the VVIP visit to these islands and doing so shall be punishable under section 188 of the Indian Penal Code.

This order shall come into force with effect from 18th February 2024 to 24th February, 2024 till the return of VVIP. It shall extend to the entire area/jurisdiction of Port Blair Tehsil and Swaraj Dweep.

**ORDER NO.164**

Whereas, in view of the proposed visit of the VVIP to A & N Islands during the 03rd week of February, 2024, elaborate Law & Order arrangement are being made in South Andaman District for the safety & security of VVIP. Considering the significance and security requirement, it is imperative to ensure public safety and order during the period of the visit.

And whereas it is necessary to take preventive measures to maintain law and order, mitigate potential security risks and facilitate the smooth conduct of the VVIP visit to A & N Islands.

Now, therefore, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure, 1973, I, Veditha Reddy, IAS, District Magistrate, South Andaman District, Andaman And Nicobar Islands, do hereby prohibit the assembly of five or more persons in public places from 18th February till 24th February, 2024 in the area of Port Blair Tehsil and Swaraj Dweep in connection with the VVIP visit to these islands and any violation of this order shall be strictly dealt with as per Section 188 of the Indian Penal Code, 1860.

This order shall not apply to Executive Magistrates, Police Personnel and other Public Servants on duty and other Officials for VVIP Visit.

In view of the emergent situation this order is passed ex-parte and addressed to the public in general.

This order shall be enforced by the Sub Divisional Magistrate, Superintendent of Police, S/A District, Executive Magistrates and other Officials on duties during the above said period.

This order shall come into force with effect from 18th February 2024 to 24th February, 2024 till the return of VVIP. It shall extend to the entire area/jurisdiction of Port Blair Tehsil and Swaraj Dweep.

**PS Kalighat destroys illicit liquor containers in Talbagan Forest**

The Kalighat Police executed a swift operation and successfully confiscated a substantial quantity of Lehan in the dense forest of Talbagan, under the jurisdiction of PS Kalighat recently. Acting on a tip off, S/SP Singh, SHO PS Kalighat formed a specialized team consisting of ASIMukesh Charan, I/C OP Kishorinagar, PCs Irenious, Ramu and Shoaib Ali. The proactive team successfully seized a significant quantity of 150 liters of illicit Lehan, along with 1 iron drum, various utensils, and timber materials used in the production process. > Pre-bid meetings will be conducted meticulously for each procurement proposal in order to incorporate generic specifications and clauses in a timely manner, thereby enabling broader participation in GeM bids.

> To enhance publicity and maximize firm participation, all tenders will be published on A&N Police's Social Media Platforms, providing details of the articles to be procured and the bid's closing date.

The vendors received assurances of assistance and cooperation from respective procuring unit officials regarding any doubts or clarifications.
