

## Administration takes preventive step to contain spread of COVID-19 among students

### Higher Educational Institutions & Schools across A&N Islands to remain closed from today

Port Blair, Jan. 10

Consequent on approval accorded by Competent Authority, the classes of five colleges namely - JNRM, TGCE, DBRAIT, ANCOL & MGGC and classes from I to XII of all management schools (Govt., Govt. Aided, Private Unaided, Local Bodies, KVs & JNVs) across Islands will remain closed with effect from January 11 to January 31, 2022 as a precautionary measure to prevent the spread of COVID-19 among students.

Academic instructions to all the students shall continue to be made available through alternate mode by the cable TV, Education Department's YouTube Channel 'AN Education Dept Andaman', All India Radio and WhatsApp Groups, a press release from Directorate of Education said.

Several specific orders were issued by the District Administration, South Andaman from time to time to ensure compliance of the Containment Measures for COVID-19, in view of the recent surge in the positive cases. In order to ensure compliance to the containment measures of isolation and social distancing

in the South Andaman District with some of the strategic areas of intervention focusing on containment, test, track, surveillance, clinical management, vaccination and COVID Appropriate Behaviour to control any surge of the cases of COVID-19- Variant of Concern (VoC), 'Omicron' and also to prevent any disturbance to the

peace and tranquility and taking into consideration the request of the public representatives and general public, Shri Suneel Anchipaka, District Magistrate, South Andaman District, in exercise of the powers vested U/s 144 of Cr.P.C., has ordered following restrictions are enforced in addition to the Order No. 05 dated 3<sup>rd</sup> January

2022. As per the order, Social/ Political/ Sports/ Entertainment/ Academic/ Cultural/ Religious/ Festivals related and other gathering and congregations shall be prohibited. Similarly, all religious places/ places of worship shall be closed for public worship. Further, religious congregations/

gatherings are strictly prohibited. Any person/organisation violating the above directions shall be liable to be fined to the tune of Rs. 20,000/- which shall be payable by the Management. All Tourist spots in South Andaman District shall remain closed for Tourism activities with immediate effect. The

medicine, Home Quarantine and Field Surveillance. It is also carrying out follow up on COVID-19 patients and ILI/SARI patients on daily basis and around 31,872 households covering a population of 1,15,163

have been surveyed and around 7,407 co-morbid persons being monitored. Around 817 medicine kits and 271 oximeters have been issued to eligible cases for better tracking of health parameters of the

## Inoculation of COVID- precaution vaccine doses for HCWs, FLWs & people above 60 with co-morbidities begin in Isles

374 beneficiaries vaccinated on the first day

Together with the rest of the country, the administration of COVID precaution vaccine dose for Healthcare and Frontline Workers and those over 60 years of age with co-morbidities got underway today in A&N Islands. Good number of Healthcare and Frontline Workers and those above 60 years of age with co-morbidities were seen taking the vaccine jab

at their respective/ closest Vaccination Centres. As per the data received from the Health Department, 374 beneficiaries were inoculated with COVID precaution vaccine doses in different parts of the Islands today. Accordingly, 293 beneficiaries were inoculated in South Andaman District, 45 were inoculated in North & Middle Andaman District while 36 were

inoculated in Nicobar District. The A&N Administration is making sure that inoculation of Healthcare, Frontline Workers & people above 60 with co-morbidities continues without any hiccups for the safety of the eligible beneficiaries. ## Zero Tolerance towards 'Encroachment on Govt. Land by Govt. Servants'

Such illegal practice to be viewed seriously and action under CCS (Conduct)/CCS (CCA) Rules will be taken

Port Blair, Jan. 10

It has come to the notice of the Chief Secretary, A&N Administration that a large number of Govt. Servants who have been allotted Govt. accommodations have made encroachments on the Govt. land either adjacent to the allotted quarters or other places illegally

and constructed permanent/temporary structures thereon, which is violation of laid down Rules. Such encroachments on Govt. land by Govt. servants, and indulgence in such illegal practice by Govt. servants will be viewed seriously and action under CCS (Conduct)/ CCS (CCA) Rules will be taken, which may even lead to dismissal from Govt. service. It has also come to the notice that a large number of transferred/ retired Govt. Servants are residing in the Govt. quarter after the permissible period of retention and overstayed unauthorisedly, which causes the delay in

providing Govt. accommodation to eligible/ needy applicants. Such unauthorized occupants have been requested to vacate the quarter without any further delay. Any lapse on the part of transferred/ retired Govt. servant will be viewed seriously.

(VoC), 'Omicron', in different pans of this UT as per the advisory issued by the Ministry of Health and Family Welfare (MoHFW) dated 21<sup>st</sup> December, 2021 for ensuring strict compliance prescribing a normative framework for taking evidence based containment measures at district/ local level for the whole of Andaman and Nicobar Islands and which shall remain in force up to 31<sup>st</sup> January, 2022.

## Vaccination drive in A&N Islands 15,362 beneficiaries in the age group 15-18 administered first dose of Covaxin so far

The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 5,98,587 beneficiaries in the age group of 18 and above have been vaccinated so far in A&N Islands. Similarly, 15,362 beneficiaries have been vaccinated in the age group of 15 to 18 years against the target beneficiaries of 23,000. A total of 2639 people were vaccinated today. 1540 beneficiaries were vaccinated in South Andaman District, out of which, 845 beneficiaries were in the age group of 15-18 years while 293 beneficiaries were in the age group of 18-44 years. Similarly, 574 beneficiaries were vaccinated in North &

order further states that all Parks/Play grounds/Stadiums/Gyms and yoga institutes shall remain closed with immediate effect.

In view of the emergent circumstances, this order is being issued ex-parte and is addressed to the public in general. This order shall be promulgated in the South Andaman District. Further, the Superintendent of Police / Sub-Divisional Magistrate/Executive Magistrates and all authorities concerned shall ensure strict compliance of this order and shall adequately inform and sensitize the field functionaries to note that these restrictions fundamentally relate to movement of people, but not to that of essential services.

Any disobedience of the above orders shall invite penal action u/s 188 of Indian Penal Code, 1860 and the relevant provisions of the Disaster Management Act, 2005 against the violator(s) and fine shall also be imposed as per Order issued by this office from time to time.

This order shall come into effect from tomorrow (Jan. 11) and shall remain in force till further orders.

Now therefore, in pursuance of powers vested u/s 51(b) of the Disaster Management Act, 2005 and in order to enforce strict compliance of the National Directives on COVID-19 in South Andaman and North and Middle Andaman Districts, the following fines have been prescribed for the violation of the National Directives on COVID-19 Management issued by the Ministry of Home Affairs.

1.	Non-wearing of face cover in public places, work places and in public transport	Rs.1000/-
2.	Spitting in public & work places	Rs.600/-
3.	Violation of social distancing norms by individual (s) in public places and work places.	Rs.400/-

5.	Violation of National Directives with respect to Marriage (gathering of more than 50 persons).	Rs.20,000/-
6.	Violation of National Directives with respect to Funeral/Last rites (gathering of more than 20 persons).	Rs.5000/-
7.	Consumption of liquor in public places	Rs. 10,000/-
8.	Consumption of paan, gutka, tobacco etc. in public places	Rs.600/-

required to get a COVID precaution vaccine dose. The Centre has informed that the precautionary vaccine dose will be the same vaccine as administered previously in the first two doses.

Those completed 270 days after second dose are eligible to receive COVID precautionary vaccine dose. The beneficiaries have to bring Aadhaar card and second dose certificate copy. The eligible population who have taken two doses of Corona vaccine can directly walk-in to any COVID vaccination centre all over the Islands.

# Containment measures for COVID-19 in North & Middle Andaman District

Mayabunder, Jan.10

In exercise of the powers conferred under section 24 (I) of the Disaster Management Act 2005, the Chairperson, Union Territory Disaster Management Executive Committee, for the Union Territory of A&N Islands has directed vide Order No.91 dt. 31st December, 2021 to ensure compliance of Containment Measures for COVID-19 as well as increased detection of the Variant of Concern (VoC), 'Omicron', in different parts of this UT as per the advisory issued by the Ministry of Health and Family Welfare (MoHFW) dated 21st December, 2021 for ensuring strict compliance prescribing a normative framework for taking evidence based containment measures at district/local level for the whole of Andaman and Nicobar Islands and shall remain in force up to 31st January, 2022.

In exercise of the powers conferred under section 144 Cr.P.C, 1973, the District Magistrate, North and Middle Andaman, Smti Anjali Sehrawat has directed the following for the compliance of the normative framework for taking evidence based containment measures for COVID-19, in accordance with the advisory issued by MoHFW dated 21st December 2021, which shall continue to be strictly followed and shall remain in force w.e.f. 11th January, 2022 for the whole of North and Middle Andaman till further orders.

As per the order, night curfew shall be enforced in the entire district of North and Middle Andaman from immediate effect with no movement of men and materials between 9 pm and 5 am until and unless permitted by the District Magistrate on case-to-case basis. All shops and establishments are permitted to open between 5 am and 9 pm. They shall strictly follow norms of social distancing by maintaining a distance of at least 1 meter from a person and not allowing more than 03 persons at a time inside the premises. Any overcrowding on violation of social distancing will be responsibility of the shopkeepers and will invite fine of Rs.4000/- for violation of social distancing norms and Rs10,000/- for overcrowding in shops/ establishments, along with sealing of shop for 14 days. No movement of public beyond these

timings will be allowed except for Hospitals, medical labs, medicines and medical equipment, ambulance and hearse vehicle services, medical and its allied activities, all medical emergency cases shall be permitted. Persons engaged for essential activities for movement of goods on Andaman Trunk Road, loading and unloading of essential cargo shall be allowed on production of valid movement passes issued by the Office of District Magistrate, Movement of officers/ officials involved in providing essential services such as District Administration, Police, CISF, Health Services, Home Guards, Electricity, Fire and emergency services, Defence personnel on duty shall be permitted on production of valid Identity Cards issued by their concerned Departments. Movement of bare minimum personnel involved in providing Broadcasting and Cable services, Internet service providers, all print and electronic media persons, private security services, POL Outlets, LPG Stores/ Godowns, ATMs, Cold Storages and warehouses shall be allowed for which valid passes shall be issued by the Office of District Magistrate based on the certification from the concerned organisation. Movement of Officers/Officials, involved in providing services such as Forest, Water Supply & Sanitation in Rural Areas, Disaster Management, Port and related services. Telecommunication shall be allowed after 09:00 PM on production of movement passes to be issued by the Office of District Magistrate.

Movement of personnel involved in providing essential/ emergency services shall be allowed after 9 pm on production of e-passes to be issued by the Office of District Magistrate. It shall be the sole responsibility of the owner/In-Charge of the shop/ business establishment to ensure its compliance and also if any person attached with such organisation is found misusing the e-passes or using the same for purposes other than it is meant for, the owner/in-charge shall be held responsible and he/she shall be liable to be fined to the tune of Rs. 10,000/- and shall also be liable for action under DM Act. Movement of persons from containment /ones shall be strictly restricted and

shall only be permitted on case-to-case basis upon approval from the Office of District Magistrate.

Port services will continue to operate as usual and both essential and non-essential cargo can be moved in and out of port, as per requirement for loading/unloading/ clearing of cargo and the same shall be permitted till 9 pm only. Movement passes for operation of cargo movement after 9 pm needs to be obtained, which shall be strictly permitted on case to case basis by the Office of the District Magistrate. Construction activities shall be permitted till 9 pm. Construction activities of national importance and strategic projects beyond 9 pm shall be permitted with prior permission of District Magistrate and movement passes needs to be obtained, which shall be strictly permitted on case to case basis by the Office of the District Magistrate.

Movement of persons involved with Hotels/ Restaurants and Mess to be certified by the firm/ organisation for home delivery of food shall be allowed till 9 pm on production of movement pass already issued by the District Magistrate. Dine-in shall be permitted between 5 am and 9 pm subject to 50% of the seating capacity and strict adherence of COVID appropriate behaviours. However, take away/ parcel service and home delivery should be encouraged. It shall be the sole responsibility of the Owner/Incharge of the shop/ business establishment to ensure its compliance and also if any person attached with such organisation is found misusing the movement pass or using the same for the purposes other than it is meant for, the Owner/ Incharge will be liable to be fined to the tune of Rs.10,000/-, along with sealing of shop/ establishment for 14 days and shall also be liable for action under DM Act.

Public transport/ buses shall be allowed to ply with 50% of the capacity following COVID protocols. Sale and service of liquor at licensed premises shall be permitted till 9 pm with 50% seating capacity and with strict adherence of COVID appropriate behaviours like wearing of mask, social distancing, cough etiquettes etc. Provision of thermal scanning and use of hand wash and sanitizers will be mandatory. SOPs and

orders regarding the timings for sale and service of liquor at all licensed establishments (C B1, B2 and B3 category) issued by the Deputy Commissioner North and Middle Andaman should be strictly adhered to.

All Parks/ Playgrounds/Stadiums/ Gyms and yoga institutes shall remain closed with immediate effect. All Religious places/ places of worship shall be closed for public with immediate effect till further orders. Fine to the tune of Rs. 20,000/- shall be payable for any violation. Social/ Political/ Sports/ Entertainment/ Academic/Cultural/ Religious/ Festival related gathering and congregation shall be prohibited till further orders, except marriage and funerals which shall be permitted with prior permission of Assistant Commissioners concerned subject to suitable terms and conditions for compliance of COVID Appropriate Behaviour (CAB).

All tourist spots in North and Middle Andaman district shall remain closed with immediate effect. The movement passes issued by the District Administration from 22nd May, 2021 onwards shall remain valid.

In view of the emergent circumstances, this order is being issued ex-parte and is addressed to the public in general. This order shall be promulgated in the North & Middle Andaman District Further, the Superintendent of Police/Sub-Divisional Magistrate/ Executive Magistrates and all authorities concerned shall ensure strict compliance of this order and shall adequately inform and sensitize the field functionaries to note that these restrictions fundamentally relate to movement of people, but not to that of essential services.

Any disobedience of the above orders shall invite penal action u/s 188 of Indian Penal Code, 1860 and the relevant provisions of the Disaster Management Act, 2005 against the violator(s) and fine shall also be imposed as per order issued by this from time to time.

This order shall come into force with effect from 11th January, 2022 and shall remain in force till further orders.

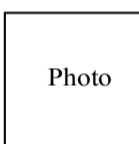
