## PM lays foundation stone of New Parliament Building

### New Parliament will witness the making of AatmaNirbhar Bharat : PM

#### Urges to take pledge to keep the country's interest paramount

New Delhi, Dec. 10 (PIB) Prime Minister, Shri Narendra Modi laid the foundation stone of the New Parliament Building today. The new building is an intrinsic part of the vision of 'AatmaNirbhar Bharat' and will be a landmark opportunity to build a peoples' Parliament for the first time after independence, one which will match the needs and aspirations of 'New India' in the 75th anniversary of independence in 2022. Speaking on the occasion, the Prime



Minister said today is a milestone in India's democratic history, filled with the idea of Indianness. He added that the start of the construction of Parliament House of India is one of the most important



stages of our democratic traditions. He gave a call to the people of India, to build this new building of the Parliament together. He said it can't be more beautiful or more pure than the new building of our

Parliament witnessing when India celebrates 75 years of its independence.

The Prime Minister recalled the moment when he entered the Parliament House for the first time in 2014 as an

MP. He said that when he entered the Parliament House for the first time, he bowed his head and saluted this temple of democracy, before stepping into it. He remarked that many new things are being done in the new Parliament House that will increase the efficiency of the MPs and modernize their work culture. He said if the old Parliament House gave direction to post-independence India, the new building would become a witness to the making of a

The Minister was briefed about the measures taken by A&N Administration in containing the spread of COVID -19 in Isles. The Minister interacted with the frontline workers, Doctors who are monitoring the health status of the patients at this COVID Care Centre. The Commissioner-cum-Secretary (Health), Dr. V Candavelou, the Deputy Commissioner, South Andaman, Shri Suneel Anchipaka were also present during the visit.

The Minister was informed about the status of COVID-19 in the Islands and the stringent measures taken by the Administration in restricting its spread through a Power Point Presentation by the Secretary (Health), Ms. Kriti Garg. 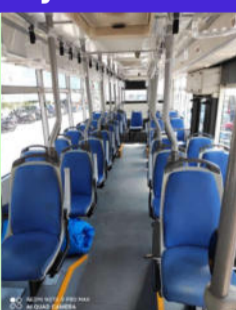
