The Government of India has decided to commemorate the 75th Anniversary of India's Independence in a befitting manner at National and International level. The programmes for celebration shall begin 75 weeks prior to 15th August, 2022. The celebrations will be launched by the Prime Minister on 12th March, 2021 that marks the anniversary of the Dandi March. On this day, events related to 'Azadi Ka Amrut Mahotsav' will unfold in the country and the celebration will also be simultaneously launched in A&N Islands. To celebrate the events in A&N Islands, a UT level Apex Committee has been constituted under the chairmanship of the Chief Secretary, A&N Administration.

The A&N Islands history is entwined with the historic Cellular

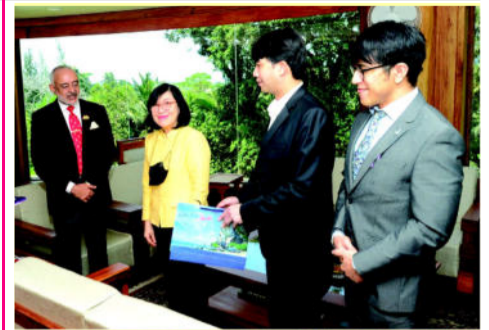


India's prized possession 'National Memorial Cellular Jail': Many visitors enchanted by the historical significance termed it as a 'Place of Pilgrimage'.

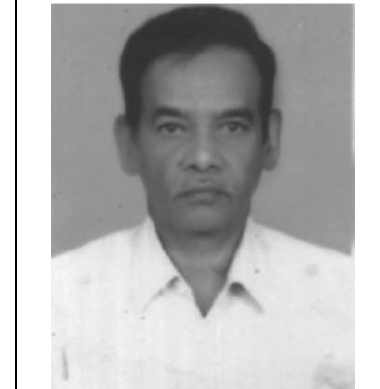

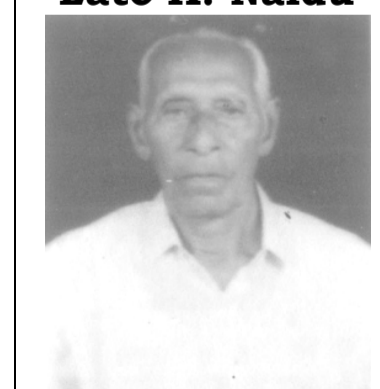
