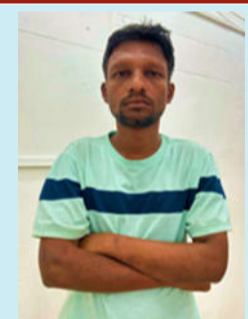
UIDAI urges residents to get benefit of free document update facility on myAadhaar Portal Service available till June 14

As part of Digital India Initiative, the UIDAI took this decision and urging residents to get benefit of free document update facility on myAadhaar Portal. The free service is available from 15th March, 2023 and will continue upto 14th June, 2023. The UIDAI is also encouraging residents to upload Proof of Identity (PoI) and Proof of Address (PoA) documents to revalidate their demographic details, especially if Aadhaar was issued 10 years back and never got updated. Port Blair, June 10 The Central Crime Station has successfully arrested an individual involved in a fraudulent job offers at VSI Airport, Port Blair, targeting unemployed youth of A&N Islands by impersonating as employee at the VSI Airport. This arrest marks a significant milestone in the ongoing efforts to combat job fraud and protect vulnerable individuals seeking legitimate employment opportunities. The suspect, identified as R. Sekar, S/o Late Ramnathan, 35 yrs, R/o Old Bimblitan mobile No. 7695027352, cunningly exploited the hopes and aspirations of job seekers. He presented himself as representative with influence over job placements within VSI Airport in exchange for substantial fees and personal information.



Later, upon receiving money and personal documents, he avoids taking call from the victims. A&N Police

strongly encourages anyone who may have fallen victim to this job scam or possesses information related to the case to come forward and report it immediately at PS Central Crime Station or contact 100, 03192-232586, 9476084840, 9474290250. Their cooperation will greatly aid the ongoing investigations and help prevent further incidents of job fraud in these Islands. 'Niramaya' scheme is to provide affordable Health Insurance to persons with Autism, Cerebral Palsy, Mental Retardation (ID) & Multiple Disabilities. The scheme is being run by the National Trust, Ministry of Social Justice & Empowerment, New Delhi. The Niramaya Health Insurance Scheme has a single premium across age band and insurance cover up to Rs.1.0 lakh (per year) on reimbursement basis only. The services covered under the insurance scheme ranges from Medical Check up to Hospitalization, Therapy to Corrective Surgeries, Transportation as per the benefit chart issued by the National Trust which may be revised from time to time. This scheme demands no pre-insurance medical tests and treatment can be taken from any hospital. A report of the World Health Organisation (WHO) has highlighted significant impacts of 'Har Ghar Jal' Programme on public health and economic savings. The report on 'Har Ghar Jal' estimates that ensuring safely managed drinking water for all households in the country could avert nearly four lakh deaths caused by diarrheal diseases and prevent approximately 14 million Disability Adjusted Life Years

giving them two years more to meet the priority sector lending targets and designating a Nodal Officer in RBI.

The Ministry of Cooperation in a statement said that UCBs can now open new branches up to 10 per cent of the number of branches in the previous financial year without prior approval of RBI in their approved area of operation. To avail this facility, UCBs have to get the policy approved by their board and comply with the Financially Sound and Well Managed Norms. The Ministry added that now Co-operative Banks through board-approved policies can provide process for technical write-off as well as settlement with borrowers. This has brought Cooperative Banks at par with other commercial banks now. It added that RBI has also decided to extend the timeline for Urban Co-operative Banks to achieve Priority Sector Lending targets by two years up to the 31st of March, 2026. (Source: india.gov.in)

Damini Lightning Apps has also been developed by IITM-Pune and ESSO where monitoring of all lightning activity happening specifically in India and alert is generated, if lightning happens nearby through GPS notification under 20KM and 40KM.

All residents of A&N Islands have been requested to download the MAUSAM App and Damini Lightning App from the Google Play Store or IOS and install the same in mobiles to get timely information, a press release from Directorate of Disaster Management said.

of the game. The victory means that the Indian team will compete in the prestigious tournament's Final for the second time, having previously reached the summit clash in 2012.

Where the Lieutenant Governor, Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, he may by order and for reason to be recorded in writing, relax any of the provisions of these Rules with respect to any class or category of persons.

6. Saving:-

Nothing in these Rules shall effect the reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to Scheduled Castes, Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.



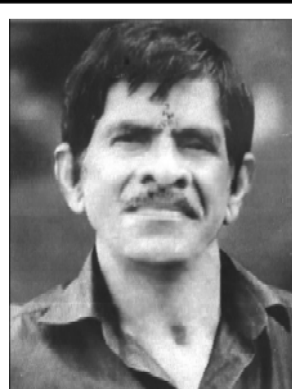

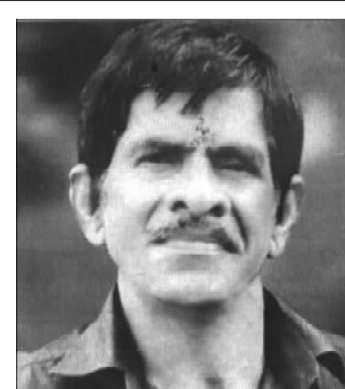
