by introducing the Maternity Benefit (Amendment) Bill 2016. The Bill is listed in the Rajya Sabha for consideration and passing. The Maternity Benefit Act, 1961, protects the employment of women during the time of maternity and entitles them of a full paid absence from work to take care for the child. The amendment bill seeks to

increase maternity leave to 26 weeks in all establishments, including private sector. The act is applicable to all establishments employing 10 or more persons. The bill also provides 12 weeks leave for commissioning and adopting mothers and makes it mandatory to provide crèche facility for establishment where the

number of workers is 50 and above. At present, the Maternity Benefit Act does not provide any maternity leave for commissioning or adopting mothers. Maternal care to the Child during early childhood is crucial for growth and development of the child. The amendments will help 18 lakh women workforce in organized sector.

Indian boxers get new kits, no threat of disqualification

Rio De Janeiro, Aug 11 Threatened with disqualification for not wearing vests bearing their country's name, Indian boxers at the ongoing Olympics have got their kits replaced as required by the International Boxing Association (AIBA) and will now compete without any hindrance. The AIBA officials had pointed out the "technical flaw" after Manoj Kumar's victory in his light welterweight (64kg)

opening contest against Lithuania's Evaldas Petrauskas on Wednesday night. "It was pointed out to us and it has been sorted. It is a very normal issue, lot of countries face this problem of their kits not being up to it. In such instances, the organisers themselves provide the replacements," national coach Gurbax Singh Sandhu said. "Our case has also been sorted and there is no risk of

disqualification. Our boys will compete as scheduled and there is no need to worry," he added. Indian boxers have been allowed to compete under the tri-colour at the Games despite the suspension imposed on the country's national federation. So far, Vikas Krishan (75kg) and Manoj (64kg) have won their opening bouts to enter the pre-quarters of their respective categories.

Brazil advance; Argentina, Mexico out

Rio De Janeiro, Aug 11 Hosts Brazil finally found their form to progress to the quarter-finals of the Olympic soccer tournament with a comprehensive 4-0 win over Denmark on Wednesday, after holders Mexico and twice winners Argentina were sent packing. After drab goalless draws in their first two matches, Brazil needed a win to calm the nerves of a soccer-mad nation and guarantee a place in the last eight, and first-half goals by Gabriel Barbosa and Gabriel Jesus provided a perfect platform. Luan and Barbosa added two

more goals in the second period to carry Brazil to the top of Group A and a Saturday showdown against fellow South Americans Colombia. Despite the heavy defeat, Denmark advanced to face Nigeria after finishing in second place on four points, while Iraq and South Africa drew 1-1 in the other group game to both be eliminated. Argentina, who were Olympic champions in 2004 and 2008, crashed out after they were held to a 1-1 draw by Honduras in Group D action, as Portugal topped the standings on seven points after

a 1-1 draw with Algeria in the other match. Honduras claimed the second qualifying spot by virtue of a superior goal difference over Argentina, who missed a penalty in their match, with both sides finishing on four points. Algeria were last after claiming a solitary point. Germany were the big winners of the day, hammering 10 goals past Fiji, with Nils Petersen scoring five and Maximilian Meyer adding three as the European side ran riot against a team who conceded 23 goals in their first appearance at the Olympics.

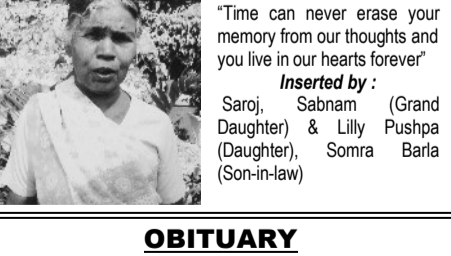

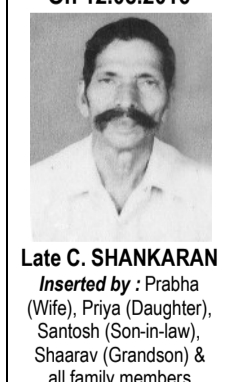
