Strict enforcement drive carried out by District Administration in South Andaman District

A&N Administration effectively implementing 'Unique ID for Persons with Disabilities' Project to empower PwDs

A&N Islands stands 2nd in the Country in implementation of the project under the guidance & direction of Chief Secretary

The Department of Social Welfare, A&N Administration is implementing the Govt. of India scheme of Unique ID for Persons with Disabilities in an effective manner to empower Persons with Disabilities. The Aadhaar-linked card would ensure ease to access various Government schemes & benefits. The Ministry of Social Justice and Empowerment, Govt. of India had launched this project in the year 2016 with a view to create a National

Database for PwDs and to issue a Unique Disability Identity Card to each person with disabilities to avail various benefits of the scheme.

The Ministry has so far generated 4832 e-UDID cards for A&N Islands with a coverage rate of 105.04% benefitting the divyangjan in all the three Districts. At present, A&N Islands stands in 2nd place as per the latest e-UDID card status released by the Ministry of Social Justice & Empowerment.

In order to achieve this target, the Social Welfare

Department in coordination with the Health Department has conducted various Disability-cum-Assessment Camps during the month of December, 2021 and also conducted camp for Hearing Impaired patients on December 21, 22 and 23, 2021 at PHC Rangat, Dr. RP Hospital Mayabunder & CHC Diglipur respectively in collaboration with Directorate of Health Services.

Similar camps were held during the month of December, 2021 at PHC Garacharma, CHC

Bambooflat and GB Pant Hospital wherein Divyangjan were assessed by the specialist doctors and registered for UDID Cards & Disability Certificates.

Divyangjan who have not yet received their e-UDID cards have been requested to kindly register in the UDID portal by visiting their nearest CSCs/ Office of CDPOs and then approach their nearby PHC/CHC for getting their Disability Certificates & UDID cards, a press release from Directorate of Social Welfare said.





COVID-19 surveillance guidelines. Further, District Control Room for COVID-19 has been activated and team of officials have been deployed 24x7 to cater to any emergencies, queries and assistance. The District Control Room no. is 03192-262924/03192-273011.

Teams for surveillance of IL/SARI symptoms have been constituted as per the National Directives for monitoring, follow-up and daily ground reporting to enable the District Administration to keep a close watch on the probable spread of COVID-19 and emerging trend thereafter. The robust reporting mechanism has been put in place to respond effectively and efficiently to the demands of the situation.

lakh along with 90 person days of unskilled labour wage through convergence with Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). Additionally, an incentive of Rs.12,000 for construction of toilets through convergence with 'Swachh Bharat Mission - Gramin' (SBM-G) is also provided to the beneficiaries. Besides that, the beneficiaries are also provided with safe drinking water through National Rural Drinking Water Programme (NRDWP); electricity connection under Deen Dayal Upadhyay Gram Jyoti Yojana (DDU-GJY) and LPG connection under Pradhan Mantri Ujjwala Yojana (PMUY). The beneficiaries have been identified by the Gram Sabha from among those who fulfil the deprivation parameters in the Socio-Economic Caste Census 2011 through a consultative process.

In the UT of Andaman & Nicobar Islands, the Department of Rural Development & Panchayati Raj aims at providing a pucca house to 1337 eligible beneficiaries under the scheme that can withstand adverse weather conditions and ensure quality of life. To ensure housing facility to the poor and landless beneficiaries of PMAY-G, the Hon'ble Lt Governor, A&N Islands has allotted land to the tune of 50 sqm to each of the landless beneficiary and more than 700 landless beneficiaries have availed its benefits so far. This was preceded by timely identification, demarcation and plotting in all the 9 blocks that was actively undertaken by the Administration. The scheme is being implemented to promote a synergetic partnership between the people and the Government. Further, the construction activity under the scheme has had a huge impact on the other sectors of the economy with a multiplier effect in employment generation.



Overcoming various challenges in the way of construction of PMAY-G houses, let it be outbreak of COVID-19, bad weather conditions, lack of construction materials, etc, with the dedicated efforts of the Block staff, the Rural Development Department has managed to complete 1000 houses under the scheme. 100% target has already been achieved in Little Andaman and execution in other blocks is well underway to ensure completion of the targeted houses by March, 2022.

In many places, the beneficiaries are already residing in the houses constructed under this scheme. The beneficiaries describe how they have benefited immensely not just from the monetary support under the scheme but also from the handholding that they received during all stages of construction from the Department. They have expressed their heart-felt gratitude to the Administration for helping them realise their dream of owning a pucca house. The neatly built house arrangement equipped with amenities like water, gas, toilet and electricity supply is an archetype of a new and aspirational Union Territory.

The Secretary (RD), Shri Suneel Anchipaka is of the firm belief that the housing scheme will play a critical role in fostering the health and well-being of people in the rural areas while ensuring safe and secure habitats for women and children. Further, the Department has undertaken a drive to expedite the process of construction of houses in a well-planned manner under his direct supervision. With his sincere efforts and regular monitoring, the target of construction of 1000 houses has been achieved and the construction of remaining houses is in good pace.

Setting off a virtuous cycle of economic activity and hygienic dwelling for the underserved in the rural areas, the PMAY-G certainly is a panacea for a bulk of problems in the rural areas of our Union Territory, a press release from Secretary (RD) said.

Vaccination drive in A&N Islands

16,249 beneficiaries in the age group of 15 to 18 years vaccinated so far

Port Blair, Jan 11

The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 5,99,400 beneficiaries in the age group of 18 and above have been vaccinated so far in A&N Islands. Similarly, 16,249 beneficiaries have been vaccinated in the age group of 15 to 18 years against the target beneficiaries of 23,000. The number of

precautionary dose of vaccine today stood at 885.

A total of 2211 people were vaccinated today. 1059 beneficiaries were vaccinated in South Andaman District, out of which, 490 beneficiaries were in the age group of 15-18 years while 275 beneficiaries were in the age group of 18-44 years. Similarly, 463 beneficiaries were vaccinated in North &

Middle Andaman District, out of which, 275 beneficiaries were in the age group of 15-18 years while 158 beneficiaries were in the age group of 18-44 years. 178 beneficiaries were vaccinated in Nicobar District, out of which, 122 beneficiaries were in the age group of 15-18 years while 44 beneficiaries were in the age group of 18-44 years, a press release from DHS said.

COVID-19 status in A&N Islands

Port Blair, Jan. 11

During the RT-PCR test conducted on 308 passengers who arrived here yesterday, 16 positive cases have been detected. Today, 14 flights with 951 passengers arrived, out of which, 702 passengers were vaccinated with both doses while RT-PCR test was conducted on 246 passengers (includes 10 foreign travellers) and the reports are awaited. During RAT conducted on 51 passengers bound for North & Middle Andaman at Ferrargunj, one positive case has been detected. At Mohanpura Bus Terminus, test was conducted on 58 passengers and all were found negative. At Phoenix Bay Jetty, 37 passengers were tested with RAT and 3 positive cases have been detected. RT-PCR test was conducted on a crew member of MV Chouldari, the report of which is awaited. At Helipad, 13 passengers were tested with RAT and all were found negative, a press release from Directorate of IP&T said.

difficulties in operating the vessel. Further, technical deficiencies were attended by the respective experts and the vessel undertook long sea trial to different ports in Southern Group of Islands. During the voyage, the expert team examined various constraints on the vessel such as Bow Thruster performance, Azimuth Thruster performance, steering at slow speed, visibility from control position in wheel house, steering of vessel in 25 Knots stern wind condition etc. The expert team made certain suggestion on the above constraints to improve the operational efficiencies.

Complying to the suggestion of the experts, the vessel started undertaking voyages with passengers and cargo and the performance of the vessel is now found to be meeting the desired standard. With the continued efforts put by the Directorate of Shipping Services, the vessel MV Sindhu has so far transported 5492 Passengers and around 300 MT plus 62 Cbm of Cargo to different port in Southern Group of Islands. The Officers and Crew on board the vessel are putting their best efforts to maintain the safe operational availability and provide better services to the Islanders which is the prime motto of the Directorate of Shipping Services. South Africa vs India, 3rd Test: SA 17/1 at stumps, trail India by 206 runs

Cape Town, Jan. 11

South Africa lost their first wicket early as Jaspirt Bumrah removed their skipper Dean Elgar minutes before stumps on Day 1 of the third Test at the Newlands Stadium in Cape Town. At Stumps on the first day of the final Test, South Africa were at 17/1, trailing India by 206 runs. Earlier, Indian captain, Virat Kohli was dismissed on 79 as the visitors suffered yet another batting collapse in the ongoing Test series against South Africa. Kohli was the lone fighter for India as the touring side was bowled out for 223 runs in the first innings. Cheteshwar



Pujara and Rishabh Pant got good starts but they failed to convert them into big scores. Pujara scored 43 and stitched a 59-run third-wicket stand with Kohli while Pant added 51 runs with the captain for the fifth wicket. However, it was a poor show from Ajinkya

Rahane yet again as the middle-order batter added only 9 runs to the Indian total. For South Africa, Kagiso Rabada picked four wickets, Marco Jansen dismissed three Indian batters while Duanne Olivier, Keshav Maharaj and Lungi picked one each.
