Misuse of social media platforms

Strict action will be taken against social media platforms, if they violate laws of land: IT Minister

New Delhi, Feb. 11

Union Minister for Electronics and Information Technology, Shri Ravi Shankar Prasad today said, strict action will be taken against Social Media platforms, if they are found to be violating the law of the land, spreading fake news and fueling violence in the country. Specifically naming Twitter, Facebook, WhatsApp and LinkedIn in the Rajya Sabha, Shri Prasad said, they have millions of followers in the country and are free to do business and make money. Shri Prasad, however, said that these platforms cannot be allowed to

circumvent the provisions of the Indian Constitution.

Replying to a question on the misuse of social

media platforms, Shri Prasad said, social media have empowered the common people. He said, they have a big role in Digital India programme. The Minister said, freedom is important, but showing revenge and obscene materials is not acceptable.

Specifically calling out the different standards of a major social media platform, Shri Prasad said, it allowed circulation of hate messages following the Red Fort violence on 26th of last month. He said, the same platform had displayed restrictive policy following the violent incident at Capitol Hill in the USA. (Source: india.gov.in)

One-stop point for scientific management & disposal of solid waste

RD Deptt. aims to make villages in Isles ODF Plus; sets up 17 Solid Waste Management Clusters

Conducts inspection at Wandoor market area

Port Blair, Feb. 11

With the aim to make the villages in the Islands ODF Plus, the Directorate of RD, PRIs and ULBs, A&N Administration is setting up 26 Solid Waste Management (SWM) Clusters across the Islands covering all the 70 Gram Panchayats. It is to mention that 17 out of the 26 SWM Clusters have been completed in full shape and made functional. The Solid Waste Management Centre set up under the Swachh Bharat Mission (Grameen) is a one-stop point for scientific management and disposal of organic and in-organic solid waste. The organic waste such as kitchen waste, garden waste etc. collected from rural

households and commercial establishments shall be converted to organic manure by composting. The in-organic waste such as plastic, metal, glass etc. shall be segregated in the SWM Centre. The non-recyclable waste shall be shredded into granules using Shredding Machine which shall be used for

road construction. Provision has also been made to dispose-off hazardous waste such as sanitary napkins etc. by using incinerators.

Meanwhile, a team of officials from the Directorate of RD, PRIs and ULBs, A&N Administration along with the Gram Panchayat Officials conducted inspection drive in all market places and commercial establishments in Wandoor Gram Panchayat area to implement Rural Areas Solid Waste Management and Handling Bye Laws, 2019. During the drive, the shopkeepers were sensitized on the initiatives being taken up by the Department for effective management of solid waste in these Islands. Fines

Food Safety Deptt. conducts surprise inspection at food business premises

Seizes huge quantities of banned half litre & one litre packaged drinking water in plastic bottles

Port Blair, Feb. 11

The officials of the Food Safety Department conducted surprise inspection of food business premises located at Bambooflat, Wimberlygunj, Garacharma, Prem Nagar and Aberdeen Bazaar and seized huge quantities of banned half litre and one litre packaged drinking water in plastic bottles. Date of packing/best before, batch no., etc. were not mentioned in the bottles for the



information of customers which is clear violation of Food Safety and Standards (Packaging and Labeling) Regulations, 2011.

Cases have been registered against the offenders under relevant sections of law and the license of the packaged drinking water manufacturing unit has been suspended with immediate effect.

Further, through the Mobile Food Testing Laboratory, a training programme was organized at Dollygunj Industrial Estate for the manufacturers/food processors, wherein the Food Business Operators (FBO) were sensitized about good manufacturing practices, good hygienic practices and guidelines on packaging and labeling of food packets. India becomes fastest country in world to achieve over 70 lakh COVID-19 vaccinations

New Delhi, Feb. 11
India has become the fastest country in the world to achieve over 70 lakh vaccinations against COVID-19 in only 26 days. It took 27 days for the US and 48 days for the UK. Union Health Ministry said, a total of over 70 lakh 17 thousand people have been administered COVID-19 vaccines in the country so far. More than four lakh five thousand people were inoculated with COVID vaccine doses in the last 24 hours. The number of beneficiaries being vaccinated every day has shown a progressive



increase. The Ministry said, 13 States and Union Territories have vaccinated over 65 per cent of the registered health care workers. Bihar leads with over 79 per cent of the registered health care workers vaccinated. Seven States and UTs have reported less than 40 per cent vaccinations of the registered health care workers. Puducherry has recorded the lowest vaccination performance of 17.5 per cent. (Source: india.gov.in)

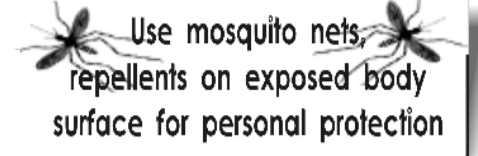


