## PM Modi, BJP MPs observe day-long fast over washout of Budget session

New Delhi, April 12 Prime Minister Shri Narendra Modi today observed day-long fast against the Parliament logjam during the Budget session.

Shri Modi, however, did not let the fast get in the way of his daily official routine and inaugurated the defence expo in Kanchipuram near Chennai. All BJP MPs, including Union Ministers, observed the fast. Around 2,000 BJP lawmakers including MPs, MLAs and MLCs took part in the day-long fast at 600 district headquarters across the country. While BJP Chief Shri Amit Shah joined the protest in Karnataka, Health Minister Shri J P



Nadda was at Prime Minister's constituency Varanasi. Law Minister Shri Ravi Shankar Prasad observed the fast in Patna in Bihar, While Union Ministers Shri Suresh Prabh, Ms. Uma Bharati,

Shri Vijay Goel and Dr Harsh Vardhan in New Delhi. Earlier, BJP MPs and NDA allies had resolved to not take salary and allowances for 23 days of the second part of the Budget Session of the Parliament. No

substantial business could be transacted during the session due to opposition's uproar on various issues including the setting up of Cauvery Management Board and special status to Andhra Pradesh.

Port Blair, April 12

The month long Measles & Rubella (MR) Vaccination campaign in Andaman & Nicobar Islands got underway with a launching ceremony held in the auditorium of G B Pant Hospital here today. The Lt. Governor, A & N Islands, Admiral D K Joshi, PVSM, AVSM, YSM, NM, VSM (Retd) launched the campaign as the chief guest. The programme, an initiative of the World Health Organization (WHO), is being organized by the State Immunization Unit of the Directorate of Health Services, Port Blair.

Addressing the gathering on the occasion, the Lt. Governor said that Measles & Rubella Vaccination campaign is a laudable initiative of WHO, which has launched the programme in Asia, covering 10 countries including India. The objective of WHO is to address the problems caused by measles disease and control the morbidity prevalent by administering Measles and Rubella Vaccination, he said. The Lt. Governor said that the remoteness of these Islands, and the scattering of the population make it difficult to reach out to the people; and delivering any



service to them within a timeframe is a massive challenge. "But we must take up the challenge and make all efforts in achieving 100% measles vaccination coverage of children", he said, advising all Departments involved in the process to extend full cooperation in the endeavour. He also urged the Islanders to render full support in the programme so that the target can be achieved

within the timeframe. The Chief Secretary, A&N Administration, Shri Anindo Majumdar, while speaking on the occasion, underlined the need for working together to accomplish the task of vaccinating children in the targeted age group and make the campaign a grand success. The Islands have achieved 87% immunization, which needs to be made 100%, he said, urging all involved to

bring to light any difficulties during the campaign, so that necessary steps can be initiated for smooth conduct of the vaccination campaign and the mission be achieved within stipulated time. # Indian wrestlers bag 2 Gold, 1 Silver & 1 Bronze medals on opening day of their competitions

Gold Coast, April 12

On the first day of wrestling competition at the 2018 Commonwealth Games, India's Sushil Kumar, Rahul Aware have won gold in the men's freestyle 74kg and 57kg respectively, while Babita Kumari claimed silver in the women's 53kg freestyle final. Earlier, wrestler Kiran had outplayed Katouskia Pariadhaven of Mauritius 10-0 to win bronze in the women's 76kg freestyle as well, at Gold Coast in Australia on Thursday.

Sushil did it in style as he won with a 10-0 scoreline, by technical superiority against Johannes Botha of South Africa in just 80 seconds. This is Sushil's third CWG gold following gold medals in the 66kg event in 2010 and 74kg event in 2014. Sushil's golden effort has taken India's overall tally at the Gold Coast Games to 29.

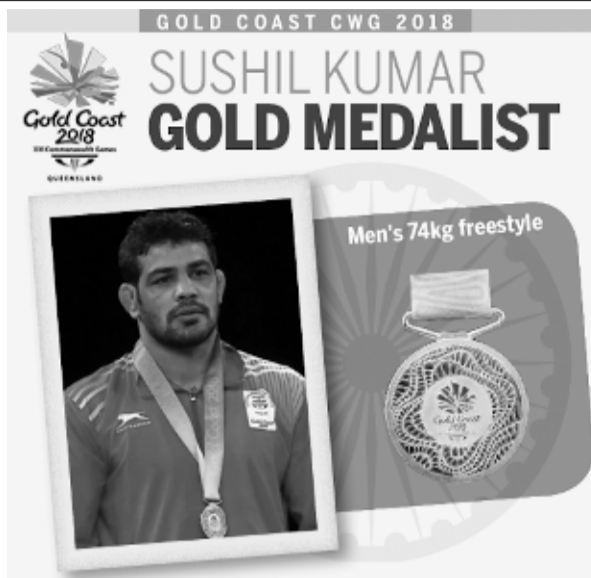
Two-time Olympic medalist Sushil advanced to the gold medal match after winning three one-sided bouts at the Carrara Sports Arena. The celebrated Indian wrestler, who won the Commonwealth Championships last December, looked in menacing form as he took down his opponents with ease. It was Connor Evans of Australia who came out charging at the start but Sushil soon got the measure of his opponent and pinned him down. He won two technical points in the first 50 seconds before finishing the match pinning Evans to the mat. The thrashing of the Aussie left the host fans stunned and for the jubilant Indian fans it was all over too fast.

The Indian showed no mercy to his quarterfinal opponent too as he beat Pakistan's Muhammed Asad Butt by technical superiority. Sushil scored six points in the first period and four more a minute into the second session to book his place in the final. Earlier, in the first round, Sushil beat Jevon Balfour of Canada.

This is the first CWG medal for Aware, 26, who in 2011 won gold at the Commonwealth Championships and an Asian Championships bronze, and Babita's third consecutive medal at the CWG.

In a gripping final bout against Canada's Steven Takahashi, Aware won 15-7 despite struggling with injury in the latter half. After showing visible discomfort while on his back, Aware roared back with a very strong second round and defeated Takahashi. One of 45 athletes who are given financial aid under the Indian government's Target Olympic Podium program, the Kolhapur-based wrestler had missed out on a berth for the 2016 Rio Olympics. Today's gold will mean the world to him, given the circumstances that combined to see his Olympic dreams dashed two years ago.

Babita, the gold medalist from 2014 and silver medalist in 2010, beat Nigeria's Samuel Bose, Sri Lanka's Deepika Dilhani and



Australian Carissa Holland to storm into the final, where she was beaten by Canada's Diana Weicker. Having gone to the 2016 Rio Olympics with high hopes, the 28-year-old had been beaten in the first round by Greek wrestler Maria Prevolaraki 5-1. This was her first international match since then, with knee injuries her bids for a comeback. Between the Rio Games and now, Babita's only appearances had come during the Pro Wrestling League where she was beaten in 46 seconds and again ruled out of the season.

## ISRO launches navigation satellite IRNSS-1I

Sriharikota, April 12  
The Indian Space Research Organisation launched the Indian Regional Navigation Satellite System-1I navigation satellite, the eighth such satellite to be a part of a constellation, from Sriharikota in Andhra Pradesh early this morning. IRNSS-II is expected to replace IRNSS-1A, the first of the seven navigation satellites, that was rendered ineffective after its three rubidium atomic clocks failed. The seven satellites are part of the NavIC navigation

satellite constellation. The launch is ISRO's second attempt at sending a replacement satellite. The previous mission of a PSLV carrying IRNSS-1H in August last year failed after the heat shield covering the satellite failed to separate. The IRNSS-1I mission takes place two weeks after the space agency launched GSAT-6A on board GSLV Mk-II. Though the rocket placed GSAT-6A in orbit, the ISRO lost communication with the satellite within two days.

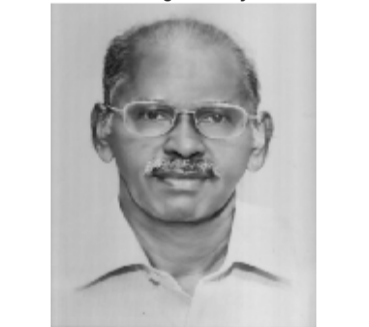
