## Prime Minister to launch platform for 'Transparent Taxation - Honoring the Honest' today

New Delhi, Aug 12 (PIB)

Prime Minister, Shri Narendra Modi will launch the platform for "Transparent Taxation - Honoring the Honest" via video conferencing tomorrow (Aug. 13). The CBDT has carried out several major tax reforms in direct taxes in the recent years. Last year the Corporate Tax rates were reduced from 30 percent to 22 percent and for new manufacturing units the rates were reduced to 15 percent. Dividend distribution Tax was also abolished.



The focus of the tax reforms has been on reduction in tax rates and on simplification of direct tax laws. Several initiatives have been taken by the CBDT for bringing in efficiency and

transparency in the functioning of the IT Department. This includes bringing more transparency in official communication through the newly introduced Document Identification Number (DIN) wherein every communication of the Department would carry a computer generated unique document identification number. Similarly, to increase the ease of compliance for taxpayers, IT Department has moved

## General Elections to Gram Panchayats, Zilla Parishads & Port Blair Municipal Council in A&N Islands postponed

### Conduct of elections in a free, fair & transparent manner in the current environment not feasible: Election Commissioner for UTs

### Election Commission for UTs to review situation to hold elections in consultation with UT Administration at an appropriate time when situation becomes normal

Port Blair, Aug 12

The Election Commission of UTs has reviewed the current unprecedented situation of public health emergency and in its context the feasibility to hold general elections to Gram Panchayats, Zilla Parishads and Port Blair Municipal Council in A&N Islands. The present term of Gram Panchayats, Zilla Parishads and the Port Blair Municipal Council in the Andaman and Nicobar Islands is expiring in September 2020.

After taking all facts and circumstances into account, the Election Commission for UTs is of the considered view that the conduct of general elections to PRIs & Urban Local Body in the Union Territory in a free, fair and transparent manner in the current environment may not be

feasible in view of the restrictions for the maintenance of social distancing, public safety and avoiding health hazard and therefore, the aforesaid general elections cannot be conducted on its schedule time.

In view of this, the Election Commission for UTs in exercise of the powers conferred on it under Article 243K and 243ZA of the Constitution of India, has ordered the postponement of general elections to Gram Panchayats, Zilla Parishads and Port Blair Municipal Council in the Andaman and Nicobar Islands until further orders. The Election Commission for UTs will review the situation at an appropriate time in consultation with the Andaman & Nicobar Administration and when the situation becomes normalized, so as to

facilitate holding of elections the announcement of general election will be made, an order to this effect issued by Shri Narendra Kumar, Election Commissioner for UTs said.

The Order to this effect also stated that the Hon'ble Supreme Court of India in its landmark judgement in Kishan Singh Tomar Vs The Municipal Corporation of the City of Ahmedabad in Appeal (Civil) No. 5756 of 2005 dated 19.10.2006 has inter alia stated that the elections can be postponed for genuine supervening difficulties and exceptional circumstances, such as natural calamities like floods, earthquake or manmade calamities like rioting or break down of law and order till the normalcy is restored.

## Karakoram to Indira Point : BRO is omnipresent Construction of North-South Road work in Great Nicobar Island in progress

### To be open for traffic on completion of major permanent bridge over Galathea river by March, 2023

Port Blair, Aug 12

Border Roads Organization (BRO) is constructing North-South Road works in Great Nicobar Island for infrastructure development on the Southernmost tip of India. The proposed road is significant in terms of socio-economic and strategic development of this remote region. This road from Shastri Nagar (km 36.45) to Indira Point (km 60.385) is being funded by Ministry of Defence. Construction of the 24 Kms road is being undertaken by 46 BR(I)TF under Project Pushpak, in a phased manner viz. Phase-I to Phase-IV. The first two phases of road construction have already been completed including black topping works. The construction of 24.75 mtrs Minor Bridge



over Krishna Nallah at km 38.750 is under progress. Formation cutting of road under Phase-III works has been completed up to Galathea river and the surfacing & permanent work are under progress.

This road construction project in Great Nicobar Island is very challenging in terms of area being more remote, difficulty in ferrying men and material across various rivers and crocodile infestation. Despite these challenges, heavy construction equipment, plant and vehicles required for construction works have been shifted across river Galathea and all other resources like manpower/ FOL etc. are being ferried by boats on daily basis. **Indian-origin senator Kamala Harris named US Vice Presidential candidate for Democratic party**

Washington, Aug 12

In the United States, Democratic Presidential nominee Mr. Joe Biden has named Indian-origin senator Miss Kamala Harris as his Vice-Presidential running mate. Joe Biden made history by selecting the first black woman to compete on a major party's presidential ticket. Miss Kamala Harris is currently the US Senator from California.



Former US President, Mr. Barack Obama has often described her as a trailblazer. If elected, Kamala Harris would be the first ever woman to be the Vice President of the United States and the first ever Indian-American and African Vice President of the country. Daughter of an

Indian mother and a Jamaican father, Harris has known many firsts. She has been a county district attorney; the district attorney for San Francisco - the first woman and first African-American and Indian-origin to be elected to the position.

provided better designs for roads and awareness opportunities for the public. Under Indian Road Safety Assessment Programme 21000 km roads have been assessed and about 3000 km road length is under technological upgradation. He said, better road engineering and increased public awareness has brought about improvement. It is estimated, he added, that these upgradation programmes will bring about 50 per cent reduction in Road accidents. Shri Gadkari informed that our objective is to set out to achieve zero road fatalities by 2030.

Shri Gadkari informed that his Ministry has taken lot of initiatives to reduce road accidents. World Bank and ADB have committed Rs 7000 crore each for this campaign. He said, by social awareness and education, improving emergency services, pressing for medical insurance, providing more hospitals, etc the country is inching closer to achieving its Road safety targets. He referred to the MV Act of 2019, which is a comprehensive legislation on all aspects of Transport sector in India.

The Minister said, the Govt is concentrating on village, agricultural and tribal sectors for providing employment opportunities there. He emphasized that it is the MSME sector which will drive the Indian economy in the coming years. He informed that investment in infra and insurance sectors has been opened up, as there are huge opportunities in insurance, pension and share economies. He said, MSME is also going to capital market soon. Dy Prime Minister of Australia Mr Michael McCormack also spoke on the occasion.

forward with prefilling of income tax returns to make compliance more convenient for individual taxpayers. Compliance norms for startups have also been simplified.

With a view to provide for resolution of pending tax disputes the IT Department also brought out the Direct Tax "Vivad se Vishwas Act, 2020" under which declarations for settling disputes are being filed currently. beyond Galathea is under progress in full swing. At km 46.450 over Galathea river, a major permanent bridge of span 216 mtrs is coming up and BRO is taking all the steps to ensure early completion of the road.

Formation works of Phase-IV (length 11.775 Km) up to Indira Point is planned to be completed by March, 2021. The complete stretch of road from Shastri Nagar to Indira Point will be open for traffic on completion of Major Permanent Bridge over River Galathea which is planned for completion by March, 2023. On establishing road connectivity, Indira Point, the southernmost tip of India will be accessible to all vehicular traffic and BRO will have the sole distinction of having completed roads both at the Northernmost and Southernmost extremities of India, a press release from BRO said.
