Andaman District. The incident occurred on 31st July when the victim entered into water for fishing near a mangrove creek inside the Lohabarrack Crocodile Sanctuary and was attacked and drowned by a crocodile. Under the provisions of Wildlife

(Protection) Act, 1972 the committee under the chairmanship of PCCFCum-Chief Wildlife Warden, after careful consideration of the case, had recommended for payment of Rs. 3 Lakhs as grant as per Gazette Notification No. 52, dated

18th March, 2013. In press releas received here today, the DCF(Wildlife) has appealed to the public to exercise extra caution while entering the mangrove creeks and to avoid venturing into Protected Areas meant for wild animals.

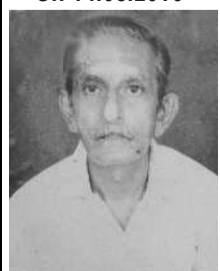

Ethiopia's Ayana shatters world record to win 10000m

Rio De Janeiro, Aug 13  
Ethiopia's Almaz Ayana smashed the world record to win the Olympic 10,000 metres title on Friday, blowing away the competition in one of the greatest ever long-distance races at the Games. In only her second competitive 10,000 metres, Ayana dominated from the start and halfway through the race she surged away from the leading pack, injecting staggering pace to finish in 29 minutes 17.45 seconds. Ethiopian athlete Almaz Ayana smashed the world record on



her way to winning 10,000m gold at the Rio Games. Ayana produced a startling run at the Olympic Stadium to storm home in 29 minutes 17.45 seconds, taking more than 14 seconds off the mark set by China's Wang Junxia in 1993. It was the first time in seven years that a female athlete had run 10,000m in under 30 minutes and the first four all achieved the feat.
