Hon'ble Lt. Governor felicitates divers for scripting Twin Guinness World Records in A&N Islands Record-Setting divers honoured with Certificates and Medallions



Sri Vijaya Puram, Aug. 13
The A&N Administration today organized a Guinness World Record felicitation function at Lok Niwas to celebrate the twin historic Guinness World Record viz. Largest National Flag Underwater & Tallest Human Stack Underwater created in A&N Islands in the month of May, 2026. Admiral DK Joshi, PVSM, AVSM, YSM, NM, VSM (Retd.), Hon'ble Lt. Governor, A&N Islands, and Vice Chairman Islands Development Agency as the chief guest felicitated the participant divers with certificates and medallions.
The function was attended by the First Lady of A&N Islands, Smt. Chitra Joshi, CINCAN, Vice Admiral Vineet

McCarthy, Chief Secretary, A&N Administration, Ms. Chanchal Yadav, DGP, Shri Ravindra Singh Yadav, PCCF, Shri Sanjay Kumar Sinha, Commissioner Cum-Secretary, Dr. Sachin Shinde, other senior officers from Defence & Civil Administration and tourism stakeholders.
The twin Guinness World Records (GWR) are 'Largest National Flag Unfurled Underwater' (60 m x 40 m; 2,400 sq.m.) and 'Tallest Human Stack Underwater' (22.3 metres height). The GWR attempts were planned by the A&N Administration to spotlight the islands' exceptional underwater wealth and to position A&N Islands as a premier international diving destination. The success in

both the event has further reinforced the Islands' reputation as a world-class destination for underwater exploration and diving.
The Chief Secretary, A&N Administration, Ms. Chanchal Yadav, in her address on the occasion highlighted the immense potential of the Andaman and Nicobar Islands in the field of maritime tourism and the strategic importance of the Guinness World Records achieved through diving activities. She said that globally, tourism can broadly be divided into two categories viz. land-based tourism and maritime tourism. Around 50 percent of global tourism is associated with maritime tourism, representing a market

valued at nearly USD 4 trillion. However, India's share in this segment is only about 2.5 percent. She emphasized that maritime tourism therefore presents a significant opportunity for India and, particularly, for the Andaman and Nicobar Islands to establish a strong presence on the global tourism map. She said, the diving-based Guinness World Records achieved by the Islands provide a unique opportunity to showcase the destination globally. "These records are our best bet for advertising the Islands on the global map," she said, adding that the Administration is not merely resting on this achievement but is taking concrete steps to establish the Andaman and Nicobar

Islands as a global diving destination.
She informed that, under the guidance of the Hon'ble Lieutenant Governor, a proposal has been submitted to the Government of India's Destination Development Scheme for developing the Andaman and Nicobar Islands as a global diving destination. She said that the initiative would focus primarily on strengthening safety infrastructure associated with diving activities, along with improving physical infrastructure such as jetties and boat repair facilities. In addition, facilities for specialized training, underwater exploration, shipwreck diving and underwater museums

The Andaman & Nicobar Administration has invited Expressions of Interest (EOIs), on a No-Cost, No-Commitment (NCNC) basis, from reputed hyperscalers, cloud service providers, AI infrastructure companies, data-centre developers and operators, marine-engineering companies, renewable-energy companies, sub-sea connectivity providers and other technically qualified entities, either individually or as part of a consortium, for exploring the feasibility of establishing a Private Sector-led Green AI/Data Centre Vertical in Great

Nicobar or Little Andaman in the Andaman & Nicobar Islands.
The potentially feasible locations are as follows:-
A. Little Andaman: Hutbay Sea Area, Netaji Nagar Sea Area
B. Great Nicobar: Campbell Bay Sea Area, Anderson Bay Sea Area,

The proposed Green AI/Data Centre Vertical may include, inter alia:

- Hyperscale and/or AI-focused data-centre infrastructure;
- GPU and high-performance computing infrastructure;
- Cloud computing and sovereign digital infrastructure;
- Renewable-energy-powered data-centre operations;
- Seawater-based or other innovative cooling systems;
- Freshwater-free cooling solutions;
- Waste-heat recovery and potential utilisation for low-temperature desalination or other productive applications; and
- Submarine and terrestrial digital connectivity

The purpose of the EOI is to enable interested private-sector entities to undertake a preliminary assessment of the technical, economic, environmental, operational and strategic feasibility of such an initiative, including the potential locations in Great Nicobar or Little Andaman, infrastructure requirements, power demand, cooling architecture, digital connectivity, environmental safeguards, regulatory requirements and possible investment models.

The proposed initiative is intended to be private-sector led. The Government / Administration's role, subject to applicable laws, policies, approvals and statutory requirements, would primarily be to facilitate coordination and provide appropriate institutional support in matters relating to land, power, connectivity, statutory clearances, environmental safeguards and other enabling infrastructure, as may be considered feasible.

This EOI is issued purely for the purpose of market sounding, technology assessment, feasibility evaluation and identification of potential private-sector interest. It does not constitute a tender, request for proposal, offer, commitment, assurance or promise of any award, concession, financial support, land allotment or other commercial benefit by the Administration.

Participation in this EOI shall be entirely on a No-Cost, No-Commitment (NCNC) basis. Each participating entity shall bear its own costs and expenses associated with the preparation and submission of its response, preliminary assessments, consultations, site visits, technical studies or any other activities undertaken pursuant to this EOI.

The proposal should reach the Office of the Secretary (IT), Andaman & Nicobar Administration within 45 days from the date of publication of this EOI. The information and proposals received in response to this EOI may be assessed by the A&N Administration for the purpose of understanding the market, assessing technological and commercial viability, identifying suitable development models and determining the desirability of proceeding with further studies or a subsequent procurement, partnership or investment facilitation process.

The A&N Administration reserves the right to seek further information, hold consultations with interested entities, undertake independent assessments, modify the scope of the proposed initiative, or decide not to proceed with the initiative, without assigning any reason and without any liability towards any participating entity, a press release from Secretary (IT), A&N Administration said.

ANC intercepts unauthorised boat, apprehends three poachers

Sri Vijaya Puram, Aug. 13

In a proactive operation to maintain the security of national waters and safeguard coastal integrity, the Andaman & Nicobar Command intercepted and apprehended an unauthorized boat near Diglipur. The operation underscores ANC's continued vigilance and resolve to maintain maritime security and protect the marine ecosystem of the Andaman & Nicobar Islands.

Based on specific and actionable intelligence regarding the presence of an unauthorized boat suspected to be involved in poaching activities, ANC swiftly launched a coordinated operation in the Diglipur area. Army and Naval Components of ANC deployed personnel and assets to conduct a systematic



search of the area, including an aerial search by a Naval helicopter, in close coordination with the Indian Coast Guard and A&N Police. On being sighted, the occupants abandoned the boat and fled into the nearby forest.

The coordinated search operation by the Army and Naval Components of ANC, along with the A&N Police, resulted in the apprehension of three

poachers. The presence of additional poachers in the area is suspected, and joint search operations remain underway to locate and apprehend them.

Diving gear was recovered from the apprehended boat, which is being handed over to the local police as per procedures. The boat and recovered equipment are being processed as part of the ongoing investigation, a press release from PRO, HQ ANC said.

Promoting sustainable, chemical-free and climate-resilient agricultural practices among farmers

Organic Certification Renewal under Paramparagat Krishi Vikas Yojana initiated in Nicobar District

Sri Vijaya Puram, Aug. 13

The Department of Agriculture, Andaman & Nicobar Administration, has initiated the process for renewal of organic certification under the Paramparagat Krishi Vikas Yojana (PKVY) in Car Nicobar and the Nancowrie group of Islands, with the objective of promoting sustainable, chemical-free and climate-resilient agricultural practices among farmers.

The Paramparagat Krishi Vikas Yojana (PKVY) is a Centrally Sponsored Scheme launched by the Government of India during 2015-16 under the National Mission of Sustainable Agriculture (NMSA). The scheme promotes sustainable and eco-friendly models of agricultural production, with emphasis on improving soil fertility, conserving natural resources and producing healthy, chemical-residue-free food through organic

farming practices.

Under PKVY, the Participatory Guarantee System (PGS-India) serves as a key mechanism for quality assurance and organic certification. Farmers are provided the flexibility to adopt suitable forms of organic farming in accordance with PGS-India standards, while the cluster-based approach supports not only farm management and organic input production but also quality assurance, value addition and direct marketing.

A significant milestone was achieved in 2021-22, when 14,491 hectares of the Nicobar group of Islands were declared as a traditional organic area under the Large Area Certification (LAC) component of PKVY with effect from 6th April, 2021. The organic certification subsequently expired, as certification data is required to be updated annually on the PGS portal for renewal and

issuance of the Organic Certificate.

The Department of Agriculture is now taking steps to renew the organic certification in Car Nicobar and the Nancowrie group of Islands. The initiative is expected to further strengthen institutional support to farmers through a cluster-based approach and encourage wider adoption of organic farming practices, while creating opportunities for value addition and improved direct marketing of organic agricultural produce.

The renewed focus on organic certification is aimed at strengthening the traditional organic farming systems of the Nicobar Islands, improving soil health and promoting sustainable agricultural development while preserving the region's indigenous farming practices, a press release from Directorate of Agriculture said.

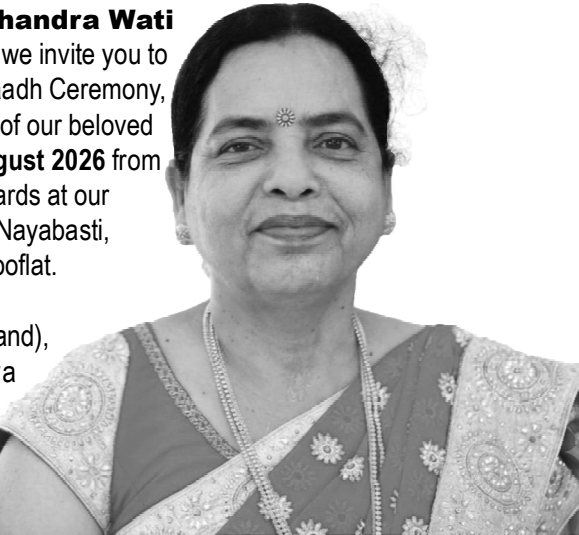
