

## Support to training & employment programme for women aims to provide skill for self employed: Govt

New Delhi, Mar 15  
Minister of Skill Development and Entrepreneurship Shri Rajiv Pratap Rudy has said, under the Support to Training and Employment Programme for women, government aims to provide competencies and skill that enable women to become self employed. Replying to supplementaries in the Lok Sabha, Shri Rudy said under the scheme, over 15,000 women have been provided training.

The Minister said, the flagship programme of Ministry namely 'Pradhan Mantri Kaushal Vikas Yojana' (PMKVY) is for all sections of the society including women. Shri Rudy informed the House that under PMKVY 2015-16, out of 19.8 lakh candidates, about 8.64 lakhs were trained, approximately 44 per cent were women.

### Union Cabinet approves 2% additional DA for Central govt employees

New Delhi, Mar 15

The Union Cabinet has approved 2 per cent additional Dearness Allowance for Central government employees and Dearness relief for pensioners. It will be effective from 1st of January, 2017. The decision was taken at a Cabinet meeting in New Delhi this evening. The decision will benefit about 48.85 lakh Central government employees and 55.51 lakh pensioners.

The work for improvement & widening of road as need for State Highway from the existing width of 3 mtrs to 5.50 mtrs could not been taken up by APWD for want of fund. However, after possible effort of the Member of Parliament, A&N Islands, Shri Bishnu Pada Ray, the

Ministry of R.T.& Highway has sanctioned Rs. 9 crores Central Road Fund for improvement & widening of State Highway from Wright Myo to Shoalbay-15. APWD has invited the tender and rate quoted by M/s CSE Construction (India) for Rs.7.51 crores is found lowest amongst others. The APWD is in the process of awarding work to the lowest bidder. The sanction amount is Rs.9 crores and lowest bid

amount accepted by APWD is Rs. 7.51 crores. Thus saving of Rs. 1.39 crores, due E-Tendering process (a transparent & Corruption free process) introduced by BJP Govt. of 16th Lok Sabha. The Member of Parliament, Shri Bishnu Pada Ray will lay the foundation stone for starting this work at 11 am at Wright Myo on Mar 18, 2017, a communication from the Office of the MP said here.

**Virat Kohli and Co poised for the kill, but visitors can spring a surprise**

Ranchi, Mar 15  
The spotlight is firmly trained on the pitch as an ambitious India brace up for what is expected to be a high-voltage battle of attrition against Australia in the third cricket Test starting here on Thursday (March 16). Since the amicable end to the acrimonious DRS saga, the focus has shifted to the pitch at the Jharkhand State Cricket Association (JSCA), which is organising its first-ever Test match. The four-match Border-Gavaskar Trophy is locked at 1-1 and the game at former India captain Mahendra Singh Dhoni's home town would be crucial to the outcome of the series. The wicket for the first Test was rated poor while the Bengaluru surface, where the second match was played, has been deemed "below average" by match referee Chris Broad. Trailing 0-1 following a shocking 331-run defeat in the opener, India will enter the match with new-found

confidence having scripted a brilliant fightback in Bengaluru. Australian captain Steve Smith had stirred up a controversy in Bengaluru by seeking advice from the dressing room on using the contentious DRS technology for an lbw dismissal at a crucial juncture. Heading into the match, both teams are wary of the pitch. A few days ago, Dhoni, who is currently in Delhi leading Jharkhand in the domestic one-dayers, was seen with the curator during the pitch preparations. On the surface, the 22-yard strip looks tailor-made for spinners, even as the local officials maintain it will last the distance. Head coach Anil Kumble took a long look at the pitch in consultation with East Zone curator Ashish Bhowmick, assessing its firmness. It was watered in the morning and there were a few spells of rain about a week back, explaining its moisture-laden appearance. Having posted 600-plus totals in their

**Shashank Manohar steps down as ICC chairman**

Dubai, Mar 15  
In a surprise development, Shashank Manohar today resigned as ICC chairman after merely eight months in office citing personal reasons. The 59-year-old Manohar mailed his resignation letter to ICC CEO Dave Richardson without clarifying the exact reason for this sudden move to end what was to be a two-year-tenure. However, according to highly-placed sources Manohar has

decided to quit as BCCI seems to have gained enough ground to block the constitutional and financial reforms that were set to be passed by the ICC at its next board meeting. Any reform to be passed needs 2/3rd majority but BCCI, in all likelihood, has managed to get Bangladesh, Sri Lanka and Zimbabwe on its side. It is learnt, expecting a loss of face, Manohar has resigned with immediate effect.

**Production of milk, eggs & meat increased in country: Agriculture Minister**

New Delhi, Mar 15  
The government has said the total production of milk, eggs and meat has increased in the country. Replying to questions in the Lok Sabha recently, Agriculture and Farmers Welfare Minister Shri Radha Mohan Singh said milk production has increased by 4.38 per cent, eggs 6.42 per cent and meat 8.74 per cent during July 2016 to October 2016 as compared to same period during 2015. The Minister informed the House that the Union government supports the states through many schemes to increase the production of milk, eggs

and meat in the country. Shri Singh said, National Programme for Bovine Breeding and Dairy Development programme was launched in 2014 for genetic upgradation of cows and buffaloes with the aim of enhancing their production and productivity including development of dairy infrastructure. He said 'Rashtriya Gokul Mission' scheme has been launched from 2014-15 with the objective of conserving and developing indigenous breeds in a focussed and scientific manner with an outlay of 500 crore rupees. The minister also informed that National

beneficiaries in terms of consumers perspective are well addressed and protected. About the changing trends of online shopping, he said that in traditional way of transaction, the buyer used to select the product before it is purchased, but with the introduction of online shopping, the avenues of unfair trade practice have also increased to a greater extent and thereby the ambit of the consumer law has also extended to that level. Similarly, he stated, that there have been instances of misleading advertisements, which lures the consumers through unrealistic commitments. Often these consumers get into the trap of the misleading advertisements and are exploited or cheated by the unlawful business entities. In these modern days, it becomes our mandate to address this menace, so that consumers are well protected from the unethical trade practice, the Lt Governor added.

The winners of various competitions organized during the week long programme as part of creating awareness on Consumer Rights were felicitated by the Lt. Governor. He also felicitated the FPS owner of Deepali Enterprise from Diglipur for implementing 50 thousand cashless transactions, SC Enterprise from Nicobar for implementing 4 lakh cashless transaction and FPS Rajan Store, Dairy Farm for maintaining good ambience in the shop. The President of the State Commission, A&N Islands, Justice Asim Kumar Ray, while speaking about 'Consumer Rights in the digital age' said 'the death of distance' that is intrinsic to information networking is probably the single most important economic force shaping the society at the dawn of 21st century. He said, today is an age of internet economy and according to the study by the Boston Consulting Group's Centre for consumer and customer insight, India is on the threshold of a digital revolution. The number of internet users in India is expected to nearly triple from 125 million in 2011 to 330 million by 2016, he added. He further added that the rapid pace of development of internet in such a short span of time has also created a huge platform for an informational world- wide market. Speaking about the consumer movement in India, he said, one of the important milestones in the consumer movement in the country has been the enactment of the Consumer Protection Act, 1986. This, he said is a progressive and comprehensive piece of umbrella legislation covering all goods and services.

In his address, the Chief Secretary, Shri Anindo Majumdar complimented the Department of Civil Supply & Consumer Affairs for striving to improve awareness among consumers about their rights. He also complimented the Department for the successful implementation of e-PDS in South Andaman despite poor connectivity. He remarked that often consumers are not aware of their rights and do not have access to free market but with the arrival of digital age, things are being transformed. He said in these Isles, the consumers are reasonably informed about their rights, but nowadays a lot many consumers have switched to online shopping as well. He further stated that improvement in the IT sector in Isles with proper connectivity in place; will further enable the consumer the right to choose. He said, more thrust has to be given in creating awareness about consumer rights among Islanders and the right to consumer education should continue in every part of the Islands particularly the Nicobar District.

He said, the World Consumer Rights Day aims at creating awareness among consumers about their basic rights as well as to protect them against market abuse and various other social injustice meted out to the consumers. He also threw light on the various initiatives taken up by the Dept. of CS&CA for the consumers of A&N Islands. He informed that so far, e-PDS has been implemented in 345 FPS out of 487 and the remaining FPS will also be covered soon while 70 thousand smart cards have been issued to the PDS beneficiaries which has led to ease in use of commodities as well as knowledge about rates of commodities. He further added that 97% of the population of Isles has been covered by FPS for meeting the food grains requirements. Further, focus is on to cover the North & Middle Andaman Districts as well as the Nicobar District phase wise, he added.
