India approves strategic airport near Malacca Strait

India has approved a major infrastructure project on Great Nicobar Island, paving the way for the construction of a new international airport close to the strategically important Strait of Malacca, one of the world's busiest maritime trade routes.

The project moved forward after receiving environmental clearance, allowing authorities to begin the next stage of development on the island located about 180 kilometers from Sumatra, Indonesia, News.Az reports, citing Telegram.

According to the plan, the airport will be built in four phases extending until 2075. Once completed, it is expected

to handle around 1.35 million passengers annually, significantly improving connectivity to the remote Andaman and Nicobar Islands and strengthening India's presence in the eastern Indian Ocean.

Officials say the facility will serve a dual purpose. While it will operate as a civilian airport under the Airports Authority of India, it will also support the Indian Navy, giving the military an additional strategic foothold near the

Malacca Strait - a key chokepoint through which a large share of global oil and trade flows.

The location is considered highly strategic, as the Malacca Strait links the Indian Ocean with the South

China Sea, making it one of the most critical maritime corridors in the world.

The airport project is part of a broader development initiative for Great Nicobar Island, which also includes plans for a transshipment port, power infrastructure, and urban development aimed at boosting economic activity and strengthening India's strategic presence in the region.

Experts note that the project could significantly enhance both commercial connectivity and maritime security in the Indo-Pacific region, where geopolitical competition and trade flows continue to grow. (Source: https://news.az/)

State Level Communication Mock Exercise on Earthquake & Tsunami today

General public urged not to panic during siren activation & mock exercise

Sri Vijaya Puram, Mar. 15 The Directorate of Disaster Management, A&N Administration in coordination with all emergency support functionaries, ANC, NDRF and INCOIS is going to conduct a State Level Communication Mock Exercise on Earthquake and Tsunami across the Andaman & Nicobar Islands on March 16 from 9.30 AM to 11.30 AM.

The objective of the exercise is to test the effectiveness of the disaster communication systems, alert dissemination mechanisms, emergency

siren systems, and coordination among various Departments and emergency response agencies during earthquake and tsunami situations. During this Exercise, various communication modes are to be checked and no physical activities to be carried out.

As part of the mock exercise, emergency sirens will be blown at designated locations on March 16 to simulate early warning dissemination. The siren activation is only a part of the mock exercise. The general public have been urged

not to panic during the siren activation and mock exercise activities. All essential services and routine public services will continue as usual and will not be interrupted during the exercise.

The cooperation and support of the general public is requested to ensure the successful conduct of this communication exercise, which is aimed at strengthening disaster response mechanisms and enhancing public safety across the islands, a press release from Directorate of Disaster Management said.

ULLAS - Nav Bharat Saaksharta Karyakram; A&N Islands declared fully literate Union Territory

Sri Vijaya Puram, Mar. 15 The Union Territory of Andaman and Nicobar Islands has achieved a historic milestone in the field of education and social development by being formally declared a fully Literate Union Territory under the ULLAS - Nav Bharat Saaksharta Karyakram (New India Literacy Programme - NILP).

The flagship adult education scheme ULLAS-NILP was implemented in the Andaman and Nicobar Islands during the year 2023-2024 with a focused and systematic approach. Comprehensive surveys were conducted across the Islands to identify non-literate adults, following which eligible learners were enrolled at nearby Samajik Chetana Kendras. These learners were imparted Foundational Literacy and Numeracy (FLN) through committed voluntary teachers. All enrolled learners subsequently appeared in the Foundational Literacy and Numeracy Assessment Test (FLNAT) conducted by the National Institute of Open Schooling (NIOS) and successfully qualified.

The Adult Education Bureau, Department of School Education and Literacy (DoSE&L), Ministry of Education, Government

of India, has prescribed a Standard Operating Procedure (SOP) for declaring a State or Union Territory as fully literate, communicated vide letter No. 8-4/2024-AE.2 dated 11.12.2025. The provisions of the SOP are as under.

- Reference: Census of India 2011 data: Total number of population.
- Projected population in 2024 excluding population below 7 years.
- Derive the number of 5% of total population.
- If the total number of non-literate population

identified through the ULLAS Survey is less than the 5% of total population, then the State/UT has literacy rate more than 95% and may declare as a fully literate State/UT

Alliteratively, a survey under ULLAS may determine that 95% people are literate.

As per the suggested SOP, the following has been followed by the State Literacy Mission Authority (SLMA), Andaman & Nicobar Islands for ascertaining the status of fully literate.

Aforementioned data reflects that as per ULLAS Survey, 2023, the total number of illiterates were 3387 against 19154 (5% of the projected population of 2025). Thereafter, the State Literacy Mission Authority conducted ULLAS-Survey's in 2024 and 2025 to identify the non-literates of age above 15 years and identified learners were imparted teaching at Samajik Chetna Kendra's to enable them appear and pass the Foundation Literacy & Numeracy Assessment Test (FLNAT). During the period 2023 to 2025, altogether 6087 learners qualified FLNAT and were declared literate by NIOS. This includes the recent and the last batch of 492 learners who qualified the FLNAT held on 21-09-2025.

Small poultry initiative brings big success: Shri Mohammed Ali's inspiring journey in backyard farming

Sri Vijaya Puram, Mar. 15 Shri Mohammed Ali, a 39-year-old resident of Lillypur, Sri Vijaya Puram, has emerged as a shining example of how small-scale poultry farming can yield substantial income when supported by proper guidance and veterinary care from the Department of Animal Husbandry & Veterinary Services (AH&VS). Starting with a modest investment, Shri Ali has transformed his venture into a resilient and profitable enterprise, achieving a total profit of approximately Rs. 90,750 through dedicated management and departmental assistance, highlighting the potential of backyard poultry as a reliable source of additional income for



island residents. In September 2025, Shri Ali began his poultry journey with 100 Quails procured from the Central Hatchery, LFC, Dollygunj, at an initial investment of just Rs. 600. He actively sought guidance from the AH&VS Department, attending sessions on maintaining hygienic conditions in poultry sheds and ensuring proper feeding practices for

optimal egg production. Free veterinary medicines from the Veterinary Hospital, Junglighat, further supported his efforts. With consistent care, the Quails began producing eggs regularly, generating around Rs. 60,000 from egg sales. Additionally, he sold Quail birds for meat, earning Rs. 7,500, and used the profits to expand his operations. Encouraged by these

results, Shri Ali purchased 60 Nicobari chicks in the same month from the Central Hatchery. Out of these, 25 male birds were reared to maturity and sold for meat, fetching Rs. 23,250. The female birds were retained for egg production, providing a continuous income stream. Building on his success, Shri Ali invested in another batch of 200 Quails in February 2026, further scaling his unit. His story demonstrates how small-scale poultry farming can become resilient and profitable with dedication and departmental support, reducing risks and maximising returns.

This success underscores the importance of training and

Community-led beach cleanliness drive removes over 230 kg of waste from Little Andaman Beaches

Little Andaman, Mar. 15
In a strong demonstration of environmental responsibility, the local administration and residents of Little Andaman conducted a large-scale coastal cleanliness drive across key shoreline locations today.



The initiative focused on critical coastal areas under the jurisdiction of local Gram Panchayats, particularly the Fish Landing Jetty at Hut Bay (Netaji Nagar) and Dungi Ghat at R.K. Pur. The campaign was organized in response to the growing accumulation of non-biodegradable waste in these environmentally sensitive zones. Through the collective efforts of volunteers and officials, a total of 233 kg of

waste was removed from the beaches, significantly improving the cleanliness and natural beauty of the coastline. The waste collected included PET and glass bottles (145 kg combined), multilayer plastics (40 kg), industrial ropes (30 kg), footwear or chappals (12 kg), and thermocol (6 kg). Participants included Panchayat Secretaries and PRI members, staff from various Government departments, as well as local residents and volunteers. All collected waste was carefully segregated, documented, and transported for proper disposal and recycling, ensuring that the materials do not return to the marine environment, a press release from BDO, Little Andaman said.

Training Prog. on scientific rearing and management of dairy cattle successfully conducted

Sri Vijaya Puram, Mar. 15
A comprehensive two-day training programme on "Scientific rearing and management of Dairy Cattle" was successfully organised under the Extension Reform scheme (UTATMA) from 6th to 7th March, 2026 at the Veterinary Hospital, Campbell Bay, under Govind Nagar Panchayat. The programme was specially designed to equip local dairy farmers with modern scientific knowledge and practical skills essential for improving cattle productivity in the challenging island environment of Great Nicobar.



During the training sessions, participants were provided with in-depth understanding of key aspects including proper breed selection suitable for tropical island conditions, balanced nutrition and feeding practices, preventive health care measures, scientific housing and shelter

management, reproductive health management, and techniques for value addition of milk and milk products. Resource persons from the department delivered both theoretical lectures and hands-on practical demonstrations, ensuring that farmers could directly apply the learning in their day-to-day dairy operations. 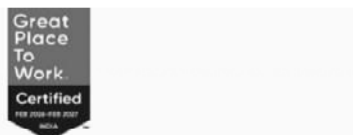
