## Virtual museums to be set up in 50 places across country: PM Modi

Bhubaneswar, Apr 16 Prime Minister Shri Narendra Modi today said virtual museums would be set up at 50 places in the country to highlight the significant role of the tribals in the freedom struggle. The Prime Minister said, the government seeks to present before the present and future generations the sacrifices made by the tribal communities in the country's freedom struggle. Prime Minister Shri Modi today felicitated the family members of 16 great freedom fighters including Raghu Dibakar, Laxman Nayak, Chakhi Khuntia, Bauji Jagabandhu, Veer Surendra Sai, Nirmal Munda and others, who participated in the first mutiny against British rule known as Paika Rebellion. He met family members of the great souls at Raj



Bhawan in Bhubaneswar, who undertook an armed rebellion against the British East India Company in 1817. On the occasion, Shri Modi said it is a proud moment for him to remember the sacrifices made by the martyrs and he is fortunate

to meet their family members. Shri Modi also termed the Paika revolt as one of the major historical event of the freedom struggle. The Prime Minister said, unfortunately, the history of freedom struggle was restricted to a few families, years and a few

incidents. It was a massive people's movement for many years and the present generation must know about it. Shri Modi also visited 11th century old Lingaraj Temple and offered puja and prayers to Lord Shiv and other deities at the Mandir premises.

## CBI to get new online system to deal with black money cases

New Delhi, Apr 16 The Central Bureau of Investigation (CBI) will get a new online system to assist it in probing cases of illegal wealth or black money. It will be helpful in collating data from various agencies including banks, Income Tax, I-T, department and Financial Intelligence Unit, FIU, among others. The move comes after a multi-disciplinary committee formed by the Central Vigilance Commission, (CVC) which exercises superintendence over the CBI in investigation of corruption cases, suggested changes in the existing system. The CVC felt to improve

the system for computation of disproportionate assets, including development of a software to capture all the events related to income and expenditure during the check period. It was also observed by the Central Vigilance Commission that in the present system, data availability with banks, FIU, taxation departments, etc are not being mandatorily obtained and utilised for computation of disproportionate assets. After the new system will be put in place it will be more scientific and help investigators get information of all hidden income using modern tools.

## Book titled 'Islands in Flux - The A&N Story' to be released on Apr 20

Port Blair, April 16 'Islands in Flux - The Andaman and Nicobar Story', a new book by researcher and novelist Pankaj Sekhsaria is slated to be released at Nehru Memorial Museum and Library (NMML), Teen Murti Bhavan in New Delhi at 3 pm on April, 20, 2017. ## Extension of dry dock-II at Port Blair to enhance ship repair facilities; work commenced by ALHW

Staff Reporter, Port Blair, Apr 16 Shipping activities are considered to be the life line to the Islands and almost all the developmental activities are linked with the shipping activities. Considering the increase in developmental activities that are taking place in these Islands, the ship movements have significantly been increased in order to meet the demands of the Islanders as well as tourist population which is further increasing manifold year by year. To keep the shipping activities alive without any



interruption, the ship repair facilities are also being developed in the Isles concurrently. Accordingly, to meet the demand of ship repairing in Islands itself, the present length of the existing Dry

dock-II at Marine Dock Yard will be further extended to 90 more meters in length to accommodate more vessels intending to take up repair facilities. The extension of dry dock facility will double its

capacity for ship repair facilities in Port Blair. The work for the project has already commenced, which will be completed by March 2019. Fund for the project was

## Cyclonic Storm 'Maarutha' over Bay of Bengal; fishermen cautioned

Port Blair, Apr 16 The cyclonic storm (Maarutha) over east central Bay of Bengal further moved North eastwards with a speed of 19 kmph during past 06 hours and remained centred at 1430 on 16th April, 2017 over eastcentral Bay of Bengal near Latitude 17.5°N and Longitude 93.2°E, about 510 km nearly north of Maya Bandar (Andaman & Nicobar Islands) and 160 km southwest of Sandoway (Thandwe), Myanmar. The system is likely to move northeastwards and cross Myanmar coast near Sandoway (Thandwe) around mid-night of Apr 16.

**Wind warning:** Squally winds speed reaching 40-50 kmph gusting to 60 kmph would prevail over Andaman Islands and adjoining Sea areas during next 12 hours.

**Sea condition:** Sea condition would be rough to very rough along & off Andaman Islands during next 12 hours.

## Young Islander cracks SSB with flying colours My only goal was to wear 'Olive Green Uniform', says Shubham

Port Blair, Apr 16 Despite lack of proper connectivity and facilities, Islanders are making waves all over, due to their sheer determination to be at par with the rest. One such story is that of Isles very own student, Shubham Shukla, who recently cracked the Services Selection Board (SSB) from 11SSB Allahabad, considered to be the toughest board of India. He secured the first rank in all India merit list for SSC Tech 48.

Shubham is currently undergoing year long training at Officers Training Academy, Chennai and will be a Commissioned Officer in the Indian Army after completion of the training.

Speaking to the DT Reporter over phone recently, Shubham recalled his momentous journey to SSB. He adores martyred Late Capt. Ashim Kumar Bhattacharjee, alumni of JNRM, who inspired many students of Isles to get into the defence forces. Shubham did his schooling from JNV Panchawati, N&M Andaman District and B. Tech in Civil Engineering from DBRAIT.

Acknowledging the support of his family members, Shubham said, "Family is the only key to my success". His father, Dr. A. K. Shukla, HoD, Hindi Deptt. ANCOL, his mother late Manjula Shukla and three elder sisters have always been his source of strength. He also owes his success to his cousin, Shri Devanand Pathak, SI A&N Police, for his constant guidance. He vowed to make them proud and did live up to his word.

"The only goal I set was to wear 'Olive Green Uniform' and told this to every person I came across that I wanted to get into the defence force", recalled Shubham. He started preparing for different stages of SSB, since 2015. In his first attempt, Shubham was confident of making it through and he

New Delhi, Apr 16

The Centre plans to issue an advisory to states asking them to crack down against unfair imposition of service charge on food and drink bills.

Talking to reporters in New Delhi recently, Food and Consumer Affairs Minister Shri Ram Vilas Paswan said the service charge does not exist and it is being wrongly charged. He said his Ministry has

prepared an advisory on this issue and sent it to the PMO for approval. A senior ministry official said the levying of service charge without seeking customer consent will be considered as unfair trade practice under the Consumer Protection Act.

Earlier too on several occasions, Shri Paswan spoke against unfair imposition of service charge on food bill and had

even sought explanation from hotels and restaurants' bodies. In January, the Department of Consumer Affairs stated that service charge on food bills is not compulsory and a customer can choose to have it waived if not satisfied with experience. The states were told to ensure that hotels and restaurants disseminate this information through displays in their premises.

**Government to set up 32 new seismological observatories**

New Delhi, Apr 16

Government will set up 32 new seismological observatories by the year end to boost information gathering capability on earthquakes. At present 84 such observatories are functional in the country. The observatories generate ground motion data recorded by the digital

seismography used for estimation of data and other earthquake parameters. Secretary in the Ministry of Earth Sciences Shri M Rajeevan said, the five observatories will be installed in Uttar Pradesh, four each in Bihar and Haryana, three each in Himachal Pradesh and

Delhi, two each in Jammu and Kashmir, Rajasthan and Madhya Pradesh and one each in Uttarakhand, Jharkhand, Punjab, Chhattisgarh, West Bengal and Lakshadweep. He said, by adding these new observatories, the information can be gathered within shorter time. Shri Rajeevan said.

The committee suggested modifications in research topics in the action plan for refinement and assessment of new technologies for farming communities & unemployed youth in the respective KVKs of each district based on local needs. The Director, ATARI, Kolkata urged the Senior Scientist & Heads of KVKs to streamline their activities based on perception, priorities and reality. The Director, CIARI highlighted that KVK plays a vital role between researchers and farming communities in dissemination of new innovations in the field of agriculture and allied aspects. The Vice Chancellor, Bihar Agricultural University in his concluding remarks emphasized on the need for strengthening the existing soil testing labs in KVKs by providing sufficient funds from ICAR-ATARI.

Further, he stressed to augment the seed and planting material production under each KVK to meet the demand of local farmers. A total of 89 KVK heads have participated from all the four states under Zone-II ATARI.

During the programme, the Director, Extension from BAU, Bhagalpur, RAU, Ranchi and WBUAFS, Kolkata shared their views for improvement in the basic infrastructures of KVKs for better functioning. In the programme, a total of 18 technical bulletins on different themes in local languages were released for the benefit of farming community. A field visit was also arranged for the participants of the workshop.

At the end of the workshop, the panelist also submitted their recommendations for improvement and strengthening of KVK system. Earlier, Dr. F. H. Rahman, Principal Scientist, ATARI welcomed the participants while Dr. P.P.Pal, Principal Scientist, ATARI proposed the vote of thanks, a communication said.

got screened out from 17SSB Bangalore on Feb 9, 2016. Closer to the ladder of success, he worked twice hard and his second attempt fructified. Recalling the arduous journey, Shubam said, competing with candidates from different parts of mainland was not a cake walk, but nonetheless, the education system of Isles is at par with mainland and many Islanders have proved their mettle in different spheres of life.

Sharing about the training which begins this month, Shubam stated that there are many cores in Indian Army and presently he has not got into such cores, but he is most likely to be inducted into military engineering services since he was selected in technical entry.

About the process of writing SSB, Shubham said there are many entries for non-tech students. "There is an exam conducted by UPSC called Combined Defence Service Examination. The ones who cross the cut off have to appear for SSB in different boards. For technical and NCC 'C' Certificate candidates, there is a direct entry to SSB Board. They have to create an id in joinindianarmy.nic.in and register themselves", he added.

SSB is a five day interview panel in which a person will be judged mentally physically and psychologically. He focused more on Psychological test, which is the second day procedure in SSB interview and was quite a challenging one, he admitted.

Though not many will be able to clear it at the first stroke, yet it will be a learning process and provides opportunity for self introspection, said Shubham. His message for the youth is that, to be successful in life, one has to stay focused and not let negative thoughts diminish the will power. One should set a goal and achieve it, he said.
