National Fellowship & Scholarships for Higher Education of ST Students

Port Blair, April 18

The Ministry of Tribal Affairs, Govt of India has launched a Central Sector Scheme namely 'National Fellowship and Scholarships for Higher Education of Scheduled Tribe Students' in November, 2017 which provides for grant of fellowships to the students belonging to the Scheduled Tribes for pursuing higher studies such as M.Phil and Ph.D in the Universities and Institutions recognized by the University Grant Commission (UGC) under Section 2(f) of the UGC Act and Scholarship for pursuing studies at Degree and Post Graduate levels in any of the Institutions identified by the Ministry of Tribal Affairs.

As per the guidelines, the duration of grant of fellowship is for a maximum period of 2 years for M.Phil

course and 5 years for Ph.D course and 5 years i.e. 2 years for M.Phil plus 3 years for Ph.D under the combined M.Phil & Ph.D course. The scholarship amount covers tuition fee, boarding and lodging expenses, book grant and a onetime grant for purchase of a computer alongwith its accessories including the full amount of tuition fee and other non-refundable dues in respect of Government/ Non-Government funded institutions. However, in case of the students pursuing their studies in private sector institutions, a ceiling of scholarship amounting to Rs. 2 Lakh per annum per student has been fixed by the Ministry. India clubbed with Maldives,
Sri Lanka in SAFF Cup Football

New Delhi, Apr 18
Seven-time champions India have been drawn in Group B with Maldives and Sri Lanka during the official draw of the 2018 SAFF Cup Football tournament. In group A, the tournament hosts Bangladesh, will go head-to-head with Nepal, Pakistan, and Bhutan after an exciting ceremony at the Pan Pacific Hotel Sonargaon. The SAFF Suzuki Cup, the region's premier football tournament, will be played in Bangladesh from September 4 to 15 - marking the third time it has been staged in the country. India have faced Maldives three times in the SAFF Cup final defeating them in 1997 and 2009 - when the event was last played in Dhaka. In 2008, the Maldives got the

better of their prestigious rivals for what remains as their sole success in the competition. India are also the defending champions following their success in 2015, when they overcame Afghanistan in the final. The latter team is not competing this year having joined the Central Asian Football Association. The Bangabandhu National Stadium will host all the matches in September with the top four teams qualifying for the semi-finals. Bangladesh will hope that the return of the SAFF Suzuki Cup to home turf will mean a second title. When the tournament was hosted by the country for the first time in 2003, the Bangladeshis came out trumps by defeating Maldives on penalties in the final.

"Today, we raised the curtain on what will be the 12th edition of our region's biggest and most important international football tournament," said Kazi Md Salahuddin, President, South Asian Football Federation (SAFF). "Since our first tournament in 1993 in Lahore our tournament has made great strides forward and our organization is truly proud to be here today boasting seven fine footballing nations. The SAFF Cup plays such an important role in raising the profile of football in our region, and inspiring our younger generation to play the game." As well as winning a record seven times, India have been runners up three times while Afghanistan, Bangladesh, Maldives, and Sri Lanka have each tasted victory once.

New Delhi, Apr 18
India's bowling spearhead in Test format, fast bowler Ishant Sharma has made a promising debut for his side Sussex in the ongoing County Championship against Warwickshire. Ishant dished out a couple of impressive spells to end up with match figures of 29.2-7-69-5. The Delhi-born speedster took 3/53 and 2/16, respectively, in the two Warwickshire innings. In the first innings, he picked the three wickets of Wilfred Rhodes, Adam Hose and wicket-keeper batsman Tim Ambrose. While, in the second innings, Ishant bowled with a lot of nip and picked up the wickets of Jonathan Trott and Ian Bell, which gave Sussex some moments to cheer before the



close of play on the final day. As Sussex recruits Chris Jordan and Jofra Archer are busy in the Indian Premier League (IPL), Ishant's performance is a saviour for the County side. However, Ishant's performance went in vain as the weather gods kept intervening as the match resulted in a draw. After going unsold in the cash-

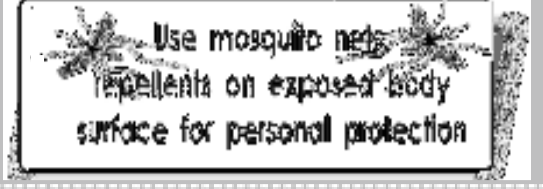

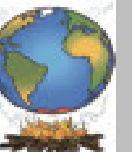
