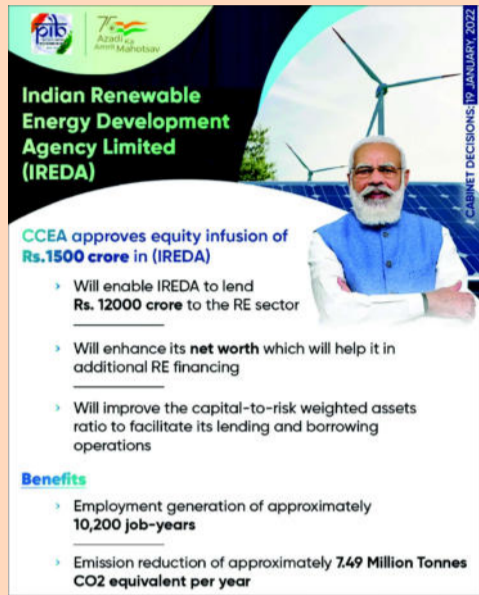


Cabinet approves infusion of Rs 1500 Cr in IREDA; also approves extension of tenure of National Commission for Safai Karamcharis for 3-years

New Delhi, Jan. 19

The Union Cabinet today approved infusion of one thousand 500 crore rupees in Indian Renewable Energy Development Agency Limited, IREDA. Briefing media in New Delhi, Information and Broadcasting Minister, Shri Anurag Thakur said it will enable IREDA to lend 12 thousand crore rupees to the renewable energy sector. He said, this will enhance its net worth which will help it in additional Renewable Energy financing. The Minister said, it will also improve the capital-to-risk weighted assets ratio to facilitate its lending and borrowing operations. The decision will generate employment over ten thousand jobs every year.

The Cabinet also approved extension of tenure of the National Commission for Safai Karamcharis, NCSK for three years beyond 31st



March, 2022. The total implication of the extension for three years will be approximately 43.68 crore rupees. The major beneficiaries will

be the Safai Karamcharis and identified manual scavengers in the country.

The number of Manual Scavengers identified under the Manual Scavengers Act Survey is over five lakh eight thousand. The NCSK was established in 1993. It has been giving its recommendations to the Government regarding specific programmes for welfare of Safai Karamcharis, study and evaluate the existing welfare programmes for Safai Karamcharis and investigate cases of specific grievances.

The Cabinet has also cleared the Scheme for grant of ex-gratia payment of difference between compound interest and simple interest for six months to borrowers in specified loan accounts. It has approved the

Preventive measures to contain COVID-19 & its variant Omicron Passengers arriving at Little Andaman from Port Blair should remain under home quarantine/isolation for 7 days

Port Blair, Jan. 19

It has been noticed that there has been surge in positive cases of COVID-19 in South Andaman District in the recent times. In order to ensure compliance to the containment measures of isolation and social distancing in the South Andaman District with some of the strategic areas of intervention focusing on containment, test, track, surveillance, clinical management, vaccination and COVID Appropriate Behaviour to control

any surge of the cases of COVID-19-Variant of Concern (VoC), 'Omicron' and also to prevent any disturbance to the peace and tranquillity and taking into consideration the request of the public representatives and general public, Shri Suneel Anchipaka, District Magistrate, South Andaman District, in exercise of the powers vested U/s 144 of Cr.P.C has ordered that passengers reaching Little Andaman from Port Blair shall remain

under home quarantine/isolation for a period of 7 days. All such persons under home quarantine or isolation have been directed not to leave the designated premises under any circumstances, till final clearance from the competent authority. Any disobedience of the above orders shall invite penal action u/s 188 of Indian Penal Code, 1860 and the relevant provisions of the Disaster Management Act, 2005 against the

PBMC striding towards making A&N Islands plastic free Using/selling single use plastics prohibited

Port Blair, Jan. 19

With the endeavour to make A&N Islands plastic free, the Administration has banned the sale/use of single use plastics in different forms. Despite the imposition of ban on single use plastics, it has come to the notice of the Port Blair Municipal Council that these products are being used and sold by users/commercial stakeholders respectively in the form of plates, glasses, cups, parcel paper, carry bags etc. Besides aluminium bottles, foils, wrapper and carry bags have been introduced in the market which are even more

dangerous than plastic. In this regard, PBMC has requested stakeholders not to store, use or sell such products. If any person is found using such single use plastic, fine will be imposed

as per PBMC, SWM (Handling Rules 2017) and commercial establishment will be seized for storing and selling/ providing such type of articles.

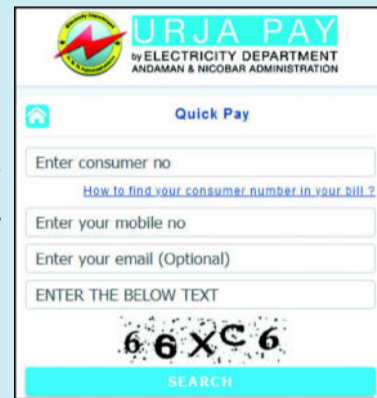

Online payment facility of electric bills witness positive response from consumers in Isles 13646 users registered; 169292 transactions made through 'Urjapay' portal so far

Reduced dependency on cash, transparency and the ease of transaction has made online payment, a preferred mode of payment for the Islanders. The online payment facility of electricity bill anytime anywhere has now become a boon for the Islanders residing in South Andaman as well as in North & Middle Andaman, as more and more users are registering themselves for paying their bill without queuing up at the billing centres for hours. The Digital India initiative of A&N Administration has made life much easier for people as access to facilities are at the click of a button. This is evident from the number of users registered as on



date. Under this facility, a total of 13646 users have registered and about 169292 transactions have been made through this portal. A total transaction amounting to Rs. 174885310/- has been made through this facility in South Andaman and North & Middle Andaman Districts.

As per the District-wise details available, the total number of transactions made in South Andaman District is 162166 and the

total transaction amount stood at Rs.170890390/-.

Similarly, about 1370 transactions have been made through this portal in North & Middle Andaman and the total transaction amount stood at Rs.3994920/-.

The online bill payment facility has been extended to both domestic and commercial consumers and they are now able to pay their bills from their residence/office or on the go, through the internet.

Consumers have been encouraged to make use of this facility by visiting the website <https://urjapay.andaman.gov.in>. The consumers have two options for making the payment viz. by registering themselves on the website. The registered user can add

As per data available, a total of 6,02,225 doses of vaccines have been administered to beneficiaries in the age group of 18 and above so far in A&N Islands. Similarly, 18,691 beneficiaries have been vaccinated in the age group of 15 to 18 years against the target beneficiaries of 23,000. The number of beneficiaries administered precautionary dose of vaccine so far stands at 3517.

multiple accounts besides they will be provided with a dashboard to view the details of previous transactions of all accounts including the due amount and make payment and by using quick pay option-the consumers can now make the payment by entering the consumer number.

When the consumer clicks on the prompt "PAY NOW" he/she is redirected to BharatKosh-Non Tax Receipt Portal where he/she is provided with list of payment gateway. After selecting choice payment gateway, he/she has the option to make the payment through Internet banking, Credit Card, Debit Card of all major banks and Unified Payment Interface (UPI) including BHIM. After successful completion of transaction, the consumer is redirected on to the website with a successful receipt of payment.

In case of error/ non successful transaction, the consumers are advised to wait for 30 minutes and check their status by visiting the "Urjapay" portal. In case of failed transactions, the amount, if any, debited will be reversed within 3-7 days. In case the amount is not reversed, they can file a grievance at "complaint section" of urjapay or may send through email at itcellepb@gmail.com.

in A&N Islands. This calls for speedy deployment of towers to expand the coverage. DOT has planned to provide 4G mobile coverage by installing 128 towers for covering 85 uncovered villages and along NH-04 in A&N Islands. However, due to misconceptions and misinformation, public at some locations are apprehensive whenever a tower is proposed in the vicinity of residence etc.

Department of Telecom (DoT) has created a mechanism to ensure that radiation limits from telecom towers are within limits. All telecom service providers have to give periodic certificates to this effect and DoT field offices have been mandated to audit 10% BTS every year. As part of this, DoT A&N has tested 351, out of 702 BTS till 31st December, 2021 and found that all towers are within the permitted radiation levels.

Apart from this, DoT has created a portal www.tarangsanchar.gov.in wherein there is a provision for the General Public to see the radiation level of towers in their vicinity by entering their area postal PIN code.

Considering the mobile expansion plan for introduction of 5G, the number of towers is to be increased from 309 to 511 within the next 2 years. In view of this, DoT A&N Port Blair has request co-operation from stakeholders including the general public to shed all misconceptions about mobile tower radiations and come forward to extend all possible support for faster roll out of telecom infrastructure to meet the unprecedented demand for telecom services.

Furthermore, in order to create awareness and dispel myths about towers, a session will be held on January 20, 2022 at 11.30 am and the general public have been invited to participate via a Google link https://meet.google.com/xqu-gijp-sdv or send "Hi" message to 9932081423 to know more about this and get link, a press release from DoT A&N said.
