In continuing action, seven officials have been suspended and the Chief Secretary has asked the Jail Authorities to see that necessary corrective measures are taken immediately. The seven erring officials who have been placed under suspension w.e.f 29.11.2021 are 1 Chief Head Warder, 1 Head Constable, 2 Head Warders, 1 Ward Attendant and 1

Barber. Besides this, X-Ray Machine as well as rotation of officers of Prison Department have been issued memo, calling their explanation. Further, corrective measures have also been advised in the inquiry report such as installation of CCTV at all places, X-Ray Machine as well as rotation of prisoners not only in the same Jail but elsewhere and conducting regular inspection in order to prevent such reoccurrence in future, a press release from Superintendent (Prison) said.

## Hassle free processing of applications related to COVID-19 death compensation cases

### District Administration (SA) sets up Help Desk to assist next of kin/family members of deceased in disbursement of ex-gratia relief

Port Blair, Dec. 1 In pursuance of Hon'ble Supreme Court's Judgment in W. P. (C) No. 539 & 554 of 2021, the National Disaster Management Authority (NDMA), Government of India has issued guidelines for Ex-gratia assistance to next of kin of the deceased by COVID-19 pandemic and recommended an amount of Rs. 50,000/- per deceased person including those involved in relief operations or associated in preparedness activities of COVID-19 subject to cause of death certified as COVID-19 and the said ex-gratia assistance to be paid from the State Disaster Response Fund (SDRF).



Administration, South Andaman has started the procedure for identifying the cases for Ex-gratia assistance to next of the kin of the deceased by COVID-19 pandemic. Taking proactive steps in this matter, Shri Suneel Anchipaka, District Magistrate/Deputy Commissioner, South Andaman has launched a Help Desk for hassle free processing of applications related to COVID-

19 death compensation cases. The dedicated help desk will assist the next of kin/family members of the deceased with any information related to documents required for processing the applications smoothly and also help the applicants in getting early disbursement of ex-gratia relief.

The Assistant Commissioner (Relief & Disaster Management) has been designated to monitor and verify the cases received in the Help Desk on a day to day basis in the Relief & Disaster Management Cell, District Office, South Andaman.

## Low pressure over central parts of Andaman Sea & neighbourhood

### Likely to concentrate into depression today; fishermen advised not to venture into sea

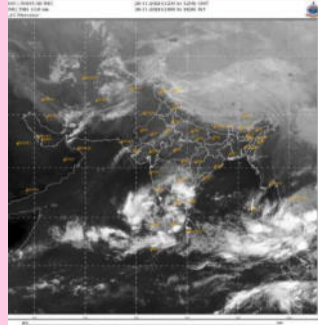
Port Blair, Dec. 1

A low pressure area lies over central parts of Andaman Sea & neighbourhood. It is likely to move west-north-westwards and concentrate into a depression over southeast & adjoining east-central Bay of Bengal by tomorrow (Dec.2) and intensify into a Cyclonic Storm over central parts of Bay of Bengal during the subsequent 24 hours. Subsequently, it is likely to move northwestwards, intensify further and reach near north Andhra Pradesh-Odisha coasts around 4<sup>th</sup> December morning.

Under its influence, heavy to very heavy rainfall is very likely to occur over A & N Islands on Dec. 2. Squally wind speed reaching 45-55 kmph gusting to 65 kmph is likely to prevail over Andaman Sea and it would further increase to wind speed reaching 50-60 kmph gusting to 70 kmph over southeast & adjoining East-Central Bay of Bengal, A & N Islands & Andaman Sea on Dec.2.

Gale winds speed reaching 65-75 kmph gusting to 85 kmph is also likely to prevail over central Bay of Bengal from the early morning of Dec. 3 and gradually increase becoming 90-100 kmph gusting to 110 kmph over Northwest & adjoining West-Central Bay of Bengal from the morning of Dec. 4 for the subsequent 24 hours.

Sea condition would become very rough to high over Southeast & adjoining east-central Bay of Bengal,



Andaman & Nicobar Islands & Andaman Sea on 2<sup>nd</sup> December. Sea condition would be high over central Bay of Bengal and high to very high over West-Central & adjoining northwest Bay of Bengal from the early morning of 4<sup>th</sup> December for the subsequent 24 hours.

Fishermen have been advised not to venture into Andaman Sea on Dec. 2 and those out at sea have been advised to return to coast by the morning of 2<sup>nd</sup> December.

The commuters/general public have been informed that due to prevailing inclement weather conditions, considering the safety of the passengers and the vessel, the announced sailing programme on all sectors on 2<sup>nd</sup> and 3<sup>rd</sup> December, 2021 may get disrupted leading to suspension or cancellation. The sailings will be reviewed/ confirmed 2 hours prior to the sailing of the vessel. Therefore, passengers and tourists have been advised to plan their journey suitably to avoid any inconvenience.

Similarly, in the prevailing weather conditions, operation of harbour/vehicle ferry services between Chatham, Bambooflat, Phoenix Bay, Dundas Point & Panigat may also get disrupted/suspended in short notice depending upon the weather conditions, a press release from DSS said.

Accordingly, the vaccination began with administering of COVISHIELD vaccine for Health Care Workers followed by frontline workers and vulnerable population with co-morbidities. Subsequently, the vaccination for 45 and above was initiated followed by 18 to 44 years which is currently underway.

Meanwhile, the vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 5,54,860 doses of vaccines have been administered to beneficiaries so far in A&N Islands, out of the target beneficiaries of 2, 86, 600 (approx.).

Today, a total of 1346 people were vaccinated. 1116 beneficiaries were vaccinated in South Andaman District, out of which, 83 beneficiaries were in the age group of 18-44 years. Similarly, 210 beneficiaries were vaccinated in North & Middle Andaman District, out of which, 9 beneficiaries were in the age group of 18-44. 20 beneficiaries were vaccinated in Nicobar District. A total of 1,75,862 eligible people in the age group of 18 to 44 years have been vaccinated till date, a press release from DHS said.

### Farmers' Corner- A Knowledge Hub

#### Rain water harvesting through lined pond

In Andaman and Nicobar Islands, during post monsoon period, there is growing scarcity of water for meeting even domestic demand and livestock use resulting in very less importance given to agricultural use. Hence, the only option available is rainwater harvesting, storage and its efficient use in agriculture and other sectors. In the islands, normally rain water harvesting is done through farm ponds which dry up during summer months due to water loss from evaporation and seepage. However, efficient water storage in small ponds is possible in the island through lining with suitable material. Plastics can be used very effectively in lining the ponds. The lined tanks have been found as one of the best option for water storage at cheaper cost. Generally mechanical excavator is used for making pond in high rainfall and sandy coastal areas. The pond of any size can be made based on available space and budget. However, small size (6 x 5 m) pond is always better for the islands. The steps involved in construction of lined pond are,

- ♦ Site selection, cleaning, levelling and demarcate pond area (6 x 5 m)
- ♦ Dig the soil upto 1.5 m depth using mechanical excavator and make boundary around the pond
- ♦ Give 1:1 or 1:0.5 slope depending on the soil type and to prevent collapse of side wall
- ♦ Remove any stones or other projections from the bed and sides of the pond followed by compaction and consolidation
- ♦ A layer of fine soil (1-2 inch) should be spread over the bottom of the pond to avoid any damage to the film.
- ♦ Place LDPE film of size 10 x 10mat bottom and side slopes of the pond followed by anchoring

From this small lined pond, about 40 m<sup>3</sup> (1m<sup>3</sup>=1000 lit) of rain water could be harvested and stored at the end of rainy season, which is sufficient to irrigate vegetable crops in 0.20 ha. The approximate cost of making lined pond is Rs. 50,000. The short duration vegetables like okra, cowpea, gourds, palak and amaranthus etc can be easily cultivated and an average yield of 1000-1500 kg/0.2 ha can be achieved.

Benefits: Rainwater harvesting through lined pond is one of the best options for efficient water storage without seepage loss and promoting vegetable cultivation for household use.

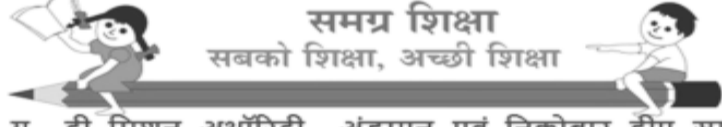
