Stakeholders, farmers & Agriculture Units urged to use only organic inputs

The Hon'ble Lt. Governor, Union Territory of Andaman & Nicobar Islands in a notification issued today has imposed a uniform ban on sale/use/entry/storage of all agro-chemicals for agricultural practices in Car Nicobar and Nancowrie group of Islands (Kamorta, Katchal, Teresa, Nancowrie & Chowra) with immediate effect with a broad vision

to declare the above Islands as 'Agro Chemical Free Zone'. This has been done to ensure that agricultural practices of Car Nicobar and Nancowrie group of Islands are organic.

All the stakeholders, farmers and Agriculture Units should use only organic inputs which includes on-farm/off-farm organic inputs for agricultural practices in the above Islands, the notification added.

Joint Military exercise 'Kavach' to be organized by ANC Exercise aims to fine tune joint war-fighting capabilities & SOPs towards enhancing operational synergy

Port Blair, Jan. 21

A large scale Joint Military exercise titled 'Exercise Kavach' involving assets of Army, Navy, Air Force and Coast Guard will be conducted in the coming week under the aegis of the Andaman and Nicobar Command (ANC), the only Joint Forces Command of the country. The exercise would involve participation and deployment of elements of Army's Amphibious Brigade along with

supporting forces including Special Forces of Navy, Armour/ Mechanised components, Naval Ships comprising Destroyers, ASW Corvettes and Landing Ships with ship-borne helicopters of Eastern Naval Command and ANC, Jaguar Maritime Strike and Transport aircrafts from Indian Air Force and assets of Coast Guard.

The exercise involves synergised application of maritime surveillance

assets, coordinated air and maritime strikes, air defence, submarine and landing operations. Concurrently, Joint Intelligence Surveillance and Reconnaissance (ISR) exercise involving various technical, electronic and human intelligence from three services will be conducted. The ISR exercise will validate the capabilities of intelligence gathering from space, air, land and sea based assets/

sensors, its analysis and sharing to achieve battle field transparency for quick decision making at different stages of operations. The joint force would execute multi domain, high intensity offensive and defensive manoeuvres in the Andaman Sea and Bay of Bengal and carry out amphibious landing operations, air landed operation, helicopters-borne insertion of Special Forces from sea

Implementation of Aatmanirbhar Bharat Rozgar Yojana Scheme to incentivize creation of new employment opportunities in EPFO registered establishments

Port Blair, Jan. 21

As part of the Aatmanirbhar Bharat 3.0 package, the Central Government has launched the Aatmanirbhar Bharat Rozgar Yojana (ABRY) to incentivize creation of new employment opportunities during the COVID-19 recovery phase by providing assistance to the employers of establishments registered with the Employees' Provident Fund Organisation (EPFO) to recruit unemployed persons



including re-employment of those who were rendered unemployed during the pandemic.

Under the ABRY, both the employees' share (12% of wages) and employer's share (12% of wages) of contribution depending on the employment strength of the establishment will be

paid by the Central Government in the Universal Account Number (UAN) of eligible new employees employed in EPFO registered establishments. The scheme shall remain in force for registration of eligible employees from 1st October, 2020 to 30th June, 2021.

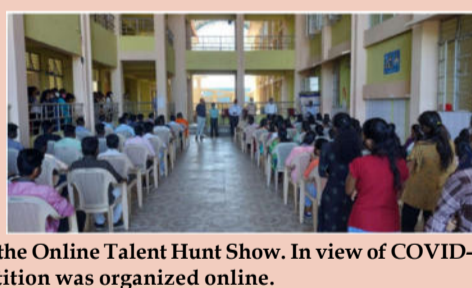
