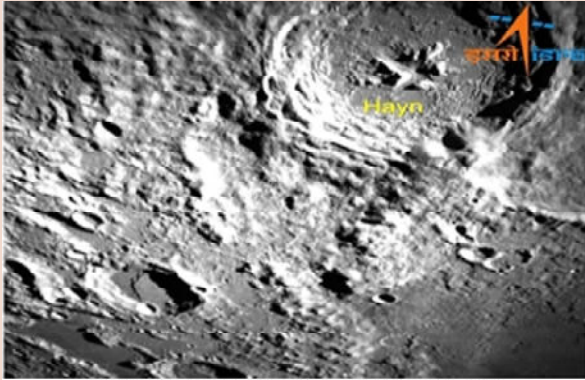

A new 5 MT Ice-Plant and 10 MT Cold Storage has been constructed at the premises of Fish Landing Jetty, Junglighat by the Fisheries Department for the benefit of the fisherfolk of the area. The fisheries infrastructure facility



was inaugurated by the Secretary (Fisheries), A&N Administration, Shri G. Sudhakar, IAS, by unveiling the plaque at a brief function held at the Fish Landing Centre. Shri Vikram Singh,

Director (Fisheries), Shri Y.Joga Rao, Ward Councilor, Shri U.Maheshwar Rao, Member NFDB Governing Body and Officials of APWD, Fisheries and local fishermen community were present on the

occasion.

The 10 MT Cold Storage Unit has dual units in case of failure of one unit. Racks are provided in the cold room using the storage space more efficiently. The 5 MT Containerized Ice Plant unit will produce 54 Ice blocks, of 50 Kg each, in 10 hours, i.e. it can produce 108 Ice Blocks per day. 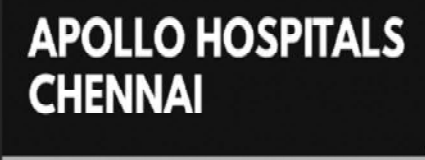

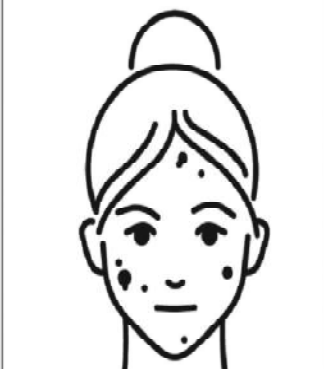

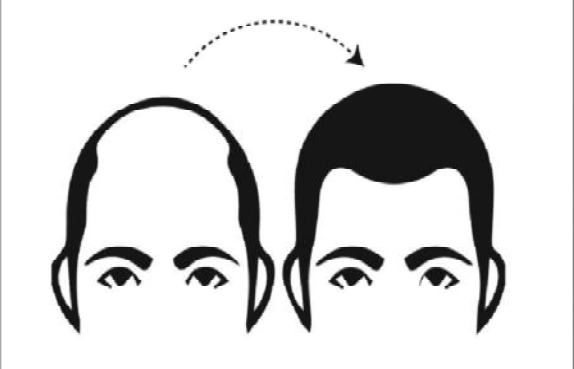
