Great Nicobar Port to get LNG-based plant, international airport

The proposed Rs 41,000-crore Great Nicobar International Container Transshipment Terminal will be supported by major facilities. This includes a 450-MW liquefied natural gas (LNG)-based power plant and a greenfield international airport. NTPC will set up the LNG power plant, while the new airport is expected to be set up by the Airports Authority of India (AAI). To ensure holistic development of Great Nicobar Island in the Andaman and Nicobar Islands, the project will comprise the development of an international container transshipment port, a greenfield airport, a power plant, and a township. It also aims to reduce dependency on neighbouring transshipment hubs, thus lowering container logistics costs. The project will soon be taken for appraisal by the Public Investment Board (PIB). This approval precedes a nod of the Union Cabinet for such large infrastructure projects. The LNG handling facilities will be developed at the transshipment terminal. This project is proposed to be developed in four phases, with a capacity of four million twenty feet equivalent units (MTEU) to be added at each stage. The maximum capacity of the Great Nicobar project is expected to reach 16 MTEUs by 2059. The port is pitched as a regional hub for Bangladesh, Myanmar, and India's eastern coast. Port Blair, July 22 The skies of Andaman & Nicobar Islands are poised for a transformative leap as the Airports Authority of India has signed a landmark Operation & Maintenance Agreement with the Union Territory Administration of Andaman & Nicobar Islands today. The agreement was signed by Shri Vishwendra, Secretary, Civil Aviation, A&N Administration and Shri N V Subbarayudu, Executive Director-II (JVC/PP) Airports Authority of India. As per this agreement, Airports Authority of India will operate and maintain the airports for five years which can be extended for a further period of five years on mutually agreed terms and conditions.



Similar agreement for Shibpur Airport was already signed on 01.09.2023. Airport Director, Shri Devender Yadav said it is a new chapter in civil aviation excellence. This momentous partnership will usher in the operationalisation of Car Nicobar Airport & Campbell Bay Airport and will make a new era of air connectivity and development for the region, a press release from Airport Director, VSI Airport said.

Bar and POL owners urged to strictly comply with due dates for remitting VAT

Port Blair, July 22 It has been observed that some Bar Owners and POL (Petroleum, Oil & Lubricant) Owners are not remitting their Value Added Tax (VAT) on a monthly basis within the due dates as notified vide F.No.1-1/DC (SA)/VAT (PF)/2017-18/5974 dated 31st December, 2020 issued by the Commissioner (VAT), A & N Islands. This non-compliance constitutes a gross violation of VAT Rules and results in a significant loss to the Government exchequer. Therefore, all bar owners and POL owners have been once again directed to strictly comply with the due dates as per the aforementioned notification provided as under:

Enhancing milk production and productivity in cattle Livestock owners of A&N Islands urged to take benefits of 'Rashtriya Gokul Mission' Scheme

Port Blair, July 22 The Department of Animal Husbandry & Veterinary Services has implemented the 'Accelerated Breed Improvement Programme - Sex Sorted Semen (ABIP-SS)' under the central sector scheme 'Rashtriya Gokul Mission' in these Islands. This scheme aims to strengthen the ongoing Cattle Development Programme for up-gradation of local cattle through Artificial Insemination using frozen semen of bulls having superior quality. The Department has been implementing these programme since the last three decades and a sizeable population of local variety of cattle yielding an average of (2.5-3 litres) of milk per day has been upgraded by cross breeding to yield on an average of (8-10 litres) of milk per day. Along with the cross breeding programme, the Department of AH&VS also implements scheme for improving the fodder production in the Territory and for better management of dairy cattle. One of the major constraints in dairy development in these Islands is import of good variety of high yielding milk producing cattle in these Islands due to the high cost of quarantine and transport. Hence, all efforts to increase milk production needs to be focussed on the existing population of breedable cross. The cross breeding programme using conventional semen straws, though effective in up-gradation of productivity, but also results in production of male calves. It is expected that out of the total number of calves born every year 50% will be male. The male calves are neglected and thus become stray and also subject of animal welfare issues. To address this problem, Govt. of India has introduced the ABIP using sex sorted semen. (Contd. on last page)

(Contd. from page 1) The sex sorted semen differs from conventional semen straws by the fact that it ensures 90% birth of female calves. Under this scheme, interested beneficiaries will have to register his/her name at the local Veterinary Institution and agree to bear the cost of frozen semen. The beneficiary will be eligible for subsidy and will have to pay Rs 250/- per semen straw. The cattle should be healthy and should not be more than its 3rd lactation. In case the animal does not conceive in the first attempt, farmers have the option to purchase the second sex-sorted straw. However, in the case the animal does not conceive even after two attempts, the amount deposited will be refunded but further insemination will be done using conventional semen straws only. If a male calf is born after two attempts, then the farmer will be entitled to get 50% refund. All information will be uploaded using Bharat Pashudhan App under the National Digital Livestock Mission. The farmer has the option to choose between three types of breed including Jersey Pure breed and Cross breed Sahiwal & Cross breed Gir. The Department aims to produce 2000 cross breed female calves in a span of 5 years. This will accelerate the induction of good variety of diary calves by the year 2027 when the calves start producing milk. It is estimated that about 300 such calves will be in production and contribute an additional 7 lakhs litres of milk annually, which will keep increasing in subsequent years. All the livestock owners of the UT of A&N Islands have been requested to take benefits of this scheme. 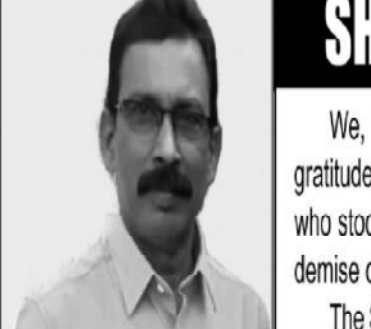
