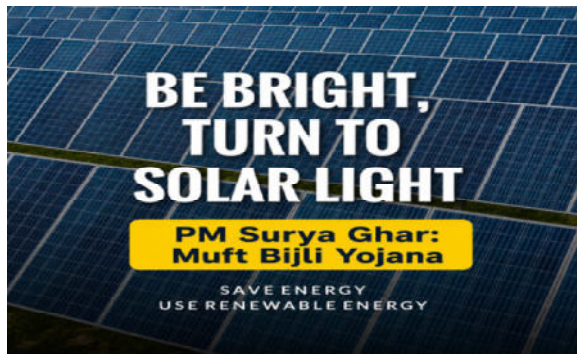

Historic national recognition for Nicobar Tribal Community: Ms. Shanta Cyntrick conferred Ustad Bismillah Khan Yuva Puraskar 2025

Car Nicobar, June 23

In a historic achievement for the Nicobar District and the Nicobar tribal community, Ms. Shanta Cyntrick of Tapoiming Village, Car Nicobar, has become the first artist from the Nicobar Tribal Community and the first individual from Nicobar District to receive the prestigious Ustad Bismillah Khan Yuva Puraskar, conferred by the Sangeet Natak Akademi, New Delhi, under the Ministry of Culture, Government of India.

The Ustad Bismillah Khan Yuva Puraskar is among the most prestigious national honours instituted by the Sangeet Natak Akademi to recognize outstanding young practitioners in the fields of Music, Dance, Theatre, Folk and



Tribal Arts, Puppetry, and other performing arts. Named after the legendary Shehnai maestro and Bharat Ratna awardee Ustad Bismillah Khan, the award seeks to encourage and honour young artists who have demonstrated exceptional talent, dedication, and contribution towards the preservation and promotion of India's diverse cultural traditions. The award carries a citation, an Angavastram, and a cash prize and is conferred by the

Chairman of the Sangeet Natak Akademi at a special national ceremony. The award has been announced by the Sangeet Natak Akademi for the year 2025 under the category of Folk Dance (Andaman & Nicobar Islands), recognizing Ms. Shanta Cyntrick's outstanding contribution towards the preservation, promotion and dissemination of traditional Nicobari folk dance.

This landmark recognition marks a



defining moment in the cultural history of the Nicobari tribal community. For the first time, a traditional folk artist from Nicobar District has been honoured with a national-level performing arts award from India's apex cultural institution, bringing national recognition to the rich indigenous cultural heritage of the Nicobarese people.

Ms. Shanta Cyntrick has been actively performing Nicobari Folk Dance since 2006 and has represented

the unique traditions of the Nicobari community at various prestigious platforms across the country. As a dedicated performer and troupe leader, she has played a pivotal role in preserving and promoting Nicobari cultural traditions among younger generations.

Govt. to provide financial support for opening Pashu Aushadhi Vikray Kendras

Sri Vijaya Puram, June 23

The Government of India has launched a new initiative under the Livestock Health and Disease Control Programme to improve animal healthcare by opening Pashu Aushadhi Vikray Kendras - dedicated stores that will sell quality generic veterinary medicines at affordable prices to livestock owners, especially in rural and remote areas.

These Kendras can be set up by registered Pradhan Mantri Kisan

Samridhi Kendras (PM-KSKs) and Cooperative Societies. To qualify, the applicant must have at least 120 square feet of space, employ a registered pharmacist (B. Pharma or D. Pharma), and possess a valid drug sale license from the State Drug Control Authority. Only one Kendra will be permitted per revenue block, with priority given to areas having large livestock populations.

The Government is offering attractive financial support to

encourage participation. Store operators will receive a 20% margin on the selling price of medicines (excluding tax). A one-time incentive of Rs.15 lakh is available for Kendras opened in aspirational districts, hilly areas, islands, and northeastern states. Additionally, a monthly incentive of up to Rs. 20,000 will be provided based on stock maintenance and sales performance.

SVPMC carries out major anti-encroachment drive in Mohanpura; stern warning issued to illegal vendors

Sri Vijaya Puram, June 23

In a decisive move to clear public pathways and ensure smooth traffic movement, the Sri Vijaya Puram Municipal Council (SVPMC) conducted a major anti-encroachment drive today morning. Supported closely by the A&N Police, the SVPMC enforcement team successfully evicted numerous unauthorized street vendors and removed illegal structures from several highly congested commercial zones, viz. near LIC Office; near Old Syndicate Bank; near Taxi Stand; near Bus Stand and Mohanpura Footpath.



These areas had seen a rise in unauthorized vendor setups, severely obstructing pedestrian movement on footpaths and causing traffic bottlenecks.

Strict warning against Non-Vending Zone violations:

The Council maintains a zero-tolerance policy toward commercial activities in non-vending



zones. **Public Space Preservation:**

Footpaths and roadsides are meant strictly for public convenience. Encroachments of any kind will not be tolerated.

Future Actions:

Regular monitoring will be conducted at these cleared

locations. Any repeat offenders or new unauthorized structures will face immediate eviction, seizure of goods, and legal action without further notice.

Call for compliance:

Vendors are directed to utilize only the designated vending zones by the

Council and to comply with municipal licensing norms.

Illegal sale of Giant Grouper Fish; Two arrested

Sri Vijaya Puram, June 23

Two accused were arrested from Bathubasti fish Market

based on charges of sale of Giant Grouper Fish (Epinephelus lanceolatus) which is Schedule-1 article as per the Wildlife Protection Act, 1972.

Subsequently, a wildlife offence case was registered under the relevant provisions of the Wildlife (Protection) Act, 1972. The accused persons were produced before the Hon'ble Chief Judicial Magistrate, Sri Vijaya Puram, and were remanded to judicial

custody. They were later released on bail as per the orders of the Hon'ble Court. The Deputy Conservator of Forests, Wildlife Division, Haddo, appeals to the general public to provide information regarding any illegal hunting, possession, transportation, trade, or other suspicious activities involving wildlife and protected species. Such information may be shared with the Wildlife Control Room at 03192-245229, a press release from DCF (WL) said.
