Transport Department urges motor vehicle owners to carry valid Pollution Under Control Certificate

The Transport Department has informed the general public and all Government Departments that as per the provisions of Rule 115(7) of the Central Motor Vehicles Rules, 1989 every motor vehicle including Government owned vehicles is required to

carry a valid Pollution Under Control (PUC) Certificate.

The PUC Certificate certifies that the vehicle's emissions are within the permissible limits prescribed under law. Possession of a valid PUC Certificate is a statutory requirement and an essential measure to ensure

DSS announces special provision for two-wheelers accompanying ambulance or Mortuary Van on Phoenix Bay - Bambooflat vehicle ferry route

Sri Vijaya Puram, Nov. 23

The Directorate of Shipping Services has always remained committed to the welfare and convenience of the island residents, especially in matters of health, emergency and community well-being.

In response to requests received from the residents of Bambooflat and surrounding areas, and after careful examination of the practical difficulties faced by families during medical emergencies and in moments of bereavement, the Directorate has taken a considerate and compassionate decision. With immediate effect, maximum of two (02) two-wheelers along

with attendants accompanying an Ambulance carrying referred Patients or Mortuary Van carrying mortal remains shall be permitted to embark the vehicle ferry on priority, from either side-Bambooflat or Phoenix Bay, during scheduled trips. Night standby vessel facility at Bambooflat will be utilised only for transporting ambulance with patient referred by hospitals. This relaxation is being extended purely on humanitarian grounds, recognising the emotional distress faced by families and the need for timely movement during such sensitive circumstances. Plying of Autorickshaw without switching on fare meters & charging exorbitant fares will be viewed seriously: STA

The State Transport Authority (STA) has been receiving complaints from general public regarding plying of Autorickshaw without putting/switching on the fare meters and charging exorbitant fares by the drivers. Section 74 (2)(viii) & Section 96(xx) of the MV Act 1988

mandates that in case of Autorickshaw/Taxi, a fare meter shall be fitted and maintained in proper working order. This has been informed to the general public as well as Autorickshaw owners/drivers through releases in local media on many previous occasions.

The Autorickshaw Permit holders have

been informed once again to refrain from such practices as repeated violations will warrant actions for cancellation of Permits. Enforcement drives will be carried out to ensure the strict compliance of the permit conditions.

Training prog. on Adult BCG Vaccination for Medical Officers and Health Staff of Nicobar District held

Car Nicobar, Nov. 23

A two-day training programme on Adult BCG Vaccination for Medical Officers and Health Staff of Nicobar District was held on Nov. 19 & 20, 2025 at the Directorate of Health Services.

The programme was jointly organized by the Central TB Division (MoHFW, GoI), the State TB Cell, and the State Immunization Division of A&N Islands.

The training was conducted in hybrid mode, with technical sessions delivered virtually by experts from the Central TB Division and in-person facilitation by State-level trainers. The inaugural session was addressed by senior officials including Dr.



Urvashi B. Singh, Deputy Director General (TB), Dr. Veena Dhawan, Additional Commissioner, CTD, and Dr. Suja Antony, Director of Health Services. Dr. Urvashi B. Singh emphasized the significance of Adult BCG Vaccination in reducing TB incidence, while Dr. P. Lal, State TB Officer, provided an overview of the TB situation in the islands and the rationale for launching the pilot in Nicobar.

Participants were trained on key operational and technical components such as beneficiary identification, micro-planning, documentation, reporting, injection techniques, cold-chain management, AEFI preparedness, and biomedical waste handling. A total of 06 Medical Officers and 13 Health Staff participated from Nicobar District, a communication from State Health Society said.

reduction of vehicular pollution and protection of environmental quality.

Driving a vehicle without a valid PUC Certificate constitutes a violation under Section 190(2) of the Motor Vehicles Act, 1988 and shall attract penalties as prescribed.

All concerned have been requested to ensure compliance to help reduce air pollution and maintain a clean environment in the Islands, a press release from Transport Department said.

vide Notification dated 11-01-2023 for A & N Islands and the Auto-rickshaw permit holder /drivers were asked to get their fare meter calibrated and stamped as per the notified Fares from Legal Metrology, Directorate of Civil Supplies & Consumer Affairs and also the Autorickshaw owners were asked to display the fare chart issued by STA in their Autorickshaw.

Fare should be charged strictly as per the Fare Meter. Exorbitant or Overcharging of Auto fares, refusal to ply autorickshaw as per the request of passengers and misbehavior with passengers shall be viewed seriously. Enforcement drives would be conducted and actions would be initiated against those Autorickshaw owners found not exhibiting the fare chart or driving with defective/faulty & not calibrated & unstamped Fare meters.


