Lt. Governor revises Minimum Rates of Wages across 6 Schedules of Employment Revised rates of Minimum Wages to come into effect from Jan. 1

The Lieutenant Governor, Andaman & Nicobar Islands has revised the Minimum Rates of Wages across 6 Schedules of Employment in addition to Govt. Departments/Offices/ Industrial Establishments as mandated under the

provisions of Minimum Wages Act, 1948 in the UT of A&N Islands w.e.f. 1st January, 2025. The Revised Rates of Minimum Wages are as under:-

Category of employee	Minimum wage per day
Unskilled	Rs. 641.00
Semi-Skilled/Unskilled Supervisory	Rs. 722.00
Skilled/Clerical	Rs. 845.00
Highly Skilled	Rs. 928.00

ANPCC urges general public & industrial stakeholders to responsibly manage and dispose of waste generated in domestic and industrial setups

Sri Vijaya Puram, Dec. 24

The Andaman and Nicobar Pollution Control Committee (ANPCC), Department of Science and Technology, Andaman and Nicobar Administration has urged the general public and industrial stakeholders to responsibly manage and dispose of waste generated in domestic and industrial setups in accordance with the Municipal Solid Waste Management Rules, 2016. Effective waste management is critical to maintaining the

pristine environment of the Andaman and Nicobar Islands and ensuring the health and well-being of the community.

For domestic setups, residents have been requested to segregate waste at the source and hand over to the Municipal authorities for proper processing and disposal. Industries operating in the region have been mandated to follow best practices for waste management by implementing waste segregation, recycling and safe disposal protocols. All industrial

units must ensure compliance with environmental regulations, including obtaining necessary consents from ANPCC for waste generation and treatment. Hazardous industrial waste should be disposed of through authorized agencies and untreated waste water must not be discharged into the environment. Industries have also been encouraged to adopt cleaner technologies and reduce waste generation at the source. The public have been

urged to avoid open dumping and burning of waste, as these practices can lead to air, water and soil pollution.

In light of the growing concern regarding cigarette and bidi butt litter, ANPCC also highlights the importance of their proper disposal. Cigarette and bidi butts, though small in size, pose a significant environmental threat due to their non-biodegradable components and toxic chemicals. Local authorities have been

ICC Announces Fixtures for 2025 Men's Champions Trophy: India to take on Pakistan on Feb 23

Dubai, Dec. 24

The International Cricket Council (ICC) today announced the fixtures for the ICC Men's Champions Trophy 2025. The championship will take place from the 19th of February to the 9th of March, next year. Defending champions Pakistan will host their first global cricket tournament since 1996, alongside the UAE as the neutral venue.

India is in group A, along with Bangladesh, New Zealand and Pakistan. Group B

consists of Afghanistan, Australia, England and South Africa. The Champions Trophy begins with hosts Pakistan facing New Zealand on 19th February in Karachi. India will play its first match against Bangladesh on 20th February in Dubai. On 23rd February, India will clash against arch-rivals Pakistan in Dubai.

The stadiums in Lahore, Karachi, and Rawalpindi will host the matches in Pakistan, while Dubai will host the matches in the UAE.

The first semi-final is scheduled to be played on 4th March in Dubai, and the second semi-final and final are slated for 5th March and 9th of March in Lahore. However, if India qualifies for the semifinal or final, then the matches will be played in Dubai. Moreover, the Indian team is not travelling to Pakistan due to security concerns and will play all of its matches in Dubai. ICC chairperson, Shri Jay Shah said, ICC is delighted to release the schedule for the Men's Champions Trophy 2025, marking the tournament's much-anticipated return since 2017.

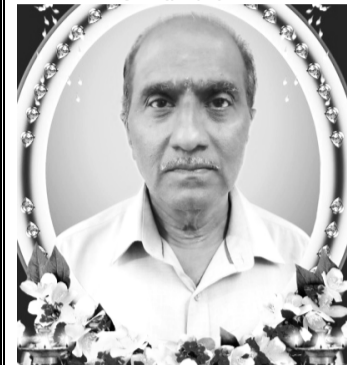

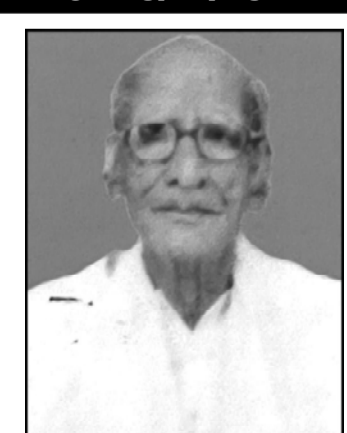
