a preventive measure to stop the spread of Corona Virus (COVID-19) till further orders.

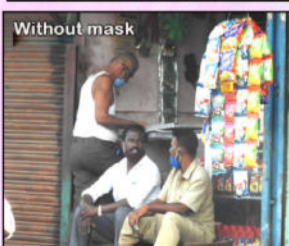

He urged the younger people to wear mask, sanitize their hands and maintain social distancing rated as key measures to restrict the spread of the virus. The Director (IP&T), Shri Alok Kumar, Deputy Director, IP, Shri RS Meena also attended the press conference.

**Two eco-huts inaugurated under MGNREGA at Arong Village Car Nicobar**

The Minister said, India is working to eliminate malaria nationally and to contribute to improved health, quality of life and alleviation of poverty. He said, the World Malaria Day celebrations also provide inspiration to the global community and all affected countries that are working to root out this disease.

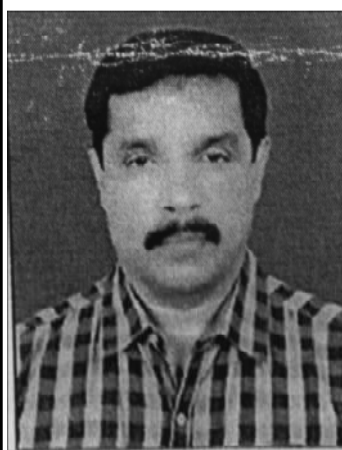

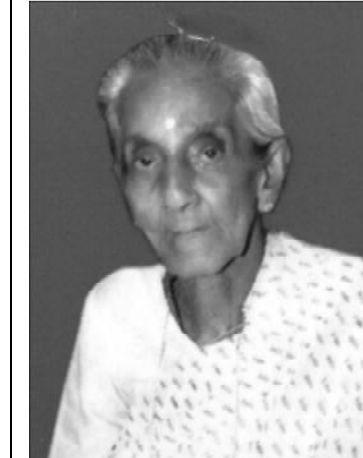
