

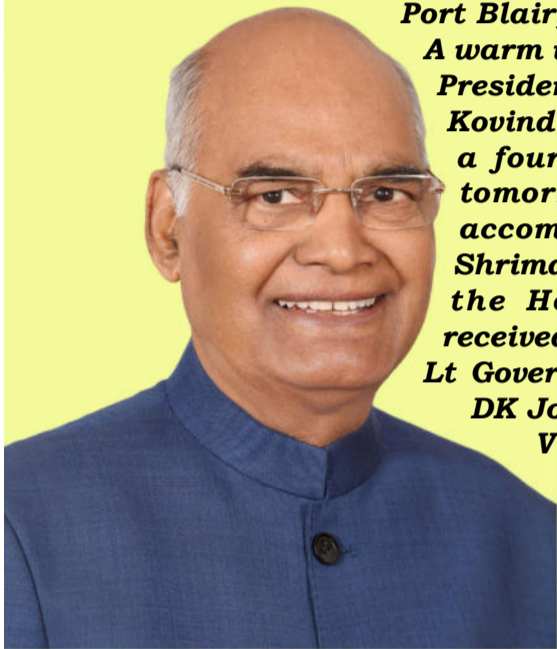

## Hon'ble President of India Shri Ram Nath Kovind to arrive on a four-day visit to A&N Islands today

### To visit National Memorial Cellular Jail and pay homage to freedom fighters at Martyrs' Column



Port Blair, Feb. 25

A warm welcome awaits the Hon'ble President of India, Shri Ram Nath Kovind who will be arriving here on a four-day visit to A&N Islands tomorrow (Feb. 26). He will be accompanied by the First Lady Shrimati Savita Kovind. On arrival, the Hon'ble President will be received at Airport by the Hon'ble Lt Governor, A&N Islands, Admiral DK Joshi, PVSM, AVSM, YSM, NM, VSM (Retd.), Member of Parliament, Shri Kuldeep Rai Sharma, Commander in Chief, A&N Command, Lt Gen Manoj Pande, Chief Secretary, A&N Administration, Shri

Chetan B. Sanghi, DGP, Shri Satyendra Garg and Senior Officers of A&N Administration.

Later in the evening, the Hon'ble President will visit the National Memorial Cellular Jail and lay wreath at the Martyrs' Column and visit the Jail Complex and Museum. He will also witness Light & Sound Show at Cellular Jail.

On Feb. 27, the Hon'ble President will depart for Swaraj Dweep in the morning. On Feb. 28, the Hon'ble President will be briefed and updated on ANC activities at Radhanagar Beach. He will also witness the operational demonstration planned by Andaman Nicobar Command. The Hon'ble President will also visit Radhanagar Beach.

On completion of the visit, on March 1, the Hon'ble President will depart for New Delhi in the evening.

### Profile of Hon'ble President

Shri Ram Nath Kovind was sworn in as the 14<sup>th</sup> President of India on 25 July, 2017. A lawyer by profession, he had been the Governor of the State of Bihar before he took over the highest constitutional office. Shri Kovind brings to the office a rich experience of working across the spectrum of the republic, from the grassroots to the apex court and parliament. He has been an ardent champion of equality in society and integrity in public life.

#### Early Life and Education

Shri Kovind was born on 1<sup>st</sup> October 1945 at village Paraunkh in Kanpur district of the State of Uttar Pradesh. Coming from a family of modest means, his beginning was humble. He attended school and college in Kanpur. He first studied commerce for Bachelors and then attained his Law degree from Kanpur University.

#### Professional Career

Shri Kovind enrolled as an advocate with the Bar Council of Delhi in 1971. He served as Counsel of the Union Government in the Delhi High Court from 1977 to 1979. In 1978 he rose to become an Advocate-on-Record with the Supreme Court of India. From 1980 to 1993, he was Standing Counsel for the Union Government in the Supreme Court. Under the Free Legal Aid Society of New Delhi, he also provided pro-bono aid to weaker sections of society, especially women and the poor.

#### Public Life and Parliament

Shri Kovind was elected as a member of the Rajya Sabha, the Upper House of Parliament, from Uttar Pradesh effective from April 1994. He served two consecutive terms of six years each till March 2006. Serving on numerous Parliamentary Committees, he gathered in-depth experience in governance. He addressed the United Nations General Assembly on 22 October 2003 as a member of the Indian delegation.

Shri Kovind is an ardent advocate of education as a tool for social empowerment. He actively supports greater participation of women in nation-building and has been consistently calling for the society to create more opportunities for the deprived sections, especially the disabled and the orphans. He served as a Member on the Board of Management of the Dr. B. R. Ambedkar University, Lucknow, and also as a Member on the Board of Governors of the Indian Institute of Management, Kolkata. President Kovind's vision is to contribute towards "creating that optimal partnership between citizens and their representatives in the Government".

#### Governorship of Bihar

Shri Kovind was appointed Governor of the State of Bihar on 8 August 2015. His term as Governor received all-round appreciation for upholding the values of the Constitution. He, in his capacity as Chancellor, introduced several reforms and modern technology in the working of State Universities and brought transparency in the appointment of Vice-Chancellors. He earned respect from leaders of all political parties for his statesmanship, sagacity and adhering to democratic ethos.

#### Ascent to Presidency

Shri Kovind's achievements as a Governor burnished his credentials as a candidate for the Presidency in 2017. After his election to the highest constitutional office, he has discharged his duties as the first citizen of India with foresight and humility. He has paid State Visits to 28 countries till December 2019 enhancing India's global outreach and footprint. On these State Visits, President Kovind conveyed India's timeless message of peace, progress and harmony. As the President of India, he has received the highest State honours from six countries, namely Madagascar, Equatorial Guinea, Eswatini, Croatia, Bolivia and Republic of Guinea.

As the Supreme Commander of the Armed Forces of India, in May 2018 President Kovind made a historic visit to the troops deployed at 'Kumar Post' in Siachen, the highest battlefield in the world.

He is an avid reader and has keen interest in books on politics and social change, law, history and spirituality.

#### Personal Life

Shri Kovind married Shrimati Savita Kovind in May 1974. They have a son and a daughter.

In A&N Islands around 2,06,961 lakh people have created Digital Health Identity Cards as on date under the Govt.'s National Digital Health Mission.

**India crush England by 10 wickets in 3<sup>rd</sup> Cricket Test in Ahmedabad**



Ahmedabad, Feb. 25 India crushed England by 10 wickets on day two in the third Test at Narendra Modi Stadium in Ahmedabad. India are now leading the four-match Test series 2-1. India achieved the victory with a huge six hit by Rohit Sharma. Without losing any wicket in their second innings on day two of the match this evening, Openers Rohit Sharma and

Shubman Gill led India to this remarkable victory. Earlier, England were bundled out for 81 runs in their second innings. This is the lowest ever Test score of England against India. Local boy Axar Patel claimed five wickets while Ravichandran Ashwin bagged four and Washington Sundar got one. Ashwin has become the fastest Indian to pick 400 wickets. India were all out for 145 runs in their

first innings this afternoon. For the hosts, Rohit Sharma was the highest scorer with 66 runs. For the visitors, Joe Root claimed five wickets while Jack Leach bagged four and Jofra Archer got one. England were all out for 112 in their first innings yesterday. India's chances of earning a World Test Championship final spot depends upon the outcome of the remaining test.

**Centre announces guidelines & digital media ethics code for OTT, online streaming & social media platforms**

The Centre today announced guidelines and digital media ethics code for Over The Top (OTT), online streaming and social media platforms. Briefing media in New Delhi, Communication and IT Minister, Shri Ravi Shankar Prasad said, under the guidelines the social media platforms have to appoint a Chief Compliance Officer of complaints, Nodal Contact person and a Resident Grievance Officer. He said, now the social media platforms will be required to disclose the first originator of the mischievous contents. He said, various concerns over rampant abuse of social media have come to the Government.

Information and Broadcasting Minister, Shri Prakash Javadekar announced three-tier mechanism for regulation of OTT and Digital media platforms.

Creation of Health ID will enable people to keep a track of their health data and share it only with verified doctors or health providers when needed after an informed consent. The Health ID is designed with highest standards of security and privacy and will enable inclusive access to all health services. The Islanders can create their Health ID online by visiting the site <https://healthid.ndhm.gov.in/>.

The Health ID can be created using Aadhaar number option or Mobile number to receive their OTP and filling up basic information which includes name, sex, date of birth and mobile number. The State Health Agency is the implementing agency for NDHM in these Islands. For any technical help, general public may contact State Health Agency over phone number 03192-231993.

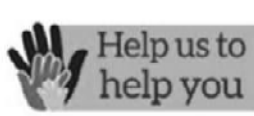
