## Nine Indian Islands chosen for Singapore-like tourism boost

## Smith, Ross, Avis & Long Islands from Andaman & Nicobar Islands selected

New Delhi, Sept 26  
The azure seas and white coral beaches of Lakshadweep and the tropical lushness of Andaman & Nicobar have been identified as tourism growth zones with nine islands selected as part of a Niti Aayog master plan. The islands are being seen as drivers of tourism and sustainable economic development on the lines of countries like Singapore that use water parks and natural resources to promote tourism, overcoming limited land areas while being mindful of conservation. Given ecological sensitivity of the islands, capacities will be limited,



though current options for tourists will be improved. Options in Lakshadweep, which is seen as a high end tourism destination, are limited compared to Andaman & Nicobar. Among the islands identified are Smith Island,

Ross Island, Avis Island and Long Island in Andaman & Nicobar. In the Lakshadweep, Bangaram, Thinnakara, Suheli, Cheriya and Minicoy are among those slotted for development. There are tourist facilities

in Lakshadweep, but these are limited to Bangaram and a few other islands. "We are working on a master plan for sustainable development of the nine islands," said Niti Aayog CEO Shri Amitabh Kant. (Contd. on last page)

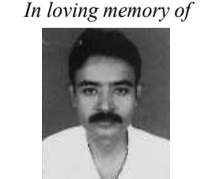

# Ashwin's six-wicket haul gives India a massive win in its 500th Test

Kanpur, Sept 26

A six-wicket haul by R. Ashwin propelled India to a massive win in its 500th Test on Monday, giving the host team a 1-0 lead up in the three Test series against New Zealand. New Zealand had six wickets in hand when they started out on the final day of the Test, needing 341 runs to close the deal.

After reducing the Kiwis to 205-7 at lunch, India claimed the three remaining wickets to clinch the opening Test on the fifth day here.

Ravindra Jadeja is the Man of the Match, while Ashwin bagged a total of 10 wickets in both innings, becoming the fastest Indian to scalp 200 wickets.



Earlier, paceman Mohammed Shami struck twice after Luke Ronchi gifted away his wicket, reducing New Zealand to 205 for seven at lunch on the fifth day, on Monday. Overnight Kiwi batsmen Ronchi (80) and Mitchell Santner (56 batting) frustrated the Indian bowlers for about 20 overs, adding 65 runs to their

overnight total of 93-4 before India struck thrice to position themselves for a massive win in their 500th cricket Test. It was Ronchi, who handed India the opening when he went for a sweep slog against Jadeja and handed a top-edge to Aswhin. The mistake ended his 102-run stand with Santner, who scored

his maiden Test fifty.

Both Jadeja and Ashwin flighted the ball through the air opting full length most of the time. Ronchi comfortably drove Jadeja in the cover region and Ashwin did not mind using his feet.

The two Kiwi batsmen soon started to score at a brisk pace with Santner even slog-sweeping Jadeja for a huge six over mid-wicket.

After persisting with Jadeja and Ashwin for 12 overs, India captain Virat Kohli asked paceman Umesh Yadav to bowl.

They frustrated India for the first hour and the hosts struck in the first over after drinks break when Ronchi was guilty of slugging a Jadeja ball.

# Kabaddi World Cup to begin from October 7



New Delhi, Sept 26

Seven-time champions and favourites India will face South Korea in the opening match of the 2016 Kabbadi World Cup, to be held in Ahmedabad from October 7 to 22.

Besides hosts India, other participating nations in the tournament are USA, England, Australia, Iran, Poland, Thailand, Bangladesh, South Korea, Japan, Argentina and

Kenya.

The 12 teams have been divided in two groups of six each. While Group A consists of India, Bangladesh, South Korea, Australia, England and Argentina, Group B will have Iran, Thailand, Japan, USA, Poland and Kenya.

The semi-finals of the tournament will be held on October 21 with the summit clash slated for the next day.

# Sania Mirza continues to dominate doubles ranking

New Delhi, Sept 26

India's Sania Mirza maintained her numero uno position in the latest WTA women's doubles ranking following her recent victory in the Pan Pacific Open in Tokyo, partnering Barbora Strycova of Czech Republic. Sania continued to be world number one in doubles but only five points separate her from her former partner Martina Hingis.

Among Indian men, Sakth Myneni is the highest place singles player. Myneni, who entered the main draw of the US Open after winning three rounds in the Qualifying event, dropped a rung to be placed



138th in the list. Second highest-ranked Indian singles player Ramkumar Ramanathan, who featured in the recent Davis Cup tie against Spain, plummeted 10 places to 229, while out of action Yuki

Bhambri dropped a whopping 62 places to be placed 282nd in the chart. In the men's doubles chart, Rohan Bopanna is static at 18th, while veteran Leander Paes has moved four places to 60th.

# India's Polar Satellite Launch Vehicle PSLV-C35 creates history

Sriharikota, Sept 26

India's Polar Satellite Launch Vehicle PSLV-C35 created history by launching multiple satellites in two different orbits in space in a single mission this morning. The launch vehicle lifted off with eight satellites on board including the primary payload SCATSAT-1 of India from the Satish Dhawan Space Centre, Sriharikota. In its longest ever flight, the rocket weighing 320 ton during lift off put all the satellites successfully in their intended initial orbits in over 2 hours 15 minutes. This is the 37th flight of the PSLV and the 15th journey in its extended version with solid strap on motors to give it the required additional thrust. This month, this is the second launch for the ISRO.

The ISRO Chairperson AS Kiran Kumar in his congratulatory message after the successful mission said it is a landmark day for the ISRO. The SCATSAT-1 is a continuity mission for the much acclaimed Oceansat-2 that has completed its operational life. Its accurate data is credited with forecasting precisely about the landfall of the Cyclone Phailin in October 2013 helping in taking sufficient precautionary measures and thereby reducing loss of lives significantly. Its successor, the SCATSAT-1, with the expected life period of five years, has more sophisticated features to generate data on wind

vectors. The data could be correlated with the inputs of other meteorological satellites to arrive at an accurate picture of emerging weather situations. Algeria's three payloads Alsat-1B, 2B and 1N are meant for earth observation, remote sensing and technology demonstration. The micro-satellite Pathfinder-1 is an US payload designed for commercial high resolution imaging services. The Canadian payload NLS-19 has been developed by students for experimenting on reduction of space debris.

The inclusion of Little Andaman, the biggest island in the chain with an area of 734.34 sqkm, almost equal in size to Singapore, came in for detailed discussion. According to Shri Vivek Rae, former Petroleum Secretary who served as Chief Secretary of A&N Islands, Singapore has earmarked 10% of its area for parks and natural resources and is also ranked fourth globally in the environment performance index. In contrast 90% of the Andaman & Nicobar Islands are notified as reserved or deemed forest with only 6% of land available for development. The plan has gained momentum after a recent PMO announcement that the islands will be selected for infrastructure, tourism, agriculture (organic and fisheries) and renewable energy development.
