



3,52,991 fresh cases of COVID-19 & 2812 deaths reported in the country

New Delhi, April 26

A total of 3,52,991 new cases have been reported in the country in the past 24 hours taking the cumulative positive cases to over One crore 73 lakh. The Health Ministry said 2812 deaths have also been reported during the last 24 hour taking the toll to over one lakh 95 thousand across the country.

The country's COVID-19 recovery rate is at 82.62 per cent with the recovery of more than two lakh 19 thousand patients in the last 24 hours. The Ministry said that more than one crore 43 lakh patients have already recovered from this disease. Presently, the total number of active cases in the country is over 28 lakh 13 thousand which comprises of 16.25 per cent of total positive cases. (Source: india.gov.in)

movement of prisoners from one barrack to another to attend various reformatory activities/trainings, food etc. Further, it has been directed to distribute all the meals in the prisoners living barrack itself. Directions have also been given to issue PPE kits to all the Medical staff and security staff working in COVID Isolation Ward (B. No. 7). The Chief Medical Officer of Jail Hospital has been directed to check SPO2, Pulse rate of affected prisoners twice in a day and submit the report to the concerned authorities for proper action. Further, it has also been directed to ensure sufficient stocks of required medicines, oxygen cylinders, sanitizers, face mask, gloves, oxy meter etc. to tackle the unforeseen situations, if any. Directions have also been given to enforce strict protocol/SOPs issued by the Department and A & N Administration.

Similarly, to contain the spread of the virus in Prisons, the 'Physical Mulakat' of the prisoners have been suspended with immediate effect. Further, telephone facilities have been liberalized and the Jail Officers have been directed to inform the prisoners to contact their lawyers/families through the telephone facilities.

fight yesterday. Of this, 9 passengers were tested positive, despite the fact they had RTPCR negative report with them. It is a matter of great concern that flight passengers are tested positive on a daily basis, the Secretary added.

The Secretary said, surveillance team monitoring different areas have observed that people are not adhering to the COVID protocols despite repeated appeals made by the A&N Administration, religious leaders through All India Radio and regular publications in print media.

As a preventive measure to contain spread of COVID-19, instructions have been issued regarding staggering of the timings of the office staff of departments of A&N Administration, the Secretary said. He said, the Departments have started functioning with staggered timings from today (April, 26). Maintaining social distancing and avoiding unnecessary movement in market places has to be practiced by every individual in letter and spirit to stop the spread of corona virus, the Secretary said. Self safety is the only mantra for safety of individuals from this virus, he added.

The Secretary informed that altogether 1322 eligible persons above 45 were vaccinated till 1 pm on April 26.

The Deputy Director GB Pant Hospital, Dr. Amitabha De informed that there is sufficient stock of medicines and oxygen cylinders in A&N Islands. More cylinders will be received in a week's time from Govt. of India. He said that proposal for setting up one oxygen plant in South Andaman district has been approved.

The Director (IP&T), Shri Alok Kumar and Deputy Director, IP, Shri RS Meena also attended the press conference.
