
Andaman and Nicobar government to study ecological impact as tourist inflow rises, plan new islands

Andaman and Nicobar is carefully opening new islands to tourists. The government is balancing increased visitor numbers with ecosystem protection. New tourism experiences like birdwatching and astro-tourism are being developed. The Union Territory aims to preserve its natural beauty while welcoming more visitors. Plans include training local guides and designating astro-tourism spots.

The Andaman and Nicobar government is analysing the impact of opening new islands and the rising influx of tourists in the archipelago to ensure the preservation of the ecosystem while ensuring more islands are opened in a graded manner, officials said.

The island Union Territory known for its pristine Islands, told PTI. beaches and mangrove kayaking tours, has witnessed a significant jump in domestic tourism associated with the rising number of tourists, she since pre-COVID years.

A comprehensive Group Personal Accident Insurance Scheme, 'KESRI', is also being implemented by the Coconut Development Board in association with insurance companies for Coconut Tree Climbers, Neera Tappers, Hybridization Workers and Coconut Labourers in the A&N Islands.

Under this scheme, coconut labourers working in coconut farms/plantations or in registered small-scale coconut-based industries can avail insurance coverage against all accidents and accident-related hospital expenses. The annual premium of Rs. 956 is shared between the Board and the beneficiary in an 85:15 ratio. The Board pays Rs. 813, and the beneficiary pays Rs. 143 only, for a maximum insurance coverage of Rs. 7 lakh.




