President and Vice President hold discussions with Governors, LGs and Administrators of States & UTs on COVID-19 response

Lt. Governor, A&N Islands also participates in the video-conference

New Delhi, Mar 27
 The President, Shri Ram Nath Kovind, along with the Vice President, Shri M. Venkaiah Naidu, today held a video-conference with all Governors, Lieutenant Governors and Administrators of all States and Union Territories to find ways to complement the efforts of the Government of India and the State Governments in meeting the challenges arising from the outbreak of COVID-19. Preparedness/measures regarding COVID-19 were reviewed during this video-conference.



The Lt. Governor, A&N Islands and Vice-Chairman, Islands Development Agency, Admiral D K Joshi, PVSM, AVSM, YSM, NM, VSM (Retd.) also participated in the video conferencing. The President began the conference by exhorting to the collective strength of the society and urged Governors, LGs and Administrators to mobilize volunteers of Indian Red Cross Society, voluntary and religious organizations to contain the menace at the earliest. President Shri Kovind and Vice President Shri Naidu expressed hope that the Indian society's

inherent strength of "sharing and caring" and the government's measures would mitigate the sufferings of the most vulnerable sections of the society, particularly the workers of the unorganised sectors and the destitute. The video conference was conducted by the Vice President and it brought out the best practices initiated by various States to mitigate the people's plight while enforcing the lock down in the country. The discussions related to the status of COVID-19 in the States, the role of the Red Cross with focus on vulnerable sections, and the role of civil society/

voluntary organisations in complementing the efforts of the Union and State governments to contain the spread of the Novel Coronavirus, especially with the lockdown and other challenges emerging from the evolving situation. While summing up the conference, President Shri Kovind urged everyone to hold regular stock-taking with the state government and make contributions in a way that the battle against the Coronavirus could be taken to a logical end. He also said that based on these experiences, the best practices can be emulated in other parts of the country.

RMRC-ICMR confirms 5 more cases as COVID-19 positive; total 6 positive cases in A&N Islands

Health parameters of all confirmed cases normal Admn. makes elaborate arrangements for quarantine of suspicious persons One hotel of 42 rooms designated as COVID-19 hospital in Port Blair

Port Blair, Mar 27
 The designated laboratory for COVID-19 in A&N Islands, RMRC-ICMR, Dollygunj has confirmed 05 (Five) more cases as positive for Novel Corona Virus Disease (COVID-19) in Andaman & Nicobar Islands. The persons who are tested positive are also part of the same group which came from Vistara flight from Delhi and Indigo flight from Chennai on 24.03.2020. The Administration has already started the process of contact tracing which interalia includes of co-passengers of the flights, the police officials and the medical team who screened them at airport and also the staff of ambulance which transported them to G B Pant Hospital isolation facility. Yesterday the Administration submitted 24 suspected cases for testing, out of which 05 (Five) cases were reported as positive. Therefore, out of 60 suspected samples, only 06 cases reported positive. It is pertinent to mention that these 06 (Six) cases did not intermingle with local people and were transported directly from Airport to Quarantine/Isolation facility at G B Pant Hospital. The Health parameters of all the confirmed

cases are normal and they are responding to all queries being asked by the contact tracing team constituted. It is pertinent to mention that Deputy Commissioner (SA) has constituted 75 teams for contact tracing from Rural Development Departments, Panchayati Raj and Revenue Department who are covering 25 houses each assigned to them for contact tracing. Similar committees have been constituted in North & Middle Andaman and Car Nicobar Districts. The Administration has also made elaborate arrangements for isolation/quarantine for persons who are suspicious of having infection of COVID-19. Isolation wards have been setup at GB Pant Hospital (48 Beds), INHS Dhanvantri (15 Beds) and PHC Chouldari (15 beds) for treatment. Isolation/quarantine facilities have been created in Govt. Guest Houses and private hotels for asymptomatic suspicious cases. At present, there are 280 rooms with attached bathrooms for asymptomatic suspicious cases. One Hotel of 42 rooms is designated as COVID-19 hospital for symptomatic suspicious cases in Port Blair.

Administration streamlines doorstep delivery of essential commodities in Isles

Number of retail shops in each PBMC Ward increased

Port Blair, Mar 27
 After the lockdown announcement, on a short notice, a mechanism was worked out by the A&N Administration for doorstep delivery of essential items. Due to curbs on free movement of labour and vehicles, the supply chain from

wholesalers and retailers to wholesalers and retailers was severely impacted and doorstep delivery mechanism was faced with serious challenges. With due permissions, carrying

essential items started moving and stocks with the wholesalers and retailers increased. The number of retail shops identified for doorstep delivery in each ward of PBMC has been increased from 1 to 2 to cater to the high demands of the people. Besides this, vegetable shops are also identified for doorstep delivery. Vegetable vendors can deliver to neighbouring wards also to service all wards completely. People can place their demands to the local public representatives or designated Govt. staff or the retailers concerned.

MP sanctions Rs. 1 Cr. under MPLAD fund towards purchase of essential items to combat COVID-19 in Isles

Port Blair, Mar 27
 The Member of Parliament, A&N Islands, Shri Kuldeep Rai Sharma has sanctioned Rs.1,00,00,000/- under MPLAD fund towards purchase of essential items to combat COVID-19 in A&N Islands. This fund can be utilized for the

purchase of essential items viz. infrared thermometer, thermal imaging scanner, setting up of isolation/quarantine ward with desired facilities, purchase of mask, sanitizer, gloves and personal protection equipments besides any other facilities recommended by the

Ministry of Health and Family Welfare, Govt. of India and Directorate of Health Services, A&N Administration, mentioned the MP in his letter addressed to the Deputy Commissioner, South Andaman in this regard, a copy of which has been released to the press.

Doorstep delivery of essential commodities in N&M Andaman

Mayabunder, Mar 27
 As a mark of precaution in the wake of the threat from COVID-19, the District Administration, North & Middle Andaman is taking initiatives to supply essential commodities to doorstep of the general public. The requirement of the household may be conveyed to the respective vendors through sms, whatsapp, and phone calls at the numbers listed here. The groceries shall be delivered at doorsteps by the respective vendors within 24 hours, subject to their availability. The service has started from today (March 27). The whole distribution process shall be supervised by the District Administration to make it seamless and hassle free. People are strictly advised to remain confined to their homes and do not come out whatsoever for collecting their ration. Shop vendors and the delivery boys have been advised to maintain social distancing while supplying the items and use

prescribed personal hygiene methods to check the spread of virus. Movement of Govt. employees Transport Department provides services; additional trips from today

 The Transport Department, A&N Administration is providing the required transport service with its fleet of buses for the movement of employees of various Departments engaged in discharging the essential service. For this, connectivity is

provided from places like Ferrargunj, Chidiyatapu, Wandoor, Guptapara, Tirur, Tushnabad, Chouldari, Shadipur, B r o k s h a b a d , Chakargaon, Garacharama, Manjeri, Calicut, Shadipur, Dairy Farm etc. Timings have been set in such manner that suits the functioning of all essential

Departments. These services are available from 4.30 AM and continue till 9 PM every day. Besides this, dedicated buses have been provided for various Departments so as to transport their employees as per the requirement. However to accommodate more employees, additional trips and services will be introduced from 28.3.2020.
