

Lok Sabha passes Public Examinations (Prevention of Unfair Means) Amendment Bill, 2026

New Delhi, July 29

The Lok Sabha today passed the Public Examinations (Prevention of Unfair Means) Amendment Bill, 2026. The Bill seeks to amend the Public Examinations (Prevention of Unfair Means) Act, 2024. The legislation incorporates several significant provisions, including stringent penalties such as imprisonment for up to ten years, fines of up to ten crore rupees, and the seizure of the properties of convicted offenders. To ensure the expeditious disposal of cases, the legislation mandates that every State Government and



Union Territory further provides that Administration investigations into offences must be completed within two months from the date

the information is recorded at the police station. The trials must be concluded within three months from the filing of the chargesheet.

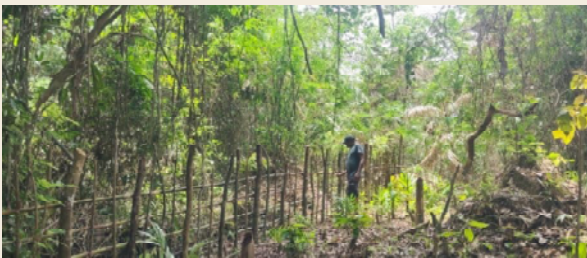
Replying to the discussion on the bill, Minister of State for Personnel, Public Grievances and Pensions, Dr. Jitendra Singh said, the amendment in the bill has been brought to make the law more stringent and ensure speedy justice. He said, the new Bill is a reaffirmation of the Government's commitment to safeguard the welfare of students and youth.

District Administration (SA) takes swift action against fresh encroachment at Mathura village under Ferrargunj Tehsil

Sri Vijaya Puram, July 29

The District Administration, South Andaman, in its continued commitment to safeguard Government land and uphold the rule of law, has taken prompt and decisive action against fresh encroachments at Mathura Village under Ferrargunj Tehsil.

During a recent inspection conducted by the Revenue authorities, with the assistance of line Departments, Police authorities and the active support of the Panchayati Raj Institutions (PRIs), fresh encroachments were detected on



Government land comprising approximately 40,000 Square meter of grazing land and 10,000 square meter of land earmarked as a playground at Mathura Village. The encroachments had been carried out by erecting railings and planting saplings in an unauthorized manner.

Acting swiftly, the Revenue authorities conducted an eviction

drive and successfully removed the unauthorized encroachments, restoring the Government land to its original status. 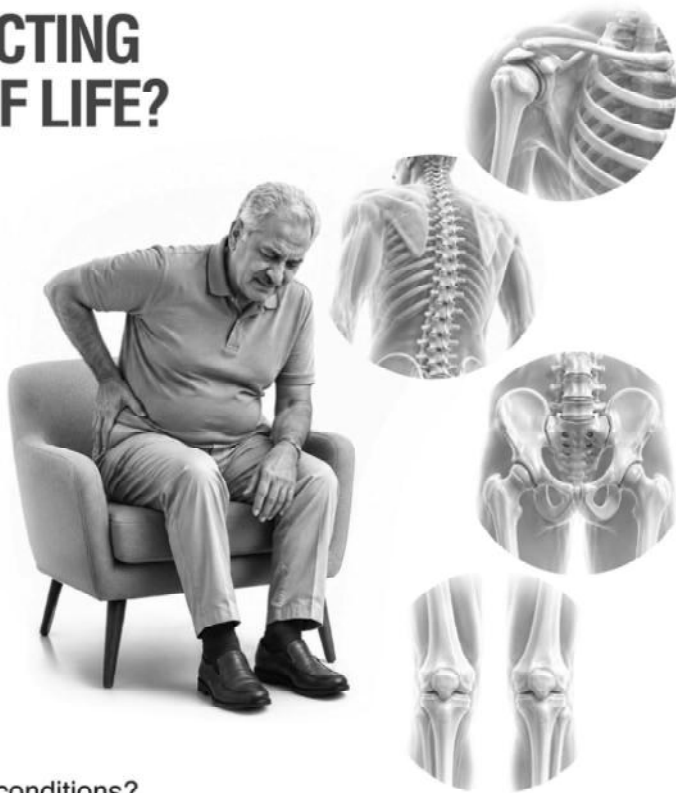

Indian mule bank accounts are given to potential victims for depositing money, initial payouts are made to gain trust, and after a significant amount is deposited, fraudsters stop communication and the citizens become victim of cyber financial fraud.

In this regard, Andaman and Nicobar Police has issued the following advisory to safeguard yourself against Fake Stock Market Investment:

- ♦ Be extremely cautious of sponsored ads on Facebook, Instagram, or Google promoting investment groups on WhatsApp or Telegram, as these may be fraudulent.
- ♦ Be alert to impersonation by fraudsters as FIIs/FPOs, financial advisors, or reputable institutions.
- ♦ Avoid sharing sensitive financial information like bank details or login credentials with unknown entities.
