Indian Army conducts surgical strikes across Line of Control

New Delhi, Sep 29
Indian Army conducted surgical strikes last night on terror launch pads across the Line of Control. Speaking to media today, Director General of Military Operations Lieutenant General Ranbir Singh said, the motive of the operation was to hit out at the terrorists who were planning to infiltrate into the Indian territory. Lt General Singh informed that significant casualty was caused to terrorists during the operation. The DGMO said, it is a matter of serious concern that there has been many infiltration bids by



terrorists at LoC and it was reflected in the terror attacks in Poonch and Uri on 11th and 18th of this month. He said, nothing was done despite India's persistent request to Pakistan not to allow territory under its control to be used for terror activities. He said Pakistan gave a commitment to India in 2004 that it will not allow its soil to be used for anti India terror activities.

He informed that almost 20 infiltration attempts have been successfully foiled by Indian Army this year. He said India has also offered consular access to apprehended terrorists from Pakistan and finger prints and DNA samples of the terrorists killed in Uri and Poonch attacks can also be made available to the neighbouring country. Lieutenant General Singh said, he spoke to his Pakistani counterpart to share India's concerns and told him about the surgical strikes. He said, India can not allow terrorists to operate across the LoC.

Amidst the ongoing tussle between the two countries, India secured a convincing 3-1 triumph over arch rivals Pakistan to setup final clash with Bangladesh. The two teams have enjoyed success before in the competition, India having been twice—winners in 2001

Indian women's kabaddi team wins gold in Asian Beach Games

Danang, Vietnam, Sep 29
India bagged their first gold medal at the 5th Asian Beach Games with the women's beach kabaddi team winning the title for the record fifth time in succession in Danang, Vietnam. Indian beat Thailand 41-31 in a hard-fought summit clash at Bien Dong Park. The Indian women's kabaddi team had been winning the gold since the inception of the biennial Games in 2008. For Thailand, it was the fifth time in a row they had lost to India in a final. The Indian men's beach kabaddi team, however, lost to arch-rivals Pakistan 28-30 in a nerve-wrecking final to settle for



a silver. India had won gold in men's beach kabaddi the 2008 and 2010 editions. In women's 70kg category kurash (a form of wrestling originated in Uzbekistan), Amisha Tokas won a silver after losing to Nguyen Thi Lan of Vietnam in the final. In beach bodybuilding, Manoj Kumar Majumdar won a bronze in upto 158cm category. India has so far won six medals including one gold, 3 silver and 2 bronze, in the Games. India are now at 15th spot in the medal table headed by hosts Vietnam (25 gold, 22 silver, 27 bronze).

NGT issues guidelines for idol immersion; all concerned asked to follow

Port Blair, Sept. 29
The National Green Tribunal, Principal Bench, New Delhi has issued orders for strict compliance of the 'guidelines for idol immersion' issued by Central Pollution Control Board, New Delhi, available on CPCB website <http://www.cpcb.nic.in>. As per the directions, the idols should be made from the natural material as described in the holy script preferably traditional clay and baked clay. The idols shall be painted with water soluble and non-toxic natural dyes. The Plaster of

Paris (PoP) should not be used for making idol and use of toxic & non-biodegradable chemical dyes for painting the idols is strictly prohibited. During the immersion the worship materials like flowers, vastras (cloth), and decorating material (made of paper & plastic etc.) should be removed before idol immersion. All the biodegradable materials should be collected separately for recycling or composting and the non-biodegradable materials should be collected separately for disposal in sanitary landfill sites. They burning of solid waste comprising of used flower, clothes, decorating etc. is strictly prohibited. The festivals should be celebrated taking all precautions with a view to minimize pollution, accidents, etc, said the Member Secretary, Pollution Control Board, Department of Science & Technology, A&N Administration, in a press release issued here, also urging one and all to comply with the guidelines issued from time to time by the local Administration.
