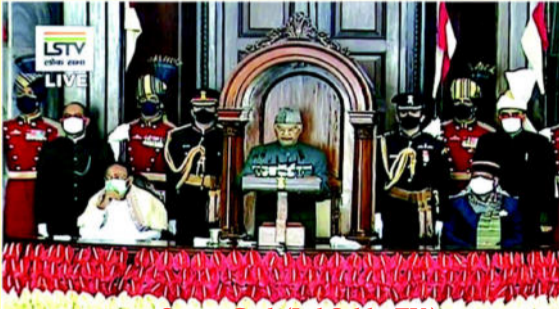

Budget session of Parliament begins

New Farm laws of Government provide more rights to farmers: President

New Delhi, Jan. 29

President, Shri Ram Nath Kovind has said the Constitution gives us the right to freedom of expression but it also expects that we abide by the laws and rules with equal sincerity. Addressing the joint sitting of both the Houses of Parliament on the first day of Budget session today, he termed the recent acts of dishonouring the National Flag and showing disrespect to the auspicious occasion of the Republic Day as unfortunate. He said the three farm laws enacted by the Parliament in the previous session aim at further helping the farmers in the country as they provide more rights and power to the farmers. President added that over ten crore small and marginal farmers have started getting benefits from these reforms in the agriculture sector.

The President also said, in light of these benefits many political parties extended their full support to the reforms. The President however said the implementation of farm laws have been put on hold by the Supreme Court and the Government will respect whatever is the decision of the Apex Court. He asserted that the Central Government has taken several measures to improve the condition of farmers in the country like implementation of the recommendations of the MS Swaminathan Committee Report on Agriculture. It has increased the MSP of crops by 1.5 times. Talking about the fight against COVID-19, President

expressed satisfaction that due to timely decisions of Government, lives of millions of people have been saved and the number of corona patients are gradually decreasing in the country. He said, the country has started recovering from the damage done to the economy by the COVID pandemic amid centre's incessant efforts to save the life of every countryman. He added that even in these difficult times, India has emerged as an attractive place for the investors of the world. He also said by making lakhs of corona vaccine doses available to several countries, India has also fulfilled its obligation towards humanity in these times of difficulty.

weekly two flights on every Tuesday and Wednesday. For Car Nicobar there will be weekly twelve flights from Monday to Saturday.

Deptt. of CS&CA launches e-Services under Legal Metrology

Online services to provide easy access to consumers without visiting the Office

Port Blair, Jan. 29

The Department of Civil Supplies & Consumer Affairs is committed to provide the citizen centric services in the Islands in an easier and affordable manner continuously. In line with this commitment and to protect the interest of consumers, by taking an important step, e-filing facility was provided to consumers for lodging the consumer related complaints online at the UT as well as District level. With the availability of better information technology and its commitment towards better governance, the Department has developed digital solutions for five services under the Legal Metrology Wing as mentioned below:

- License as Dealer of weights & measures,
- License as Repairer of weights & measures,
- License as Manufacturer of weights & measures,
- Registration as Packer of commodities,
- Registration as Importer of commodities.



These solutions were developed in close coordination with SOVTECH, Dept. of IT under the e-district Mission Mode Project (MMP).

The services were launched yesterday by Dr. Navlendra Kumar Singh, Joint Controller (LM)/ Director (CS & CA) in the presence of Assistant Controller (LM) and other staff of the Directorate.

With the launch of these consumer oriented online services, the citizens intending to avail these services can do so from anywhere without having to visit the Office by submitting application on-line through the e-district portal and uploading the required documents along with the application. The fee for all the services can be made online. After inspection and approval by the Department, the applicant will be able to download the digitally signed copy of the Certificate online, a press release from Jt. Controller (Legal Metrology) said.

Pradhan Mantri Garib Kalyan Yojana, 80 crore people were provided an additional 5 kilogram free food grains per month for 8 months. He also said that during this period, more than 14 crore gas cylinders were given free of cost throughout the country to poor women beneficiaries, under the Ujjwala scheme. Highlighting the efforts of the Centre towards ensuring best healthcare facilities in the country, he said that under the Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana, 1 crore 50 lakh poor people in the country received free treatment of up to 5 lakh rupees.

President said that raising the standard of living of the villagers has been a priority for the Government. He said, this is best exemplified by the 2 crore houses built since 2014 for the poor families living in villages. He said besides delivering water to every household under the Har Ghar Jal Yojana, work on water conservation is also progressing at a rapid pace. The SOP further stated that tourists/visitors will have to strictly follow the designated routes for entry and exit and movement inside the monument. The Department has the authority to restrict access to any part of the museum. Tourists/visitors need to strictly adhere to the time limits/ slot. The security staff has to ensure that there is no crowding at any point of time inside the monument.

Group photography will not be allowed within the premises. Vehicles will not be allowed to be parked in front of the memorial. Parking will be allowed only in designated areas. Registered Guides will only be allowed to work inside the museum. Each guide will cater to maximum four guests who will maintain social distancing during the guided tour. No food and eatables will be allowed inside the monument/premises. Spitting and smoking are strictly prohibited inside the monument. Tourist/visitors shall not throw waste inside the monument. Tourist/visitors should avoid overcrowding at the drinking water site and at the washroom area.

Respiratory etiquettes should be strictly followed. This involves strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly after use. Any other orders or advisories issued by Govt. of India, A&N Administration or any other Competent Authority will also have to be followed, a press release from Directorate of Tourism said.

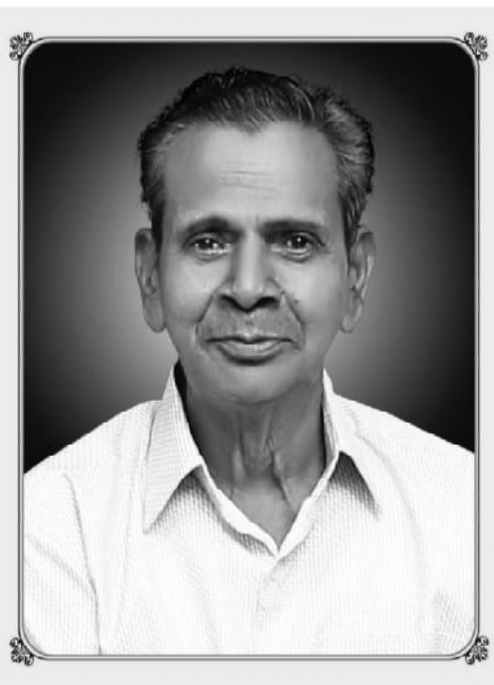

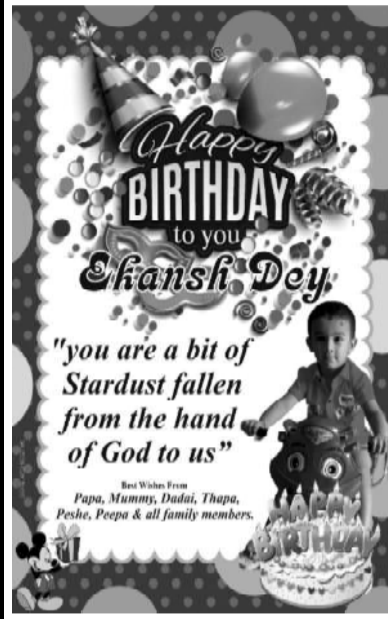

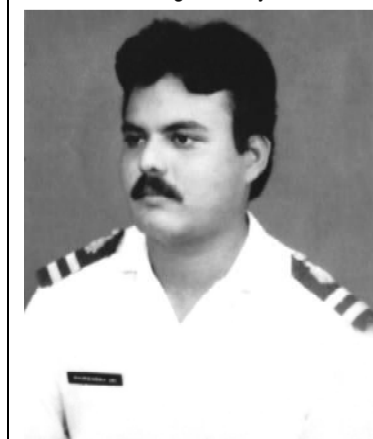
