

## Commemoration of first hoisting of tri-colour by Netaji Subhas Chandra Bose Chief Secretary hoists National Tri Colour amidst patriotic fervour at Flag Point

The 78<sup>th</sup> anniversary of the hoisting of the National Tri-colour for the first time on the Indian Soil by Netaji Subhas Chandra Bose was celebrated today. It was on this day i.e December 30, 1943, Netaji Subhas Chandra Bose had hoisted the national tri-colour Flag for the first time at Port Blair, declaring the Islands, the first Indian Territory freed from

the British rule.

To mark the Day, a State Level function was organized by the Department of Art and Culture at Flag Point today morning in which the Chief Secretary, A&N Administration, Shri Jitendra Narain hoisted the National Flag amidst patriotic fervour.

The Flag hoisting function was attended by senior officers of A&N Administration, prominent citizens, tourists and general public.

## DSS augmenting shipping services in Isles Sufficient number of operational vessels available for use in all sectors

Due to the outbreak of COVID 19 since 2020, the Directorate of Shipping Services had experienced severe difficulties in operation and maintenance of the vessels in the fleet. Due to insufficient manpower, non-availability of stores/spares, utilisation of drydock and completion of inspection and surveys the operational availability of vessels were very low in percentage. However, with such severe

constrains, the Directorate took up various initiatives and action to address all such issues by liaising with various agencies and authorities and brought the situation under control. Even with the depleted operational status of the vessels, the Directorate has put its best efforts in maintaining essential services in all sectors with limited resources.

(Contd. from page 1) other required action, the Directorate of Shipping Services has now sufficient number of operational vessels for the use in all sectors. Accordingly the Directorate has deployed vessel to handle tourist requirement both for Swaraj Dweep as well as for Shaheed Dweep. Similarly, the inter island connectivity, particularly in Southern Group has been improved thereby the passenger and cargo movement has increased to satisfactory level. Even the DSS is regularly deploying exclusive cargo vessels to Southern Group of Islands which has eased movement of essential cargo including perishable items such as vegetables, fishes etc.

With this initiative, the DSS could make MV Chowra for operation in Inter Island Sector which will further augment the shipping services particularly in the Southern Group of Island for passenger and cargo. Recently inducted vessel MV Sindhu has also resumed normal services to the satisfaction of passengers and traders for transportation of cargo. Inter Island vessel MV Campbell Bay is in the final stage of completion of repairs which is expected to arrive shortly and available for service. Similarly, two foreshore sector vessels namely MV Kamorta & MV Chouldari have resumed the operation during this month. MV Kamorta has already been deployed at Kamorta to provide inter connectivity between the islands in Southern Group. The Directorate has further initiated action to operationalise MV Kalighat in Inter Island Sector and MV Bambooka and MV Rani Lakshmi in Foreshore Sector vessels with which further augmentation of services in couple of weeks.

The DSS during the pandemic has tirelessly worked hard due to which the essential services were maintained, medicines, medical equipments and essential commodities were transported timely. The Directorate has also successfully involved in transportation of COVID vaccines to various Islands towards achieving the target of 100% vaccination in these Islands.

The Directorate of Shipping has also taken new initiative whereby a 'HELPLINE' (Toll Free Number 18003452714) has been made functional for the redressal of grievances, if any. Further, the Directorate is also in the process to create facilities for Net Enquiry and e-Booking of tickets for the passengers which is in final stage and is likely to be launched shortly, a press release from DSS said.

**Vaccination drive in A&N Islands 5,92,465 doses of vaccines administered to beneficiaries in Isles so far**

Port Blair, Dec. 30 The vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 5,92,465 beneficiaries have been vaccinated so far in A&N Islands. A total of 486 people were vaccinated today. 424

beneficiaries were vaccinated in South Andaman District, out of which, 52 beneficiaries were in the age group of 18-44 years. Similarly, 51 beneficiaries were vaccinated in North & Middle Andaman

District, out of which, 5 beneficiaries were in the age group of 18-44. 11 beneficiaries were vaccinated in Nicobar District, out of which, 2 beneficiaries were in the age group of 18-44, a press release from DHS said.

**COVID-19: Two positive cases detected during RTPCR test**

Port Blair, Dec. 30 During the RT-PCR test conducted on 466 passengers who arrived here yesterday, no positive case has been detected. Today, 12 passengers arrived, out of which, 1626 were vaccinated with both doses while RT-PCR test was conducted on 396 passengers (includes 24 international travellers) and the reports are

awaited. During RAT conducted on 145 passengers bound for North & Middle Andaman at Ferrargunj, no positive case has been detected. At Mohanpura Bus Terminus, test was conducted on 53 passengers and all were found negative. At Phoenix Bay Jetty, 90 passengers were tested with RAT and all were found negative. At

Helipad, test was conducted on 3 passengers and all were found negative. Two positive cases have been detected during the RTPCR test conducted yesterday. Today, till 3 pm 252 eligible beneficiaries were vaccinated, out of which, 236 were in the age group of 18-44 years, a press release from the Directorate of IP&T said.

**India beat South Africa by 113 runs in first Cricket Test; take 1-0 lead in three-match series**

Centurian, Dec. 30 India beat South Africa by 113 runs in First Cricket Test to take 1-0 lead in three-match series. Set a stiff target of 305 runs, South Africa were bowled out for 191 on the fifth and final day of the opening Test today at Centurian. At the lunch break, Temba Bavuma and Marco Jansen were batting on 34 and five runs respectively, as the hosts still trailed India

by 123 runs. South Africa finished the fourth day at 94 runs for the loss of four wickets with skipper Dean Elgar unbeaten on 52 after Indian batters caved in on a track with uneven bounce, getting all out for 174 in their second innings in just 50.3 overs. Wicketkeeper-batter Rishabh Pant top-scored for India in the second innings with a run-a-ball 34. Kagiso Rabada and

Marco Jansen took four wickets apiece while Lungi Ngidi got two wickets for South Africa. India had bowled South Africa out for 197 after making 327 in their first innings. K. L. Rahul was named the Player of the Match for his brilliant 100 in the first innings. The second test between the two countries will be played from 3rd to 7th January, at the Wanderers Stadium, Johannesburg.




