

Health Minister reviews Public Health Preparedness to COVID-19 with States/UT

"We have put up a strong fight against COVID earlier and this learning must be used to re-focus on efforts against Omicron variant"

New Delhi, Jan. 2 (PIB)

Dr. Mansukh Mandaviya, Union Minister of Health and Family Welfare today virtually interacted with State Health Ministers and Principal Secretaries/Additional Chief Secretaries of States/UTs to review the Public Health Preparedness to COVID-19 and progress of National COVID-19 vaccination campaign. The meeting was held in view of the rising



cases of the Omicron variant and the recent decisions to roll-out vaccination for the age group 15-18 years and precautionary dose for identified vulnerable categories. The meeting was attended by the Commissioner-

cum-Secretary (H), Secretary (H), A&N Administration and other senior officials of Health Department.

The Union Health Minister noted at the very outset that globally,

countries are experiencing 3-4 times the surge in COVID-19 cases in comparison to their earlier peaks. The Omicron variant being highly transmissible, a high surge in case can overwhelm the medical system. He therefore advised the States to leave no stone unturned in ramping up infrastructure to manage a high surge so that India escapes unscathed from this episode of COVID-19. (Contd. on last page)

Administration takes various steps to effectively manage increase in COVID-19 cases including detection of Omicron variant

All incoming passengers have to mandatorily carry RT-PCR negative test report from Jan. 5

Port Blair, Jan. 2

In view of the recent increase in the number of COVID-19 cases including detection of Omicron variant cases in Andaman & Nicobar Islands and in order to effectively manage the challenge arising out of the same, in suppression of the earlier circulars on this subject, the Andaman & Nicobar Administration has taken various steps in public health interest.

All incoming passengers above 2 years of age including partially and fully vaccinated arriving at VSI Airport, Port Blair from 5th January, 2022 onwards shall have to mandatorily carry RT-PCR negative test report issued from a ICMR recognized laboratory, subject to condition that the RT-PCR test should have been taken within 48 hours prior to

commencement of journey from the origin airport connecting Port Blair.

Further, all passengers with history of foreign travel in the last 30 days, all unvaccinated and partially vaccinated passengers shall also be tested by RT-PCR on arrival at VSI Airport, Port Blair and they have to strictly self isolate themselves till the receipt of negative

RT-PCR report.

If passenger on arrival is tested positive then, the prescribed quarantine protocol is to be followed.

Further, all Airlines shall ensure strict compliance of this order and any non-compliance will invite action under Disaster Management Act and other applicable laws, an order to this effect issued by Commissioner-cum-Secretary (Health/ Civil Aviation) said.

'Pradhan Mantri Jan-Dhan Yojana' - providing platform for channeling all social security schemes

61131 accounts opened under PMJDY in Isles

Pradhan Mantri Jan-Dhan Yojana (PMJDY) has provided a platform for channeling all the social security schemes such as Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana (APY), Pradhan Mantri Mudra Yojana (PMMY), Micro Units Development & Refinance Agency Bank (MUDRA) scheme and pushing the Direct Benefit Transfer (DBT) scheme of the Central Government. In A&N Islands, a total of 61131 accounts have

been opened under 'Pradhan Mantri Jan-Dhan Yojana' (PMJDY) so far. The scheme ensures access to financial services, namely savings and deposit accounts, remittance, credit, insurance and pension in an affordable manner to the country's poor and

marginalized section of the society. PMJDY also provides an overdraft facility- a financial facility or instrument that enables an account holder to withdraw money from his/her bank account (savings or current), even if they do not have any account

balance. Like any other credit facility, the bank levies an interest rate when an account holder avails the overdraft facility. Overdraft facility is usually offered for the withdrawal of a limited amount of money. The Centre's (Contd. on last page)

Scenario of COVID-19 & its variant Omicron in the UT discussed

Vaccination of children in the age group of 15-18 years to begin from today

Port Blair, Jan. 2

The Commissioner-cum-Secretary (Health), A&N Administration also reviewed the present scenario of COVID-19 and its variant Omicron in the UT and the availability of beds, logistic and medicines today post the Union Health Minister's meeting. He directed the DHS to ensure emergency beds ready in full capacity and to maintain sufficient stock of medicines



along with adequate manpower supply. He directed that the measure desired to contain the further spread of infection should be adopted on priority. All the passengers above 2 years of age arriving

from mainland should bring a RTPCR negative report taken within 48 hours of commencing journey from the destination. Also, all the passengers above 2 years of age who are not vaccinated,

partially vaccinated or vaccinated for less than 15 days and also the people who are vaccinated abroad must undergo a second RTPCR on arrival and to be in self quarantine till receipt of the local RTPCR result. No person should move out during the said period. Those who are having a travel history abroad in last 30 days also must undergo RTPCR in both places. Passengers who have (Contd. on last page)

India reports over 27,000 new COVID-19 cases, Omicron tally reaches 1,525

New Delhi, Jan. 2
A total of one thousand 525 cases of COVID-19 have been reported so far in the country. Out of these cases, 560 patients have already recovered. Maximum number of 460 cases have been reported from Maharashtra followed by Delhi with 351 cases. Omicron cases have been reported from 23 States and Union Territories.

Health and Family Welfare Ministry today said, over 145 crore 44 lakh doses of COVID vaccines have been administered in the country under the nationwide vaccination drive. The Ministry said, more than 25 lakh 75 thousand COVID vaccine doses were administered in the last 24 hours. Over nine thousand COVID patients have recovered during the last 24 hours and the national recovery rate stands at 98.27 percent.

The country has reported over 27 thousand new Covid cases in the last 24 hours. Currently, India's active caseload is over one lakh 22 thousand. The Ministry said, more than 68 crore COVID-19 tests have been conducted so far. (Source: india.gov.in)

The second test between India and South Africa will begin at the Wanderers Stadium tomorrow. India currently lead 1-0 in the three-match series. The visitors won the first match by 113 runs. India have yet to be beaten in a Test match at Wanderers and have a record of two wins and three draws since their first tour of South Africa in 1992/93.



Despite the Wanderers being

renowned as a ground favouring fast bowlers which should have put India at a disadvantage on some of their earlier tours, before the emergence of their potent current pace bowling attack, India have performed consistently well in

Johannesburg. A series win in South Africa remains a final frontier for India, who now have the opportunity to wrap up an historic triumph with a match to spare. (Source: india.gov.in)

Dr. Mandaviya said in this regard that irrespective of the COVID variants, measures for preparedness and protection remain the same. He urged the states to reinvigorate their teams to work at the ground level and strengthen monitoring and containment mechanisms. This was followed by a comprehensive and detailed discussion on various aspects of COVID management including ramping up of hospital infrastructure; increased testing; stringent restrictive measures for breaking the chain of transmission; and stress on COVID Appropriate Behaviour among the masses. Critical bottlenecks in medical infrastructure were also discussed.

arrived at Port Blair from any destination abroad direct or hoping must undergo 7 days' of compulsory quarantine and will be tested on 8th day and after that only, they will be allowed to move out of quarantine. The vaccination for 15- 18 years was also reviewed. He directed the concerned that the target coverage of beneficiaries with Covaxin should be achieved on priority and in time bound manner. The vaccination for 15-18 years of age group will commence from Jan. 3, 2022 in all the 29 CVCs. For the purpose of calculation of age of children, any child born on or before 31.12.2007 but has not attained his or her 18th birthday are eligible for Covaxin.

Further, he instructed the DHS to undertake precautionary vaccination dose of FLWs, HCWs, people >60 years with co-morbid conditions to be vaccinated with the same vaccine what he received earlier in the UT from 10.01.2021.

Meanwhile, the general public have been appealed that they may bring their children to the nearest booth for vaccination from Jan. 3 onwards positively at 9 am in the nearest COVID Vaccination Center. Children must bring their Aadhaar Card and in case of non-availability of Aadhaar Card they may bring school Identity Card for vaccination with a valid mobile number, a press release from Directorate of Health Services said.

and carry bags have been introduced in the market which are even more dangerous than plastic.

In this regard, PBMC has requested stakeholders not to store, use or sell such products. If any person is found using such single use plastic, fine will be imposed as per PBMC, SWM (Handling Rules 2017) and commercial establishment will be seized for storing and selling/ providing such type of articles.

The Port Blair Municipal Council has once again appealed to the general public and commercial stakeholders to refrain from using/ selling single use plastic products so as to preserve the fragile ecosystem in A&N Islands, which is also known for its rich bio-diversity including the flora & fauna, a press release from PBMC said.

scheme allows the Jan Dhan account holders to withdraw money upto Rs. 10,000 in the form of a short-term loan. This limit was earlier Rs.5,000 which was doubled last year. The owner of a PMJDY account, who wants to avail the overdraft facility, must have been satisfactorily operating it for at least six months. Also, only one member of a particular family can avail the overdraft facility. Usually female members are favoured for this. For overdraft of upto Rs. 2,000, no guarantee is needed under PMJDY. The Government has also increased the upper age limit for overdraft from 60 to 65 years.

Accounts opened under PMJDY are Basic Savings Bank Deposit (BSBD) accounts with additional features of RuPay debit card and overdraft. There is no requirement of maintaining minimum balance in BSBD accounts. Over 43.90 Crore accounts have been opened in the country under the scheme which is touted as 'one of the biggest financial inclusion initiatives in the world'.

Farmers' Corner- A Knowledge Hub
Spice it up with Mango ginger!

Mango ginger is a common terminology used to describe two botanical species namely *Curcuma amada* (used extensively in mainland India) and *Curcuma mangga* (found in the islands). As the name suggests, rhizomes of these species resemble to that of ginger, but when cut, they emit aroma akin to raw mango. Both the species have excellent flavouring properties and could be utilized for preparation of various cuisines. Studies conducted at ICAR-CIARI with local mango ginger of islands suggested that all parts of rhizomes contain Curcumin, which is a bioactive molecule predominantly present in turmeric rhizomes. The appealing aroma in the rhizomes is due to the presence of volatile oil. Experiments suggested that oil content in rhizome was about 0.5% and Myrcene and cyclofenchene were identified as dominant compounds responsible for aroma. For cultivation, rhizome pieces of 15-25 g size could be planted during April in raised beds at 25-30 cm apart. The crop grows well with supplementation of organic inputs such as farmyard manure and could be grown as a rainfed crop. Two to three weedings and earthing up (covering of exposed rhizomes with soil) are the only management practices required for the crop. Rhizomes are ready for harvest when all the leaves dry up. Such rhizomes are carefully lifted and cleaned of soil. Each plant can give about 500 to 700 g of fresh produce. Rhizomes are suitable for preparation of various value added products such as dehydrated shreds, pickles etc. It could be a potential crop for both open conditions as well as intercropping in the plantation crops. Planting material is available at ICAR-CIARI for sale during the planting season.

Cultivation of mango ginger will not only diversify the income avenues of island farmers but would also offer new flavours for the local hoteliers thereby promoting the tourism.

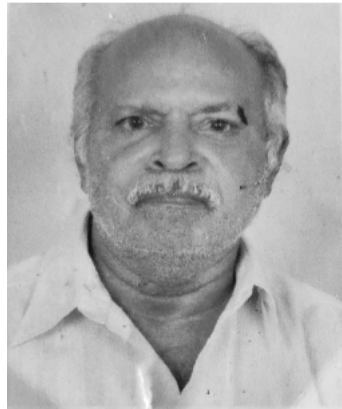

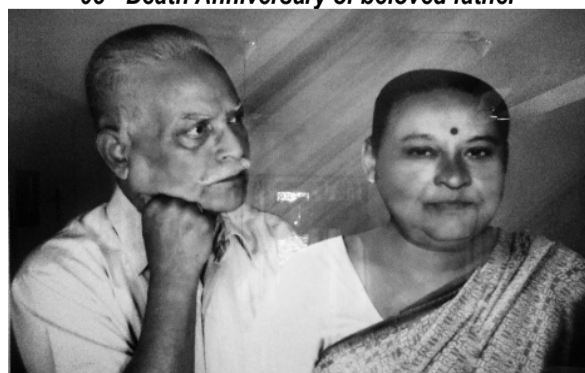
