Food Safety Department conducts surprise inspection on milk vendors

In the effort to ensure safe, hygienic and wholesome food to the islanders, the Food Safety Department conducted surprise inspections on milk vendors selling milk in the city. About 23 milk vendors were inspected and samples were collected for analysis. With the help of instruments like Milkosis and Raptor Reveal Q+, the samples were



tested to detect the presence of urea, detergents, shampoo, starch, stabilizers, aflatoxins and veterinary drug residues. All samples were found

village of South Andaman. He has been working as a photographer in a studio at Port Blair for years and never in his wildest dreams had he imagined of being an entrepreneur some day in his life. This tale reveals how a wage employee, who could not even pursue his education after completion of Class X, was pushed by circumstances to take the path of self-employment.
When the studio that he was working closed, he became jobless. Then, he started plying auto rickshaw to earn his living. But, he couldn't earn sufficient income for his livelihood support. Destiny had decided something better for him.
As he was well experienced in photography having worked for many years in the line, he was contemplating to start his own business but the lack of capital was a stumbling block in his efforts to establish his business.
Coming across a news item on PMEGP scheme of KVIC published in the Daily Telegrams, he approached the Khadi and Village Industries Board at Udyog Parisar, Middle Point where he was guided to avail the benefits under the scheme to start his business. He submitted his loan proposal which was later recommended by the District Level Task Force Committee (DLTFC) and sponsored to A&N State Co-operative Bank, Bambooflat. He was sanctioned an amount of Rs. 4,48,650/- and he managed an additional amount of Rs. 50,000/- from a family source and established his unit.

India beats Australia to take 1-0 lead in T20I

Canberra, Dec. 4
Team India defeated Australia by 11 runs in the first of three T20 Internationals at the Manuka Oval in Canberra. Australia skipper Aaron Finch won the toss and opted to bowl, with the visitors posting a total of 161 runs for the loss of seven wickets. KL Rahul was the highest run scorer, accumulating 51 runs off 40 deliveries. The wicketkeeper-batsman registered his 12th half-century in T20Is, during the course of the innings. All-rounder Ravindra Jadeja was the second-highest run-getter, smashing 44 runs off 23 balls. Jadeja's knock comprised of five boundaries and a six. Moises Henriques was the pick of the bowlers for the hosts, accounting for three wickets while conceding 22 runs. The chase started off on an attacking note with Finch smashing the ball to all corners of the ground. However, the Australian skipper's dismissal helped Team India make a comeback in the game. Yuzvendra Chahal, who came in as a concussion substitute for Ravindra Jadeja, made a decisive impact, accounting for Finch's dismissal before sending back Steve Smith early. Chahal received support from left-arm pacer T Natarajan who made his presence felt on debut. The duo finished with three wickets apiece, to help India register a win.

Reserve Bank keeps repo rate unchanged at 4 %

New Delhi, Dec. 4
Maintaining an accommodative stance, the RBI Governor, Shri Shaktikanta Das today said that the Monetary Policy Committee has unanimously decided to leave the policy repo rate unchanged at 4 per cent. He said the marginal standing facility remains unchanged at 4.25 percent and reverse repo rate stands unchanged at 3.35 per cent. The Reserve Bank of India's Governor said that the RBI expects the economy to record positive growth in the second half of the current financial year. He informed that the RBI has decided to raise the limit for contactless card transactions from Rs 2,000 to Rs 5,000 per transaction from January 2021. Shri Das said that the RTGS system will be made 24x7 in the next few days. (Source: india.gov.in)

Central Crime Station strikes hard on drug peddlers; one arrested

Information was received at PS Central Crime Station on Dec. 2 that contraband is kept in the house of S. Karthick, R/o Brookshabad, which was conveyed to Senior Officers and on the direction of Shri Jagdev Singh Yadav, Dy.SP (CID), a raiding team comprising of Inspr. Mohd Elias, In-charge PS CCS, SI T. Dilla Rao, SI Santosh R. Shenoy and other supporting staff of PS CCS was constituted and sent to Brookshabad for carrying out the raid in a highly professional and well coordinated manner. The raiding team encircled the house of S. Karthick from all sides and carried out house search after observing all codal formalities. The team recovered one yellow carry bag containing 550 gram of Methamphetamine which he was clandestinely concealed in the corner of the room. 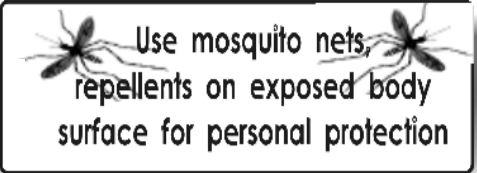
