India administers over 168.47 crore vaccine doses under Nationwide Vaccination Drive
New Delhi, Feb. 4

Over 168 crore 47 lakh vaccine doses have been administered so far under Nationwide Vaccination Drive. Health Ministry said, over 55 lakh 58 thousand doses were administered yesterday. The Recovery Rate is currently at 95.39 percent. Over 2 lakh 46 thousand recoveries in the last 24 hours increase total Recoveries to over 4 crore. India's Active caseload currently stands at 14 lakh 35 thousand 569. Active cases stand at 3.42 percent. Over one lakh 49 thousand new cases were recorded in the last 24 hours. The daily positivity rate is at 9.27 percent and Weekly Positivity Rate is at 12.03 percent. One thousand 72 deaths have been reported in the last 24 hours. Over 73 crore 58 lakh tests have been conducted so far. Over 16 lakh 11 thousand tests were conducted in the last 24 hours.

Tokyo Olympics gold medallist Neeraj Chopra nominated for Laureus World Breakthrough of the Year Award
New Delhi, Feb. 4

Tokyo Olympics gold medallist Neeraj Chopra has been nominated for the prestigious Laureus World Sports Awards. India's first-ever winner of an Olympic athletics gold medal, Neeraj has been selected as one of the six nominees for the 2022 Laureus World Breakthrough of the Year Award. The other five sportspersons who have been nominated for the award are Australian Open runner-up Daniil Medvedev, British tennis star Emma Raducanu, Barcelona and Spain footballer Pedri, Venezuelan athlete Yulimar Rojas and Australian swimmer Ariarne Titmus.

24-year-old javelin thrower is only the third Indian to be nominated for the award after wrestler Vinesh Phogat in 2019 and cricket star Sachin Tendulkar, who won the Laureus Sporting Moment Award 2000-2020.

A panel of over 1,300 sports journalists and broadcasters globally selected the nominees in seven categories. The winners will be revealed in April following a vote by the Laureus World Sports Academy, made up of 71 sporting greats.

In a statement, Chopra said, he is delighted to be nominated for this Laureus Award. It's a great honour for him to be recognized in the wider sporting world for what he achieved in Tokyo, he added.

No. 5-2/EC/A&N/2021: Whereas, it is necessary to check impersonation of voters in the interest of purity of elections to Panchayats and Municipal Councils and for the conduct of such elections in a fair manner;

And whereas, Rule (68) of the Andaman and Nicobar Islands (Panchayats) (Election Procedure) Rules, 1995 and Rule (55) of the Andaman and Nicobar Islands (Municipal) (Election Procedure) Rules, 1995, provide inter lia, that the elector shall produce his identity card before the presiding officer or the polling officer authorized by him in this behalf;

And whereas, according to the information received from the Andaman and Nicobar Administration, 98% voters have been issued Electoral Photo Identity Cards (EPICs). However, there may be electors who have lost their Identity cards and a few newly enrolled electors may not be having the EPICs, and such electors will find it difficult to cast their vote;

Now, therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission, Andaman and Nicobar Islands, hereby directs that the following alternative documents to EPICs may be used for establishing the identity of those electors who have not been provided with EPICs or have lost their EPICs and whose names are included in the Electoral Rolls:-

- (i) Unique Identity Aadhaar Card
- (ii) Indian Passport
- (iii) Motor Vehicle Driving Licence
- (iv) PAN Card issued by the Income Tax Department
- (v) Service Identity Cards issued to their employees by the Central Govt./Public Sector Undertakings and Local bodies
- (vi) Service Identity Cards issued to its employees by the Andaman and Nicobar Administration.
- (vii) Bank/Kisan/Post Office Passbook having photo affixed on it.
- (viii) Certificates of Physical Disability issued by the competent authority with photograph.

The above alternative documents for identification will also apply in respect of such electors who have been supplied with EPICs but are not able to produce them for reasons beyond their control.
