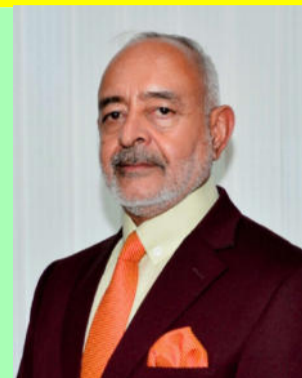

SC upholds 10% reservation for Economically Weaker Sections in admissions and Govt. jobs

New Delhi, Nov. 7

A majority of a five-judge bench of the Supreme Court today upheld the validity of the 103rd Amendment of the Constitution which provides 10% reservation for Economically Weaker Sections (EWS) in admissions and Government jobs. Three Judges upheld the Act and two Judges



dissented. The 103rd constitutional amendment was cleared by the Parliament in January

2019 and was instantly challenged in the Supreme Court.

The case was first presented before three judges, who referred it to a larger five-judge bench in 2019. This September, the court held a marathon six-and-half-day hearing of the case and reserved its verdict. (Source: india.gov.in)

ANIIMS issues clarification on media reports being circulated related to a critical patient admitted in ICU at GB Pant Hospital

Port Blair, Nov. 7

This is in reference to circulating media reports related to a patient in the Intensive Care Unit at the GB Pant Hospital on the night of 4th November, 2022. A patient in critical condition was admitted in the ICU in a very serious state. The patient had been suffering from uncontrolled diabetes, chronic kidney disease, hypertension and heart disease with heart

working at 25 percent capacity. When he was admitted in ICU, he had already developed diabetic gangrene and had gone into septic shock.

He was immediately put on ventilator. Despite the critical and complicated condition of the patient, every effort were being made to save him by the attending doctors and nurses in the ICU. While measures as critical as cardiopulmonary

resuscitation were being applied, several aggressive patient relatives gathered around the bed and interfered with the ongoing efforts, despite the doctors and nurses requesting for only one relative to be inside and rest of them to go outside in the waiting hall. The relatives were shouting and abusing inside the ICU, where more than ten critical patients were admitted at that

In supersession of all previous appointment orders of Booth Level Officers (BLOs) and BLO-Supervisors under Section 13B(2) of Representation of People Act, 1950, the following officials attached to various departments functioning under A & N Administration are hereby appointed as Booth Level Officer and BLO-Supervisor for the Part(s)/Polling Station(s) mentioned against their name with immediate effect.

The BLOs shall attend to the Electoral Roll related duties in the polling area as indicated against their name. They would be considered as on deputation to the Election Commission of India for this purpose and would be subject to the disciplinary control of the Election Commission of India under Section 32 of Representation of People Act, 1950. BLOs & BLO-Supervisors shall not proceed on leave without obtaining permission and making over his election related charge. Even in case of their transfer, they should ensure to hand over all election related papers, records and registers to their successor within the prescribed time.

The Booth Level Officers shall be required to carry out door-to-door verification of electors in their respective polling area which they have been assigned. They shall be provided with a copy of the latest Photo Electoral Rolls pertaining to their polling area and shall make necessary correction and updation of the electoral data as prescribed. The BLOs/BLO-Supervisors shall have to perform their duties in addition to their official work in such manner that it does not affect their normal duties. The BLOs are backbone of democracy and their objective shall be to prepare an error-free Electoral Roll and to achieve cent percent enrolment of eligible.

During the course of Special Summary Revision of Electoral Rolls, ordered by the Election Commission of India, the BLOs shall be required to be present in their respective jurisdiction. Duties and Responsibilities of BLO is annexed herewith as ANNEXURE-I.

The work of each BLOs shall be supervised by BLO-Supervisors appointed herewith. The BLO-Supervisor shall maintain check on the quality of work done by the Booth Level Officers and closely monitor their functioning. They shall work as a link between Booth Level Officers and Electoral Registration Officer/Assistant Electoral Registration Officers. They shall also be deemed to be on deputation to the Election Commission and therefore will be under the disciplinary control of the Election Commission of India under the provisions of Section 13CC of the Representation of the People Act, 1950.

All the BLOs are also hereby directed to carry out collection/updation of Aadhaar data from the electors on voluntary basis for linking and authentication of entries in electoral roll during forthcoming Special Summary Revision-2023 which will commence from 09.11.2022.

All the Heads of Department/Officer are requested to spare the services of the staff under their control during the Summary Revision period.

All BLOs are also hereby appointed as Designated Officer to receive claims & objections at their respective Polling Stations on all working days during the period of filing claims & objections for Summary Revision.


